

The Jim Robertson Scholarship celebrates the visionary leadership and transformative contributions of Jim Robertson, the longest-serving IV-D Director of the Kansas Child Support Services Program. Jim's legacy lives on through this scholarship, supporting students who share his commitment to serving Kansas families and their communities.



#### SCHOLARSHIP AMOUNT:

\$1,000 for the top two applicants

This nonrenewable scholarship must be applied for annually.



#### IMPORTANT DATES:

Application Deadline: April 15, 2025 Winner Notification: May 15, 2025



#### WHO IS ELIGIBLE?

To qualify, applicants must:

- Be a Kansas resident.
- Be a high school senior or a post-high school student continuing their education.
- Maintain a 3.0 GPA or higher (submit an unofficial transcript).
- Be connected to an active KCSEA member (current membership dues must be paid).
- Show a passion for pursuing a career that impacts children and families (explained in a 500-word essay).
- Provide letter(s) of recommendation.



#### **APPLICATION REQUIREMENTS:**

To apply, visit <u>KCSEA's website</u> and stat the application process today! You'll need to submit:

- 1. Completed application form
- 2.Unofficial transcript
- 3.Letter(s) of recommendation
- 4.500-word personal essay





#### **RECOGNITION AND AWARD:**

Scholarship recipients will be invited to attend the upcoming KCSEA Annual Conference, where they will be publicly acknowledged. If unable to attend, recipients can provide a photo and a statement about what the scholarship means to them, to be featured in KCSEA's Kansas Quarterly (KQ) Newsletter.

# H.R. 9076: SUPPORTING AMERICA'S CHILDREN AND FAMILIES ACT

Fifty years to the day after President Gerald Ford signed the legislation creating the federal child support program, President Biden signed H.R. 9076 (Supporting America's Children and Families Act) into law. This milestone legislation grants tribal child support programs the same access to critical enforcement information as states and territories, while also authorizing states to use contractors for child support services.

The bipartisan bill reauthorizes and strengthens child welfare programs under Title IV-B and IV-D of the Social Security Act through fiscal years 2025 to 2029. By enhancing resources, increasing funding, and addressing systemic challenges, the law aims to improve outcomes for vulnerable children and families nationwide.

#### **KEY HIGHLIGHTS:**



## Expanded Access for Tribal Programs:

Grants tribal child support programs equal access to enforcement tools and doubles funding for tribal court improvements.



#### **Increased Funding:**

Boosts allocations for programs like Promoting Safe and Stable Families, workforce development, and kinship navigator services.



#### Court Improvements:

Expands resources for state and tribal courts, supporting remote hearings and emergency preparedness.



#### **Addressing Substance Use:**

Provides additional funding for partnerships tackling parental substance use disorders.



#### Legal Representation:

Requires states to enhance access to legal representation for children and parents in child welfare cases.



#### **Workforce Development:**

Allocates funding to reduce caseloads, improve training, and retain skilled child welfare professionals.

H.R. 9076 passed with overwhelming bipartisan support in both the House and Senate and was signed into law on January 4, 2025. By addressing long-standing gaps in the system and prioritizing equity and access, the legislation represents a significant step forward in supporting children and families across the nation.
