***Financial Report***

***SACC Report***

- Due to glitch in USA Gymnastics site, State Chair was not able to access email address to send out agenda to all members. USA Gymnastics hopes to have the glitch fixed soon.
- Since State Chair is not able to give Committee Members the email addresses of those members in their area, the Representatives will send the State Chair information and she will send to all members.

***NAWGJ Report (Denise)***

- Currently 36 active judges.
- Currently 14 judges have passed the new Level 4/5 Test.
- Currently 22 meets have been requested October 2021 – March 2022.
- Judging Request forms should be sent to Patty ASAP.

- NAWGJ-WA has been selected by the SAC to assign judges for all state qualification meets. Meets that did not use NAWGJWA to assign judges will not be considered state qualification meets.
- It is highly encouraged that NAWGJWA is used to assign non-state qualification meets as well, i.e. mobility meets. This provides the judges with additional insurance, keeps an accurate accounting of what judges have been judging what levels, and lets the assigner know when a judge has accepted a meet
- Once judges have been assigned to a meet, the meet director may contact the judges regarding travel arrangements, meals, and hotel needs. Please cc Patty on these as well. Change in session times need to go through the assigner.
