- There's been no recent meeting, but Joe will set something up soon. He is going to have a meeting to discuss the opportunities with the Journal and KTIV to feature more stories on homelessness.

EFSP Ad Hoc Committee: No report.

Coordinated Entry and HMIS Update

- 268 households on the list, 375 individuals
- Referral agencies and availabilities
 - Center for Siouxland Bridges West Transitional Housing
 - Capacity: 9 single units, 6 family units/ 24 family beds
 - 1 single and 1 family units currently filled
 - Not taking referrals as they transition to the Center Apartments
 - Sioux City ERA2 Rapid Rehousing
 - 16 households currently housed
 - At capacity
 - FAVA Rapid Rehousing

- 10 households currently housed
 - Open and available for new veterans
- Heartland Counseling Permanent Supportive Housing
 - Capacity: 29 one-bedrooms, 12 two-bedroom units
 - At capacity
- SafePlace Rapid Rehousing
 - Capacity: 7 single units, 4 family units
 - Will be taking 1 2-bedroom family and 3 1-bedroom referrals at the June 5th meeting
- Walk in Coordinated Entry intake appointments are going well, most intakes are done during those times. They are Tuesdays from 10:30-12:30 and Thursdays from 2-4. We are still making appointments with staff as well to meet the specific scheduling needs of the clients.
- Submitted the System Performance Measures (SPM) Report on April 11th
- The PIT/HIC report is due June 13th
- Continuing to onboard Crittenton Center and Warming Shelter staff in HMIS
- There will be data standards changes this fall, so far this includes removing the gender option that was updated in FY 2024 (as of 10/1/23) and replacing it with sex, including the options of male, female, and client refused/client doesn't know/data not collected. More information to come.

Street Project

- Western Iowa Tech Community College had a class that was going to do a project on homelessness, but it fell through.
- Homeless Court: Clara provided an update about the homeless court, the idea for which came from the May 2024 community meeting. The Iowa Finance Authority approved a grant to support technical assistance from the American Bar Association to get a program started in Sioux City. This court is intended to reduce the barriers that traditional court involvement can have in getting someone housed. New Business:

- Election for 9 open board seats is deferred to email. Clara will send more information to the listserv soon.
- Strategic planning: Shelby with Pierce Porter Facilitation is willing to continue working with the coalition but suggests starting with facilitated conversations instead of jumping straight into a large scale strategic planning session. The executive committee will explore this option further with Shelby and will report back.

Agency Spotlight/Reports/Activities/Updates/Discussion.

- Consolidated Plan/Action Plan Discussion
 - Clara led a discussion about the consolidated plan. Neighborhood Services with the City of Sioux City conducts this plan every 5 years and is required by HUD to receive the City's CDBG and HOME funds. It sets general goals and priorities for the use of the funds. They are set to receive about \$1.5 million in CDBG and \$420 thousand in HOME funds per year. These funds are used for a variety of activities, including housing rehab, down payment and deposit assistance, public infrastructure, parks, match for CoC grants, etc. The current goals include:
 - Provide affordable owner-occupied housing opportunities
 - Provide affordable rental opportunities
 - Improve the community through public infrastructure, public services, and development opportunities
 - Improve the lives of homes and near homeless
 - Administration
 - Public input questions:
 - What are the unmet needs of the low to moderate income population in Sioux City?
 - Affordable and safe housing, transportation, food, accessible resources, infrastructure including public water and restrooms, childcare, detox opportunities, medical and mental health providers that accept Medicaid, substance use support, peer support in homelessness and substance dependence, dental care, landlords and employers willing

- to lease/work with people with complex backgrounds, language barriers, and case management.
- Are there changes in demographics over the last year that have affected needs in our community? Do you anticipate any other changes over the next year?
 - Homeowners impacted by flooding including damage to their homes and losing housing, an increase of large families, immigrants from new places without a large community of support because there aren't a lot of people from that place (Caribbean, new African countries, Micronesian, etc.) that also includes language barriers because there aren't translators that speak their languages, the political climate has affected who people are willing to let stay with them as they don't want to risk any issues by having someone who is undocumented at their house, there will likely be an increase in recent refugees losing housing and employment with the cancelling of refugee resettlement grants and programs.
 - What are the current trends in your organizations?
 - In addition to what is listed above, there is an increase in older adult homelessness and mental health issues
 - Any upcoming projects that may be CDBG and or HOME eligible?
 - Landlord incentives to increase availability of rentals and willingness to rent to 'tough' tenants, case management availability for housing, SOAR case managers to assist clients applying for disability.
- Iowa Finance Authority 2025 Iowa Innovation in Homelessness Incubator: Joe suggests trying a similar program as last year's application, including something about a landlord incentive and case management. Clara suggested the group focus on cross community collaboration for the application, as that was highlighted in the brief and was central to each of the finalists last year. Reach out to Clara if you have ideas or want to be part of creating the proposal.
- SCEH Photo, deferred to July as there were not enough people at this meeting.
- Other agency updates
 - The Warming Shelter has started a new tiered system in their overnight shelter, incentivizing self-improvement. Each tier has a different level of shelter access, including when they can be at the shelter, what resources they can access, and if they can access case management with staff. They are planning to stay open this summer.
 - The Salvation Army hosted a community baby shower on May 16th. 30 expecting mothers were celebrated and 12 agencies had tables to offer services.
 - The Salvation Army will have a Day Camp this summer starting June 9th for K-8th graders. Monday-Thursday programming is available. If interested, call Tiffany at 712-255-8836.
 - Neighborhood Services is ramping up Street Outreach again this summer. Freddy Diaz is the main contact for this program and will be reaching out to agencies to talk through referral options and what services you provide. His email is fdiaz@sioux-city.org
 - Tim Young shared that he is creating a non-profit organization to provide a day center for unhoused folks. His plan is to have agencies refer people to the day center, where he will provide what they need on a daily basis. He is planning to call it Oliver's activity and wellness center.
 - Frank suggested we adjust the May meeting next year to occur the week prior to Memorial Day to avoid vacation overlap.
