2B. Project Description

1. Provide a description that addresses the entire scope of the proposed project and how the Collaborative Applicant will use grant funds to comply with the provisions of 24 CFR 578.7.

The Siouxland Coalition to End Homelessness (SCEH), the local Continuum of Care, has six committees. The City of Sioux City (City) is an active member of three of those committees – Executive, Grant, and Project Monitoring and Development. Planning Project funds would be used to further the work of those committees.

The Executive Committee would create a training schedule and offer regular training opportunities to agencies. Regular training would be provided regarding the Equal Access to Housing in HUD Programs Regardless of Sexual Orientation or Gender Identity, Housing First, VAWA, and available main stream benefits.

The Grant Committee will thoroughly review all existing policies and determine which new policies should be developed and which policies are in need of improvement. The Committee would clearly define how we reach out to new SCEH members and ensure as much input as possible is received from those who are currently experiencing homelessness, have experienced homelessness in the past, and individuals and agencies that currently work with the homeless population. Although our community will not be receiving Emergency Solutions Grant (ESG) funding from HUD for at least two or more years, the Grant Committee will review the current Written Standards required by ESG and make improvements in an effort to best serve the needs of homeless individuals and families.

The Project Monitoring and Development Committee will work closely with the shelters and homeless service provider agencies to monitor and track continuum-wide performance measures as well as work with agencies to continue to improve on benchmarks set. Review of performance measures will be conducted quarterly and agencies will be held accountable for their results. The focus over the next few years will be to improve the ranking and project selection process for the CoC Program Competition in an effort to ensure that highest performing agencies serving clients that meet HUD's priorities are funded. Work will also be done to determine how to reduce the length of time families and individuals have remained homeless as well as a strategy to increase successful permanent housing placement and retention.

In addition, City staff will continue to serve as the Lead Agency of SCEH and will work closely agencies participating in the Coordinated Entry System to ensure the system runs as smoothly as possible and meets the needs of homeless families and individuals in our community. The City will improve gap analysis of the homeless needs and services available in the community. Based upon an analysis of the previous year, the City is seeking funding opportunities to fund a street outreach program to increase outreach and engagement, which are much needed in our community. City staff will also participate in the Point In Time Count. Additionally, the City will work closely

with SCEH to compile information for the annual Consolidated Plan.

2. Describe the estimated schedule for the proposed activities, the management plan, and the method for assuring effective and timely completion of all work.

Once funding is awarded, City staff will:

Executive Committee:

Quarter 1: Create a training schedule and enlist individuals that would provide the training. The Chair of the SCEH would then be contacted and asked to add the training to the SCEH agenda, so the schedule is available to all participating members of SCEH. Agencies would also be contacted and placed on a rotation for providing information regarding main stream benefits.

Grant Committee:

Quarter 2: Current policies (including Written Standards) would be distributed and each member of the committee would be asked to review them and be prepared to discuss proposed changes during the next meeting.

Quarter 3: Policy changes/new policies would be discussed and committee members would be asked to work on draft final policies.

Quarter 4: Final policies would be reviewed and approved.

Project Monitoring and Development Committee:

Quarterly meetings will continue and the focus will shift to holding agencies accountable for their performance measure results. Each quarter, agencies will be required to provide an explanation of any results that don't meet the bench mark. Agencies that continue to be under-performers will be further discussed during the ranking and project selection process. The project ranking and selection process will be revised during Quarter 2.

In addition, City staff will continue to serve as the Lead Agency of SCEH and will work closely agencies participating in the Coordinated Entry System to ensure the system runs as smoothly as possible and meets the needs of homeless families and individuals in our community. The City will improve gap analysis of the homeless needs and services available in the community. Based upon an analysis of the previous year, the City is seeking funding opportunities to fund a street outreach program to increase outreach and engagement, which are much needed in our community. Analysis will be performed on an ongoing basis to determine the effectiveness on homelessness. The City will also participate in the Point In Time Count. Additionally, the City of Sioux City will work closely with SCEH to compile information for the annual Consolidated Plan.

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

The planning funds will provide SCEH with the tools and funding necessary to improve and implement the policies and procedures required by HUD. These policies and procedures are essential to improving the lives of homeless individuals and families in the community. The goal is to constantly improve, and this will provide the essential funding required for the time and attention

needed to implement, monitor, and evaluate improvements and changes.

4. How will the planning activities continue beyond the expiration of HUD financial assistance?

Once all of previously mentioned work is completed, the framework will be in place and SCEH will be able to continue moving forward with regular committee meetings to review and monitor compliance and performance. The training schedule will also be in place and will just be updated each year to meet the needs of the agencies. The policies will be updated, which will allow SCEH the ability to adjust funding based upon performance and meeting the needs of the community and the priorities of HUD.
