Other committee Reports.

EFSP Ad Hoc Committee: Executive Order froze EFSP activity, so unknown when/if this will move forward.

Coordinated Entry and HMIS:

- 336 households on the list, 417 individuals
- Referral agencies and availabilities
 - Center for Siouxland Bridges West Transitional Housing
 - Capacity: 9 single units, 6 family units/ 24 family beds
 - 1 family unit currently filled
 - Contacting 1 female and 1 male referrals as of 9/18
 - Center for Siouxland shared that their building has 22 units total, 14 of which are filled with Bridges West and Center Apartment residents with 2 additional units pending. 12 of these households were homeless prior to entry and 2 were

at imminent risk of homelessness. They still receive HUD funding for Bridges West transitional housing, but they are transitioning to Single Room Occupancies and will fill the units with whichever clients come first.

- Sioux City ERA2 Rapid Rehousing
 - September was the last month of funding, so this project is closed.
 - FAVA Rapid Rehousing
 - 9 households currently housed
 - 7 households housed with homelessness prevention
 - Open and available for new veterans
 - Heartland Counseling Permanent Supportive Housing
 - Capacity: 29 one bedroom, 12 two bedroom units
 - One single opening, working with Bridges West to potentially transition one client to PSH due to client needs.
 - SafePlace Rapid Rehousing
 - Capacity: 7 single units, 4 family units
 - At capacity
- Walk in Coordinated Entry intake appointments are going well, most intakes are done during those times. They are Tuesdays from 10:30-12:30 and Thursdays from 2-4. We are still making appointments with staff as well to meet the specific scheduling needs of the clients.
 - There will be data standards changes this fall, so far this includes removing the gender option that was updated in FY24 and replacing it with sex. This is supposed to take effect on 10/1, but HUD has not released any information on final decisions.
 - Annual privacy and security training will happen in September prior to the data standards changes for those that use HMIS. Continued HMIS access will require attending this training, so plan to attend.

Street Project

- Homeless Court: We are hosting a light document fair in partnership with the Siouxland Community Health Center mobile showers on Monday, September 29th. The DOT will be there to offer support in scheduling ID appointments and determining what documents are needed to replace IDs. This is the first of many we hope to host in conjunction with the homeless court, eventually having court personnel present to provide assistance with resolving warrants and other low level court issues.

New Business:

- Strategic planning: The small group met with Shelby Pierce on September 16th to discuss ways to better leverage the SCEH. Some thoughts on next steps include needing more marketing and visibility, especially to highlight all the work we all are doing in the community. A gap here is the staff time to make this happen, so maybe it is something interns or coalition marketing staff could fill in here. Looking also for more mental health mobility and assistance for folks where they are, as well as more intensive case management. This group will continue meeting and providing direction and opportunities for the coalition to engage.

Agency Spotlight/Reports/Activities/Updates/Discussion.

- SCEH Photo: we took a photo, but please send Clara photos of your agency building to add to the website.
- Other agency updates:
 - Salvation Army: Angel Tree app will open on 10/20, call 712-255-8836. This will include a food basket and toys. They need translation volunteers. Agencies can help by hosting their own food and toy drive as well as by taking angel tree tags and bringing back the gifts for the families.
 - Austin with Rosecrance Jackson is available for trainings on addiction stigma and Nalaxone/overdose prevention for any group of 3+ people. Email aupierce@rosecrance.org
 - Haven House soup cook off is on 10/11, agencies can make a soup and table services. Email Tammy at Tammyp@havenhousefsc.org
 - Jessica Felix with IDOT shared that staff post notices 48 hours before cleaning up encampments on IDOT property. They are also designing the viaduct to deter encampments.
 - The Siouxland Sleepout is November 7th, contact Joe Twidwell for more twid473@gmail.com;

- The Nameless Project is exploring the option of installing a self cleaning bathroom in downtown. This would provide a much needed restroom where there aren't any public options. They have started with a portapotty already and it's gone incredibly well and has alleviated some of the issues in the block around it's location. They are also hosting a fundraiser for bus tokens to share with agencies that provide services to unhoused neighbors. - Siouxland Community Health mobile showers will continue until mid October. They are averaging 42 people/session, though not all take showers. They've had nurses available on Mondays outside where folks can be seen for minor illness and injuries. They are also doing STD testing on site.
- Center for Siouxland is celebrating 50 years with their fundraiser on 11/7.
