FEES:

There is a one time registration fee of \$20 per student.

1/2 hour class:	\$25.00
1 hour class:	\$50.00
1.5 hour class:	\$75.00
2 hour class:	\$100.00

For a student taking multiple classes: there will be an \$8 discount for the 2nd & 3rd classes, \$10 discount for 4th & 5th classes \$12 discount for 6th & 7th classes.

Families with multiple students: first student pays full price and then there will be a \$2 discount per child for each of the others.

All dance classes will have a monthly installment fee for costumes, competitions, and dance review. This fee will have the same \$10 late fee rule. The installment amount is an ESTIMATE. Monthly installments range from \$10 (preschool) to \$30 (advanced). See cheer contract for cheer installments.
