THIRD ORDER OF BUSINESS Consideration of Matters Related to Approved Cost Certification and Impact Fee Credits

Ms. Buchanan stated this is very similar to what you did earlier in the summer with the Marsh Harbor project. Essentially, in light of some of the work that the district did in connection with construction of roads it was entitled to impact fee credits. What we have done is identify a party that is interested in acquiring these credits from the CDD and we would authorize with this resolution the transfer of those impact fee credits from the District to the party for the value of

\$650,494.09. You will note that we are trying to come up with a standardized process. There is a parking issue at the Ponte Vedra Inn and they are doing some enhancements and we will approve this resolution and that would authorize the chair to execute the assignment and acknowledgment that is incorporated as Exhibit A. We can provide that to the county for their recordkeeping once the credits are technically acquired the district would then be anticipated to use those funds to satisfy some of those obligations under the funding agreements outstanding like the one related to Snowden. I just wanted to give you the full circle of what is happening, which is we have credits we are selling and using the proceeds of those credits to then repay the developer as promised previously.
