Report to the Congregation for the Year 2022

It is a blessing to be giving the good people of Faith Lutheran a synopsis of our time together, even though it has not spanned the entirety of the year! The excellent work on Faith's Ministry Site Profile and those who served on the Call Committee granted me a window to peek through even prior to my arrival! Leadership was also incredibly forthcoming, as were the staff and people of Faith Lutheran.

The purpose of an Interim Pastor is generally to provide a bridge between whatever came before, whether hard or easy, and to assure a measure of stability going forward by leading Worship, administering the Sacraments, visiting the sick, ministering to those who are grieving, and teaching in all areas of our life together. The particular purpose of an Interim Pastor is to always speak the truth in love. We also "listen" as people share their thoughts, concerns, and/or feelings of loss. It is never long before a picture of how members of the congregation see themselves will come into focus. Sometimes rightly, sometimes a bit skewed, whatever the case, the time of transition can be exhausting but can also be exciting and hope filled.

Step by step, we have been moving forward intentionally to meet the targeted areas of concern as identified in your Ministry Site Profile. Thanks to several sets of parents and individuals, Christian Education looks different than in the past, but students are gathering to hear the Word of God and experiencing important milestones in their journey of faith. On October 30th, 2022, twenty-three young men and women personally claimed the promises made on their behalf in Baptism. A combination of 9th and 10th grade students, it was an Affirmation of Baptism Celebration to be remembered!

Fifteen children and their parents or grandparents also participated in a First Communion Class, after which the students were welcomed to Faith Lutheran's larger Table Fellowship on December 11th, 2022. Seeds and Sprouts, led by Libbie Anderson has flourished too; the presence of the "littles" on Wednesday evenings contributes unbounded joy to the life

of our community. Finally, several Adult Bible study groups met weekly or monthly to study God's Word and explore its implication for everyday life. All this and more provides a testament to the spiritual health of Faith Lutheran. Currently, we are seeking to hire a Christian Education Director to assist volunteers and the pastor(s) with the important and labor-intensive task of handing on faith.

Visitation to the homebound, assisted living and nursing home residents was another targeted area that surfaced in the MSP. Faith Lutheran has an amazing group of volunteers called Circle of Support that regularly reaches out to grieving families and a small group that visits people in general. During my time here, only a limited number of such visits have been completed by me due to being the only pastor on staff. Day to day operations, administrative duties, funeral planning, education preparation, Worship and liturgy planning, sermon writing, and so on tends to spread even the best of pastors very thin. Visitation can get lost, especially over/against seemingly more urgent matters and deadlines. Prayerfully, you will remember this as your new pastor attempts to keep all the things he will be juggling in the air.

In addition to the above, Faith Lutheran is being called to step up boldly to meet the Stewardship levels necessary to realize the ministry envisioned by its membership. Leadership has listened carefully to all voices and has budgeted for your future accordingly. Yet, it appears to me that while acknowledging the body of Christ that is Faith Lutheran, and that Faith has been given many gifts: all things music, myriad volunteers, servant leaders, intelligence and professionalism, genuine hospitality and compassion, there is difficulty seeing what Faith Lutheran is being called to become. Being of one mind and heart in Christ Jesus, we must never forget there is nothing that is impossible, for we believe, "With God, all things are possible."

We move into a new year, mindful that from everyone to whom much has been given, much will be required (Luke 12:48a). Generosity is not a choice; it is a way of life! There is no denying the abundance of God's grace and favor poured out on us richly for the sake sharing the Good News! I can only imagine the multitude ways Christ will be made known through you in 2023!

PS: Thank you to all the saints of Faith Lutheran who embraced both Leslie and me as we came among you to partner in ministry. We will thank God every time we remember you!

YOUTH MINISTRY REPORT

First and foremost, I want to thank you, the congregation of Faith Lutheran Church, for welcoming me and my family into the family of Faith Lutheran Church over the last year. 2022 had its fair share of ups and downs for many reasons, but I wish to celebrate this combined youth ministry that I am privileged to serve at here at Faith and Peace Lutheran Churches. In all the new challenges and successes of this year, I am reminded of God's presence and goodness among all of us!

I started officially on January 4th, 2022, serving both Peace and Faith Lutheran Churches, called to focus on the fellowship and education of our students in grades 6-12 at both churches, and in the process bring the two youth programs together as one for our fellowship events, while having separate confirmation programs. I spent the majority of the Spring getting to know our students and families and began my own programming as summer got closer.



LYF meets weekly at 7:39pm on Wednesdays, and starting this summer, we rotate between meeting at Faith and Peace. Favorite events from last year include Bunco Night and the Mall of America retreat in February, the Survivor Lock-In at Peace in April, our summer Valleyfair trip, and meeting throughout the summer for games and s'mores.

For our middle school students, I have helped with teaching and leading Confirmation, and helped to create several fellowship and learning opportunities throughout the year. This included an afternoon at Big Kahuna Park here in Spicer, and our summer mission trip to Sioux Falls this summer with Peace and Vinje Lutheran churches. We served at three area ministries, as well as having play time at the beach, a trampoline park, and a sculpture scavenger hunt in downtown Sioux Falls. This past fall, we brought back 5th Quarter after our home football games hosted at Peace Lutheran three different times and we averaged about twenty students from Faith, Peace, and many other area churches. I'm excited for all these things to continue to grow and become new traditions.

I'm also excited for the shared opportunities to continue between Faith and Peace Lutheran. I am blessed to serve in a very special youth ministry role, and blessed to serve two churches. Some of my favorite combined events were the Fall Festival Fundraiser, and the MEA Paintball Trip. Our Fall Festival Fundraiser was a combined fundraiser for our students at both churches and it went really well! It included carnival games, the rock wall from Prairie Woods, a vendor fair, and a bounce house. We look forward to this new tradition on the first Saturday in October every year! For the MEA Paintball Trip, we took about twenty students in grades 6-12 to Annandale Paintball in South Haven for an afternoon on their three different battlefields!

This has been a great year, and I look forward to many more years to come getting to know each one of you and growing this ministry! I'm forever thankful for all the parents and leaders that make my job so much easier!

Seeds + Sprouts is a ministry program that happens on Wednesday nights for kids ages Preschool through 5th grade. The funding for Seeds + Sprouts was used for activities and craft supplies, along with special party items like snacks and prizes.

During the first half of 2022 the kids split into two groups, PreK-1 with Megan, and 2nd-5th with Mya. For the older group, some weeks are spent creating and crafting, playing games and with new toys, while some weeks are simply spent hanging out in our awesome Youth Space. The younger kiddos spend time in the Praise and Play Preschool room where they do activities, music, reading, and free-play.

During the second half of the year the format of Seeds + Sprouts shifted to better fit staff changes and available rooms at the church on Wednesdays. The night starts with all the kids together during the first 15 mins playing a large group game, discussing get to know you questions and hearing about the plan for the rest of the night. Then the kids split into 2 groups of various ages and each group does a Bible lesson, discussion and then a craft. Take home activities and questions were sent home with each family as a way to further connect the lesson and themes.

Libbie had a baby in November, so we had a great group of volunteers who helped keep the program going from mid-November through the end of December allowing Libbie to take a maternity leave.

On the average night, we have about 15-20 kids total that are ages Preschool through 5th grade. The Seeds + Sprouts activities and themes are different each week.

Some highlights of this year's Seeds + Sprouts were:

- Getting to be outside before it started getting cold
- Easter Egg Hunt
- Family Bingo Night
- Trying new crafts
- Learning more about God's love and kindness

PROPERTY REPORT

First off, I would like to thank Tim Kamholz who served as the Property Manager until he resigned in May 2022. I took over in June and have been busy with all aspects of the property. I very much appreciate all volunteers who assist.

Building maintenance and repairs will always be an ongoing concern. I would like to remind all members our facilities are approaching or have exceeded their 20-year birthday. So, repairs are always needed. I try to do as much as I can, if not I hire a professional to complete the work.

Some of the highlights since June:

- Faith purchased a new garden tractor with a sweeper attachment. This has been a great
 addition to keep the sidewalks clean, especially this winter of 2022-2023. I would like to
 thank all the volunteers that signed up for lawn mowing it was awesome. I will have
 another sign up for next summer. Look for communication regarding that this coming
 spring.
- Thanks to a special contribution from a member of Faith, we have been and still are in the process of upgrading our AV/sound system. As of this writing, we are about 90% complete. Once completed, I will be reaching out for volunteers to operate the AV/sound system.
- The new lighting system for the Gathering Area and Sanctuary is still a work in progress.
 I do hope to have it completed in the 1st quarter of 2023. Willmar Electric was awarded the work.

Faith WELCA has two active groups: Rachel Circle and Faith Quilters.

Rachel Circle

We met 10 times during 2022 at various members' homes or church. We had an average of 6 members at each meeting. We use the Gather magazine, published by the Women of the Evangelical Lutheran Church in America, for our bible studies. January through April, the theme was "The Kingdom of God". May through August, the theme was "Crafted in Christ". September through December the theme was "Jesus and Nature".

We take an offering at each meeting. During 2022 Rachel Circle made donations to:

Parish Arts Team

During the past year, PAT has changed the following for the church seasons: paraments, sanctuary streamers, banners, outdoor planters and table centerpieces. Outdoor flags are used periodically.

In addition, PAT has planned several special projects. During Lent, the Prayer Wall was used for people to write their prayer concerns on and put in the wall. Pastors would review them and add to their prayers. Working with the Sunday School, the sanctuary windows were painted like stained glass with a cross theme to go with the lent theme "Journey to the Cross". Crosses were also displayed with drapes in the Sanctuary and entryways. Easter brought the outdoor flags and butterfly banners added to the Sanctuary.

PAT took over the display case to the right of the Fellowship Hall and has used it for a fall theme, Thankful Tree, for people to write what they are thankful for on the leaves and presently Be the Light theme.

At Christmas, PAT brought back the blue Advent background scene behind the choir seating, along with the Advent Wreath, poinsettias, trees, streamers, and outdoor nativity scene to add to the Christmas season.

THE MINISTRY SITE PROFILE REPORT

Jill Rohman

The **M**inistry **S**ite **P**rofile is a hefty document that describes our congregation in detail. Once approved, it is posted on the ELCA website and only accessible to pastoral candidates seeking a call. Our MSP committee members were tasked with creating the profile, with guidance from Interim Pastor Gary: Patrick Goebel, Phyllis Jacobson, Sherri Klaers, Tim Renner, Jill Rohman, and Marlene Vossen.

Although each member had our own thoughts about our Faith's needs and desires, this group was committed to hearing the voice of our congregation as a whole. After reviewing other surveys and thinking about Faith's history and current status, the committee created the survey that was distributed in March 2022. A lot of thought and effort went into reaching every single Faith member. You were generous and insightful with your input. The survey identified our strengths in programming, technology, being open and welcoming, partnering with other churches, and offering a variety of services. It also identified our needs.

- 1. Visitation/Pastoral Care 2. Preaching/Worship 3. Youth/Family Ministry
- **4.** Administration/Finances

Staffing:

1. Lead Pastor and Associate Pastor **2.** Co-Pastors **3.** Lead Pastor and a Part-time position for Children Youth and Visitation **4.** Volunteer Coordinator **5.** Bring back Committees

The MSP was developed with your survey input. It was presented to and approved by the Council on 5/19/2022, then digitally submitted to our Southwest Minnesota Synod and made active on their pastoral candidate site. THE CALL COMMITTEE REPORT

The Call Committee appreciates the trust and support of the council and congregation. Our committee began by meeting with the Synod to learn about the call process and the role of the Call Committee. Our next steps included developing interview questions, planning our process and reviewing Rostered Minister Profiles (RMPs) that the Synod sent us from pastors that were interested in the position. We interviewed several candidates, and watched online sermons from the pastors. For the pastor that was recommended to the council by the call committee, we conducted 2 in person interviews, provided him with a tour of our church and the local community, we watched online sermons, a member of our call committee attended an in-person sermon and we called multiple references. After this information was gathered, we met as a committee and unanimously voted to recommend him to the council as a Lead Pastor.

Being on the call committee provided us with an opportunity to become better acquainted with others in our congregation, although it was a challenging task, we enjoyed our time together. It was valuable to have many perspectives on the committee, we appreciated one another's opinion and learned from each other. Throughout the process we acknowledged the importance of patience, discernment and prayer.

THE CIRCLE OF SUPPORT REPORT

Circle of Support Team

Mission Statement: To extend the love of Christ through a visitation ministry that seeks to grow and support relationships. Our focus group are those experiencing grief and loss.

This team was established in response to meeting the needs of members who were experiencing grief and loss in 2020. A small group of people received foundational information regarding grief from Evy Hatjistilanos, Katie Bonde, Rosie Peterson, Brenda Weise, David Rivers, and Pastor Dean Johnson. After gathering information and developing a mission statement, we began establishing a visitation ministry which included ways to support someone who is grieving. We also provided three grief presentations open to the committee, those experiencing grief or loss and interested congregation members.

In 2022 we offered Faith's first Grief Support Group led by Brenda Weise for 4 weeks at Faith. We had 8 participants plus Brenda. After the group ended, they decided to continue meeting monthly and still are meeting.

Together with Peace, we offered our first Blue Seasons Worship service on Nov 20th. We hope it will be an annual service alternating with Peace Lutheran. The service was an opportunity to experience that in the midst of whatever grief, pain, or difficulty we face we are reminded of the Light that always shines in the darkness.

We supported 22 families experiencing grief and loss in 2022. The support included phone calls, letters, cards, and visits. We also use a variety of resources including Stephen Ministries' Journey Through Grief booklets. As we recognize that grief is a necessary part of everyone's journey, the Circle of Support visitation team commits to following people for at least one year after the death of a loved one. We have found these relationships are long lasting.

THE FREEZER MEAL MINISTRY REPORT

The Freezer Meal Ministry is a unique and creative ministry here at Faith. Participants in the Freezer Meal Ministry pay for the groceries to make meals for their own families as well as cover the costs for additional meals that are frozen and stored at the church and later delivered to those who are grieving, experiencing illness, welcoming a baby or just in need of a meal. They get together in the afternoon and spend time together prepping, preparing, and dividing all the food so it is ready to be taken home for a quick and easy meal down the road.

This year, the group met 4 different times through the year to cook together. These took place on January 23, March 6, May 22 and October 16.

Due to this amazing ministry, Faith Lutheran Church received the Lutheran Social Services' Servant of Christ Award for 2022.



THE COLUMBARIUM REPORT

Columbarium Chair, Jeff Johnson

The Columbarium and Prayer Garden area continues to be a place of quiet solitude and yet at the same time offers a different perspective of life here at Faith and afterward. Over the past years it has been utilized for outdoor worship, weddings, and funerals. We appreciated the versatility of the space during the initial season of COVID and now it continues to be used for special occasions and various services. This past year saw several inurnments occur along with worship services. Currently there are 40 niches of the available 96 that have been sold and of these 29 have already paid in advance the after-death costs. We did have to institute an increase in this fee to \$325 per person to cover the increase in the cost of urns and the engraving that is charged by Eickhoff. This was the first increase since we constructed the unit in 2016. We hope that this price holds relatively stable for the next several years.

If you visited the columbarium last fall you noted a flurry of activity occurring. As a result of several donations along with existing funds in the Columbarium account we were able to purchase 3 limestone benches. As the plantings had not been changed since the original time, we thought it would be ideal to invigorate the stands with some new plants, retain some older ones and add new mulch. We were approached by one of our members, working on his Eagle Scout Project, interested in helping implement these renovations. Ian Carlson stepped up, organized the planning and implementation of the project including the installation of the benches, new mulch and fabric, re-alignment of the irrigation to aid the new plantings and organizing donations, finances, and volunteers to accomplish these tasks. We wish to thank lan, his parents, Don and Kristi, and his army of workers for volunteering. Throughout the year the Columbarium and Prayer Garden benefits from volunteer lawn mowers, tree trimmers, snow shovelers, plant tenders and weed removers. We want to thank everyone that pitched in and helped with those tasks as well as those that donated trees and plantings to keep this area inviting and relaxing.

Please also feel free to remind others in our community that this place of rest is open to all believers. One does not need to be a member of Faith Lutheran to be inurned at Faith. The cost of a niche in this unit remains at \$1600 which, together with the after death costs (\$325 for each person) allows for the inurnment of 2 individuals. Simply contact the church office for assistance in setting up an appointment.

Contributions to Faith decreased by 4.8% compared to 2021. We were able to save over \$41,000 in expenses compared to the budget. We received ERC payments of over \$55,500 and were able to reimburse the General Fund \$22,501 from remaining preschool finances. These were funds that Faith's General Fund had covered throughout Praise & Play's early lean years. These funds were of great benefit to the financial position of the church but are one-time opportunities. Stewardship will be very important in 2023.
