FAITH LUTHERAN CHURCH ANNUAL MEETING MINUTES January 28, 2024

The Annual Meeting was called to order by Secretary Carla Miller at 10:15 am. Attendance - 96 Members, Quorum met.

Introduction of the Church Council present: Carla Miller - Secretary, Doug Gronli, Marti Carlson, Jennifer Hanson, Tracy Tebben, and Mike Buboltz, Sonya Erickson – Treasurer, Pastor Tim Routh, and Pastor Katherine Rood. Absent: Dean Lindquist – President, Ross Olness – Vice President, and Mary Felt

On behalf of the absence of Faith Church President Dean Lindquist, Carla Miller read his President's Report to the Congregation.

Opening prayer was led by Pastor Tim Routh.

Tracy Tebben agreed to act as our Parliamentarian.

Doug Gronli volunteered to be the acting Secretary for this meeting.

Adoption of the Agenda as written:

*Ed Rauk made a motion to accept the Agenda as written with the exception to change the Leader of the Annual meeting from Ross Olness to Carla Miller. Al Miller 2nd the motion. Motion carried.

Approval of the Minutes from the 2023 Annual Meeting:

*Tom Jacobson made a motion to accept the Minutes from the 2023 Annual Meeting. Pastor Tim Routh 2nd the motion. Motion carried.

Review of the 2023 Financial Summary – Presented by Sonya Erickson, Treasurer. She stated that our Mortgage will be paid off June of 2031.

Presentation of the 2024 Mission Plan – Sonya Erickson, Treasurer explained to Faith members that the Mission Plan was developed by using 2023 history and adding 17% increase. Inflation was a key factor, along with the age of our building, and raising insurance costs. The total budget was decreased by \$100,000 from 2023. This reduction will be more realistic.

*Nathan Groteluschen made a motion to accept the 2024 Mission Plan as presented. Guy Christianson 2nd the motion. Motion passed. Nominations: Carla Miller presented the Nominations for the following :

Congregational Meeting Quorum:

Presented by Carla Miller. She explained to the Membership that the Faith Church Council had made a motion to change the Annual Meeting Quorum from 7% voting members to 50 members present. This is a two year process and told the membership that it has been advertised in our e news letter, bulletins and the monthly Forecaster. The time has come to ask for the final consent to Ratify the Constitution.

*The Congregational Council proposes a motion to change the Congregational Meeting Quorum requirements as set in C10.04 of the Constitution, from 7% voting membership to 50 members voting and present. Paul Carlson 2nd the motion. Motion passed.

Approval of the Mission Plan:

*Nathan Groteluschen made a motion to accept the 2024 Mission Plan as presented. Guy Christianson 2nd. Motion Passed.

YOUTH MINISTRY REPORT Youth Ministry Director, Quentin Markfort

"But grow in the grace and knowledge of our Lord and Savior Jesus Christ. To him be the glory both now and to the day of eternity. Amen" -2 Peter 3:18

As I reflect on 2024 from beginning to end, I believe the words above from the Apostle Paul fit what has happened within our ministry in the last year. With praise to God, especially in the fall, we've seen incredible growth in our regular and special events from the beginning of 2024 until now. For me as the staff member, it's incredibly exciting to see what God is doing in this time and place as our youth continue to learn more about God. I'll break my report up into middle and high ministry, but before I do, I want to offer one specific thank you. To our shared Youth Board of Peace & Faith, I'm so grateful for your wisdom and time. This board had adults from each church, and we meet roughly every two months. Their wisdom about the needs of our families has shaped our programming in a really positive way. I'm grateful for each of you!

For our middle school students, we started off 2024 with a new program named "3rd Half", which is basically winter 5th Quarter. We had snacks and games on two Friday nights after doubleheader Varsity Basketball games and saw 30-40 students each time. In February, we enjoyed our annual trip to Andes Tower Hills on President's Day for grades 6-12. Our group was about 20 students between Peace and Faith, and it was a great day!

Our year of growth continued with our middle school students with two successful trips. We had our first shared Service & Fun Trip together that had three students and two adults. We served at a Food Shelf at Living Waters Lutheran in Sauk Rapids, and we visited a Nursing Home with two therapy dog handlers and their dogs. Our Crow Wing River Canoe Trip doubled in size, taking 6 students and two adults on roughly 35 river miles in God's creation over four days and three nights. I'm excited to continue to grow these off-site ministries in the summer of 2025.

This fall, we had three 5th Quarter after football events. For these events, we averaged over 100 students each Friday, which was an incredible growth from last year. One Friday night saw students from 14 area churches, plus many students that did not have a church home. It's clearly a need that we're meeting in our community, and a fantastic outreach opportunity for our churches. I'm thankful for over 20 different parent volunteers that made this possible, many of whom spent all three Friday nights with us. We couldn't do it without you! This October we had the MEA Paintball Event for grades 6-12 with 12 students, and a really great representation of 19 students and 4 adults attending our Synod's Jr. High Youth Gathering in late November.

Our high school ministry continues to flourish and grow, as well. Specifically for our high school students, our first big event of the year was our Survivor-themed lock-in at Peace. We partnered with the Big Grove Crow River Grace Parish for that event, and had a great time! This past summer our shared youth group, LYF (Live Your Faith), met regularly on Wednesdays and had a day at Valleyfair. Many of our high school youth can also be seen volunteering at our middle school 3rd Half and 5th Quarter events throughout the school year, and I'm incredibly grateful for their leadership.

This school year our goal for high school ministry was to continue to grow LYF in new ways. We've had several strong classes of students graduate the last couple years, and we were looking to get more students involved. To accomplish this, we formed a leadership team of students that meet regularly to plan a special event for LYF one Wednesday per month. So far this year these events have included Romans and Christians, Halloween Movie Night, Game Night for the Link, and our Christmas annual Party. By God's grace, these efforts have grown our group tremendously. We average about 15 high school students every Wednesday at LYF, and our special events have consistently seen 20-30 students.

Finally, I want to offer a heartfelt thank you to all the parents and adults that offer their time for our events like 5th Quarter, Confirmation guides, and regular volunteers at LYF. It truly takes the entire body of Christ to make this ministry possible, and we couldn't do what we do without your time and help. As your staff member, it's my privilege to serve in this ministry and share these incredible stories of growth in our shared ministry between Faith and Peace Lutheran Churches. I'm thankful for all the ways our churches support our youth through fundraisers, event volunteers, and most importantly everyone's prayers. Together we will continue to shape our youth to be thoughtful disciples, and I look forward to a great 2025!



SEEDS + SPROUTS REPORT Seeds + Sprouts Program Leader, Libbie Anderson

Seeds & Sprouts is a ministry program that happens on Wednesday nights for kids ages Preschool through 5th grade.

The night starts with some group get-to-know you questions and discussing the plan for the night. Then the kids split into 2 groups of various ages and do a craft/art project based on the night's biblical theme. Then we all come back together to do a Bible lesson and discussion. We end the night with time playing a large group game or activity.

On the average night, we have about 15-24 kids total that are ages Preschool through 5th grade. The Seeds + Sprouts activities and themes are different each week.

Highlights from the year:

- Getting to be outside to play games no matter the weather
- Having a Halloween party with games, snacks and indoor trick or treating
- Making & decorating Christmas cookies for Faith staff
- Trying new crafts and using new art supplies
- Learning about the Beatitudes, Fruit of the Spirit, Who is God, Peace, Resilience and Gratitude
- Having an end of the school year Family Bingo Night
- Painting birdhouses with seniors at Glen Oaks
- Making Thanksgiving cards and making homemade soup for the seniors that Faith volunteers visit
- Continuing to practice kindness and learn about God's love
- Seeing the older kids help the younger kids and lead by example
- Having our awesome intern, Camyrn join us and help lead and plan the night
- Having amazing teen volunteers Maddie come twice a month and having parents help with service project nights

The funding for Seeds + Sprouts was used for activities and craft supplies, along with special party items like snacks and prizes.

Faith's Children's Ministry continues to be an important asset to our church. Our programing continues to be in transition mode from a mostly volunteer collaborative effort, to a paid coordinator and worship leader. Tina Magner added an additional 4 paid hours to her schedule to take charge of curriculum writing, sharing her expertise in creating engaging and enriching materials for the Sunday School Program. Her work has been an excellent and integral part of the program. Welcome Center volunteers have gathered materials for the lessons each week. The teamwork of the Education Committee, the classroom teachers, our GLLM Associate, and parents reveals how Faith Lutheran continues to prioritize our children's spiritual growth and wellbeing.

Mission Statement: To extend the love of Christ through a visitation ministry which seeks to maintain Faith relationships with people who are homebound or living in nursing homes.

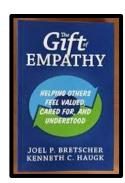

2024 Faith Quilters:

The Faith Quilters meet on the 2nd and 4th Monday and Tuesdays of each month except for the months of June, July, August, and December from 9:00am -3:00pm. In the year 2024 the quilters met for 29 days with an average, short of 8 people each day.

We made 157 quilts during those days and they have been distributed during the year. They included 21 quilts donated to the Faith High School Seniors, others went to Salvation Army, Red Cross, Lutheran World Relief, Safe Haven, Hospice, Family promise, Willmar Community College Campus, and Woodland Center.

This is a mission project and we function on monetary donations from the congregation, members' Thrivent donations, individual donations of material, yarn, thread, and individual volunteers (something to do for all talents or interests.)

<u>Lutheran World Relief Backpack Program</u> Lynda Manselle leads the school bag program. They sent off 116 completed school bags to LWR.

COLUMBARIUM REPORT Jeff Johnson, Sue Westre, Gary Lagerstedt

The Columbarium continues to be utilized, not only for inurnment of our members and neighbors but also for worship, solitude, and contemplation. It stands ready to continue those uses in 2025 and beyond. If you have not had an opportunity, we encourage each of you to take a walk down the sidewalk, stopping along the way to smell the fragrant flowers (in season, of course) read the inscriptions and consider a niche for your final resting place.





When visiting please take a look at the newly installed pergola along with flower planters and posts. These were installed with the help of generous anonymous donors of funds, time and equipment. Several pine trees were trimmed to provide more visibility from the parking area and one tree that was encroaching on the walkway was removed. We think that most will agree that all of these enhancements have

contributed well to the overarching mission of the garden area. Thanks to the donors and all the volunteers that helped and continue to do so.

Speaking of maintenance, we also wish to recognize and thank Tim Renner and his crew of lawn mowers and snow shovelers for keeping the entire Prayer Garden area looking neat and trim. There are always a lot of behind-thescenes activities that must be undertaken to keep the area looking neat and inviting. We currently have **sold 48 of the 96 niches** with many of the purchasers having also paid their after- passing costs as well. To be fiscally prudent we have utilized these after passing payments to acquire adequate urns to ensure



sidewalks. The units themselves will be installed as we see needs arise based upon sales of existing niches. Due to the increased cost of the niche units themselves the individual niches will be marketed for a cost that will be higher than what the existing units are selling for, which is \$1600. If you or others in the community that you know are considering purchasing a niche this would be a good time to do so.

Please also feel free to remind others in our community that this place of rest is open to



that increasing costs do not have an adverse financial impact on the Columbarium account. The after-death funds are maintained to pay for the engraving and postage of the granite face plate at the time of passing. Moving forward into 2025 we have proposed to the Council for continuance of Phase II which will incorporate additional sidewalks to the north and bases for the further niche units. Once we begin that phase, we will be reaching out for volunteers to assist in the necessary labor to install these



all believers. One does not need to be a member of Faith Lutheran to be inurned at Faith. The cost of a niche in this unit remains at \$1600 which, together with the after-death costs (\$325 for each person) allows for the inurnment of 2 individuals. Simply contact the church office for assistance in setting up an appointment.

With our member's generous gifts of time, work, and resources, Faith has supported the following organizations with our VOLUNTEER HOURS, MISSION OF THE MONTH OFFERINGS and NOISY OFFERINGS:

- Safe Avenues Provides advocacy, parenting time services, and emergency shelter for victims of domestic and sexual violence in a five (5) county area of West Central MN.
- The Link A partnership of Spicer and New London area congregations, providing programs to residents experiencing financial struggles. Our offering collections supported:
- Food Pantry Providing groceries for families with food needs.
- Wildcat Backpack food program Providing weekend food for NLS student families with food needs
- Tuesday's Table A community meal for all on a weekly rotation of five (5) congregations. Meal is hosted at Faith by our volunteers on the 3rd Thursday of the Month.
- Christmas Joy (Faith's Mitten Tree) Providing Christmas gifts for families in need.
- Thrift Store This year, our Mission Committee has been recruiting volunteers to be Thrift Store workers at The Link on selected Saturdays.

- Family Promise of Kandiyohi County An interfaith ministry consisting of approximately twenty (20) county congregations serving families who are experiencing homelessness. FPKC opened a residential shelter in 2023. In addition to shelter bedrooms and kitchen, FPKC provides advocacy services to families seeking affordable housing. This is crucial to overcoming barriers in acquiring housing. Faith coordinates providing meals for FPKC guests four (4) weeks a year, with volunteers from Faith, Peace, and Universal Unitarian working together to provide meals and groceries on our scheduled weeks to Family Promise guests at their shelter in Willmar.
- **Community Garden** Fenced-in garden plots, on Faith's property, are available at a very affordable cost to anyone wishing to garden. Watering is included. A "Bounty Cart" offers excess vegetables to anyone.
- Green Lake Lutheran Ministries A partnership of camps, communities, and congregations supporting Green Lake Bible Camp, Shores of St Andrew Bible Camp, and Camp House. These camps of the ELCA provide a wide variety of opportunities to campers and retreat participants of all ages. Faith is also blessed to provide summer worship services at Green Lake and a Noisy Offering collection goes to GLLM.
- Vacation Bible School Offering scholarships for a fun-filled Christian education experience to our youth. Partnering with Peace Lutheran Church and Green Lake Bible Camp.
- The American Red Cross- Offering services in Central Minnesota for disaster relief and coordinating blood drives.
- Freezer Meals Here at Faith. Participants in the Freezer Meal Ministry pay for the groceries to make meals for their own families as well as cover the costs for additional meals that are frozen and stored at the church and later delivered to those who are grieving, experiencing illness, welcoming a baby or just in need of a meal. They get together in the afternoon and spend time together prepping, preparing, and dividing all the food so it is ready to be taken home for a quick and easy meal down the road.
- Quilters Making and providing warm quilts to Lutheran World Relief, Red Cross, Salvation Army, Faith's high school graduates, and various organizations in need. Traditionally, a quilt is also donated to the GLLM Auction.
- Faith's annual plantings outside the church were boosted by Noisy Offering.

In 2024, grants were approved for a total of \$4,899.98 that went towards funding wi-fi across the GLLM campus, including the chapel, OWL camp, a sun-shade at the YMCA daycare in Spicer, new shelving for the nursery, and the sound system for the outdoor pergola. While the endowment team still has not reached enough grants to put all monies available to our endowment team each year to use, we are enthusiastic about the growing number of grant requests and the creativity in how we can meet our mission both inside and outside of our walls.

In 2025, the group plans to continue to offer grants for any projects or work that support the mission of Faith and we plan to expand on our story telling of the things these grants do for our church and our community. We also intend to more broadly share how members of our church can give to the endowment, benefiting our community now and for years. To come.

THE CIRCLE OF SUPPORT REPORT Circle of Support Team

Mission Statement: To extend the love of Christ through a visitation ministry that seeks to grow and support relationships. Our focus group are those experiencing grief and loss.

Circle of Support is a group of Faith members who reach out to people who are experiencing grief and loss. This past year we have supported over 32 families through visits, card ministry and other contacts. Thirteen of those families have been interested in a visitor following them. We continue to ask for help in identifying people in our congregation who are going through grief or loss.

Highlights

- A spreadsheet is used to track people visited through Circle of Support to help pastors follow the needs for visitation or support. Members update the pastors on their contacts.
- We use the series of 4 Stephen Ministry grief booklets to share with people throughout the first year of their grief journey.
- New resources have been added to the Circle of Support Resource Library for members to access.
- Prayer shawls/squares are available to share with people.
- Through our card ministry, members who have had the death of a loved one are sent a note card included with resource information and phone numbers of the pastors for their use. A follow up is offered.
- A Blue Christmas was held at First Lutheran of Norway Lake together with Peace Lutheran on December 21st
- A gift of money enabled Circle Support to share 30 Amaryllis bulbs with people we have been following this year. Poinsettias and Easter flowers are also shared.
- Together with the Faith Visitation Team, we had a book study/visitation training using the "Gift of Empathy" book. Pastor Katherine led 2 sessions with the groups in the fall.
- Pastor Tim led an Adult Forum on the spiritual side of end of life planning. This is the first of in a series of adult forums on "End of Life Planning" we are planning.
- For 2025 we are planning to offer additional adult forums on death/funeral planning, meet quarterly to connect, offer more visitation training, and offer a grief support group in the spring.
- Our group sponsored OWL Camp in May as a part of reaching out to offer more socialization for older wiser learners.

BETHESDA MEMBER CONGREGATION REPORT Jeff & Chery Johnson

There are 23 member congregations of various denominations who help to support the mission of Bethesda. One of these congregations is Faith Lutheran Church. Jeff and I attended Bethesda's Annual Meeting on October 10, 2024, as representatives from Faith. Each member church is authorized 2 delegates to the Annual Meeting. Representatives from the member churches are invited to attend the annual meeting to learn about the mission and accomplishments of the organization over the past year. Bethesda is a locally led and managed nonprofit that provides housing and care for seniors including skilled nursing care, short-stay therapy, home health care, outpatient therapy, independent and assisted living, adult day services, and a wellness center. They have 3 campuses, the main campus in Willmar, North Pointe in New London, and an assisted living site in Olivia.

Some of the highlights from 2024 included:

- The organization has a 47.7-million-dollar budget. Of that, \$23.275 million is invested into payroll for its approximately 625 employees.
- \$0.90 of every dollar generated goes back into resident care, programs and services provided.
- Just over \$144,600 was invested back into staff tuition, student scholarships and education to maintain quality care for its residents and ensure that staff are afforded opportunities to grow within the Bethesda family.
- Bethesda Foundation hosted their annual Sweetest Christmas Soiree which included a bake sale and a gala at O'Neil's in Spicer. The foundation supports needs at Bethesda that are not covered by other sources. They raise funds for Chaplaincy Services, Hospice, Resident life and have a special focus on transportation. Mobility van access is critical at both campuses and enhances the lives of residents by allowing them transportation to health care and community events. Donations and bequeathments are always welcome.
- Other services provided through Bethesda include Support groups for Parkinson's and Alzheimer's, Diseases, Hospice, Homecare, Adult Day Services, Outpatient Therapy, and Club Bethesda.

Current Building Projects include:

- 10 additional independent living units and a heated saltwater pool on the North Point Campus in New London opened in December of 2024. Included in the saltwater pool area is also a steam room, handicap access ramp and aquabikes for aerobic exercise. There are ongoing water aerobics classes both at North Point and at the Willmar campus as well as a fully functional fitness center at each campus. Both of the fitness centers are open to individuals over 50 years of age for a small monthly fee. You do not need to be campus resident to use them.
- Progress on the 118 unit Stone Ridge independent living housing project on Willmar Avenue is right on schedule with a projected completion date in the late fall of 2025.
