

## Holy Rosary Academy School Policies 2023-2024

The students and staff of Holy Rosary Academy take pride in the exceptional learning community that is shared on our campus. To maintain this positive feeling created through this community and to ensure that all students have an opportunity to succeed, students must agree to follow a few very specific school policies. The following policies are in effect at all times during school hours and while students are participating in all school sponsored activities.

Take a moment to carefully review the policies listed below. If you have any questions, please ask for an explanation.

1. A student who is absent must have a parent call the school the morning of the absence and send a note upon the student's return to explain the absence. ***A student who is absent has 3 (three) days to make up any missed work or tests.***
2. Students may not bring radios, ipods, cell phones, smart watches, cameras or any other electronic devices of any kind on campus. ***Any student caught with an electronic device will have it taken away and the device will only be returned to a parent along with a fee. The penalty for the first offense is \$25.00. This amount will be doubled with each offense thereafter.***
3. Students must dress according to the uniform code at all times. This includes a belt and ankle length socks (low socks are not allowed). Shirts must be tucked in at all times. Uniforms must be purchased only at approved school approved vendors. Nail polish or acrylic nails not permitted. Students are expected to wear appropriate clothing on free dress days. Short shorts, halter tops or spaghetti straps will not be allowed. Clothing with offensive statements or graphics will not be allowed.
4. Suspensions and/or referrals for expulsion may be made when it is determined that a student:
  - a. has caused, attempted to cause, or threatened physical injury to another person
  - b. has caused damage or has vandalized any school property.
  - c. has possessed, sold or otherwise furnished any dangerous object at school
  - d. has unlawfully possessed, used, sold or otherwise furnished, or been under the influence of any controlled substance including alcoholic beverages, tobacco, or intoxicants of any kind.
  - e. has possessed, offered or arranged to sell any drug paraphernalia.
  - f. has cheated on an assignment or test.
  - g. willfully violated the internet agreement or misused their computer privileges.
  - h. Has used vulgarities and/or any other inappropriate language
  - i. has committed robbery, extortion or otherwise engages in any illegal activities.
5. Students must stay on campus during the school day and be checked into the Extended Care program at 3:00 pm on regular school days or 12:00 pm on minimum school days if not picked up by a parent or authorized person. ***Students may not wait outside the school grounds for their ride and must never leave campus unattended or with another parent without written or verbal permission to the administration.***
