II. MEETING PROPER:

1. Introduction of the Board of Trustees and Officers

The members of the Board of Trustees present were introduced one by one and acknowledged their presence in the meeting. Those present online through Zoom were likewise acknowledged.

2. Invocation and National Anthem

Audio-visual presentations were presented for this portion instead of live prayer and mass singing.

3. Welcome Remarks

Trustee Ferdinand M. Garay, President of Lakan MBAI welcomed the participants by reminding them to remain steadfast in their commitment to serving the community and advancing Lakan MBAI's mission to foster brotherhood and mutual assistance among members. He urged them to continue pursuing the attainment of the vision of the Association to be the best provider of quality mutual benefit services in the public safety sector by the year 2030.

4. Call to Order

The Chairman of the Board of Trustees, Trustee Tomas G. Rentoy III, called the meeting to order and acknowledged all present including those who are watching through web Zoom.

5. Determination of Quorum

Ms. Rosalina V. Bactol, Board Secretary informed the body that there are sufficient attendees of the meeting, hence she reported to the Chairman that there is a quorum for the meeting.

Trustee Usec Barretto moved for the approval of the recommended agenda for the AGMM which was duly seconded by Trustee Garay. The Chairman declared the agenda, as presented in the Notice of Meeting, duly approved.

7. Reading of Minutes of Previous Meeting -

The reading of the minutes of the previous meeting was dispensed with considering that members/attendees were already furnished thereof before the meeting for their review. Trustee Garay moved for the approval of the Minutes of Previous Meeting and having been seconded by Trustee Usec Barretto, the same was approved.

8. President's Report

On behalf of the Board of Trustees, Lakan Ferdinand M. Garay, President, presented the accomplishments and updates on the Performance of the Association for the period June 2022 to July 2023

ON OPERATIONS -

- a) Membership As a result of more intensified efforts of information drives and campaigns, members increased from 1,248 in 2022 to 1,600 in 2023, or an increase of about 28.21%.
- b) Accreditation To facilitate the remittance of premium payments, close coordination with partner institutions was made. Aside from the Committee on Accreditation for Automatic Deduction (CAAD) which was approved by PNP on March 11, 2022, the CAAD accreditation was also granted by the BFP last December 22, 2022. The same accreditation with BJMP is likewise ongoing and the MOA signing is being scheduled.
- c) Approval by the Insurance Commission of LAKAN MBAI New Loans and Investment Products – New Loan Investments Product was approved by the Insurance Commission on March 17, 2023. The scheme was envisioned to provide financial assistance to members who are in need through loan extensions. The following loan products are available to members:
 - 8.c.1 Contribution Loan (Equity Loan)
 - 8.c.2 Salary Loan
 - 8.c.3 Emergency Loan
 - 8.c.4 Calamity Loan
 - 8.c.5 Housing and Repair Loan 8.c.6 Car/Motorcycle Loan
 - 8.c.7 IT Equipment Loan
- d) Acquisition of Additional Business Office The Association acquired an additional 32 sqm office space on May 5, 2023, located at Unit 706 7/F Tower C, Regalia Park Tower, 150 P. Tuazon Blvd. Quezon City. The office was acquired primarily to be used by the Management and Staff of LAKAN MBAI in its normal day-to-day operations, with the end view of generating savings instead of paying the high cost of rent.
- e) Claims by Beneficiaries A total of five (5) Death Claims were processed by LAKAN MBAI for this year. The beneficiaries of the three (3) death claims were already settled/paid in the amount of One Million Pesos (Php1,000,000.00) each while the remaining two (2) are still being processed and awaiting

completion of documentary requirements. As to Medical Benefits, medical reimbursement to two (2) members was already granted amounting to Fifty Thousand Pesos (Php50,000.00) each.

f) Other LAKAN MBAI Optional Products – The Association agreed with IMS Wealth Care (IWC) to provide its members with HMO coverage for an affordable monthly contribution. Likewise, Diamond Memorial Care was chosen to offer an option to LAKAN MBAI members for a complete pre-need package of funeral services at a reasonable monthly rate/cost.

After the Chairman asked if there were no further questions on the President's Report, Trustee Usec Barretto moved for the approval of the report which was duly seconded by Trustee Rariza, the President's Report was declared approved.

9. Presentation and Acceptance of the Audited Financial Statements by the Treasurer:

The Audited Financial Statements as of December 2022, with comparative figures as of December 2021 presented by Lakan Mario N. Rariza, Jr., Treasurer, as follows:

The financial data disclosed that the Association incurred a net deficiency of Two Hundred Forty Thousand Eight Hundred Ninety-Nine Pesos (Php240,899.00). This was mainly caused by the setting up of the Equity Values (savings portion) of the members' contribution required by the provision of the Insurance Code. Considering that said provision came with the approval of the product of the Association which was approved by the Insurance Commission in February 2022.

Management and staff should continue to exert all efforts and focus on a more vigorous campaign, with the end view of moving forward to increase membership and collections to attain its goals and visions. Cooperation and unity of all members will lead to success for everyone to share with.

There being no further questions on the Treasurer's Financial Report, Trustee Bathan moved for its approval, duly seconded by Trustee Sto Domingo, and the Report was declared approved by the Chairman.

Ratification of All Acts and Resolutions Passed by the Board of Trustees for the period July 2022 to June 2023 –

All the acts and resolutions passed by the Board of Trustees from July 2022 up to June 2023 were presented on the screen for approval and ratification. Copies of said acts and resolutions were sent to the members in advance for their review and consideration. There being no further questions relative to the acts and resolutions passed by the Board of Trustees, the same was duly moved by Trustee Rariza for approval, duly seconded by Trustee Bathan, and declared by the Presiding Officer as duly approved.

11. Questions and Answers /Open Forum -

The common question raised by the Cadet attendees pertained to the loan products to be offered by LAKAN MBAI to members and the same were answered by the members of the Board of Trustees.

11.1 Q: How much can be availed for Salary Loan?

A: Initial amount of the loan is Php50,000. Upon renewal, the loan amount can be increased depending on the Member's capacity to pay. The maximum amount of loan is Three Hundred Thousand Pesos (Php300,000.00).

11.2 Q: Who can avail of the loan?

A: All members active on the service (PNP; BJMP; BFP) who has the capacity to pay and are not delinquent in the payment of membership contributions.

III. Introduction of the Guest of Honor & Speaker -

The Guest of Honor, PMGen. Eric E. Noble was introduced by Trustee Buenaventura M Viray Jr., Vice-Chairman of the BOT.

The Speaker shared his experiences, including all the hardships/struggles he had undergone and overcome until he attained his position as Director of the Philippine National Police Academy and his upcoming reassignment as the Director for Investigation and Detective Management in Camp Crame.

He mentioned that the Cadet Officers and students, uniform and non-uniform personnel of the Phil. National Police, Bureau of Jail Management, and Bureau of Fire Protection (PNP; BJMP; BFP) must be encouraged to join the Association as it will truly be beneficial for them and their families. He is looking forward to continuous coordination with the Academy and the MBAI for the good and betterment of the members. He emphasized the need for unity among members to strengthen the Association and to achieve its goal of assisting members as the need arises.

PNPA graduates and the PNPA cadets are closed groups such that they readily qualify to be members of distinct and separate Savings and Loan Association. He thus encouraged the Lakan MBAI management to the possibility of spearheading efforts of providing the foundation and infrastructure for a Savings and Loan Association for these members.

IV. Adjournment - There being no other matters to be discussed, the meeting was adjourned at around 3:00 PM.

To All Lakan MBAI Members:

It is with great pleasure that I present the Chairman's Report for the Annual General Membership Meeting (AGMM) of the Lakan Mutual Benefit Association, Inc (Lakan MBAI) for the 2nd semester of 2023 and the 1st semester of 2024. This report aims to underscore the key achievements and challenges hurdled by our organization over the said period including the strategic directions we will pursue for the coming years and beyond.

Overview:

The period covered by the report is deemed another transformational phase for our organization. While we were able to secure approval from the Insurance Commission for the amendments in our basic products at the end of last year, there were consequential adjustments in our fund management, and in recording such modifications. Nevertheless, we successfully weathered these challenges, embraced the new regulatory requirements, and integrated them into our operational schemes.

Likewise, despite the global uncertainties brought about by the recent COVID-19 scourge, we continued to uphold our mission of providing excellent mutual benefit services to our members through responsive insurance protection, health care maintenance, and memorial service programs, including other mutually beneficial entrepreneurial and investment services. Our core values of dedication, professionalism, and accountability for nurturing the needs of our members have guided us through these ambiguous times and prepared us for similar ordeals in the future.

Financial and Operational Performance:

Our financial and operational performance remains strong, The Associate achieved a 42% increase in the total excess of receipts over expenses for the fiscal year 2023 compared to the previous fiscal year. I am also glad to report that the same period, our members have increased by 23%. These modest growths can be attributed to more evident prudence in fund utilization, extra aggressive information campaigns for our products, and closer involvement by the BOT in the concerns of the company. However, we must remain vigilant in managing our expenses and expanding further our efforts at seeking out potential members of the organization to ensure the sustainability of these gains. Based on what is reported by the Association's actuary and external evaluator, our financial position is healthy, providing us with a stronger footing for future endeavors.

Strategic Initiatives:

Throughout the period, we have embarked on key strategic initiatives to enhance our impact and reach. This must be given priority because it appears that we have yet to access the core of our target audience: graduates of the PNPA. Although this pursuit seemed to a lesser extent doable and replete with challenges for a startup organization such as ours, I am optimistic that we could effectively achieve this singular target.

Other initiatives include the amendment of our product line to complement the calls of the times. The initial focus of this effort is two-pronged: (1) reduce the monthly contribution for new members with decreased coverage, or (2) craft products with multiple monthly contributions/coverage that would suit the choice of a member. This will be an effective response to the impending legislated restructuring of the pay scale and retirement funding scheme of public safety workers, otherwise known as the MUP Law.

Governance and Compliance:

Our commitment to good governance and compliance remains unwavering. We have strengthened our governance practices by streamlining and solidifying the duties and responsibilities of the Audit Committee and by creating and instituting a charter for the Corporate Governance Committee. Compliance with regulatory requirements and best practices is a top priority for our organization. Through BOT resolutions, we revised and updated our corporate manual and governance policies to keep them attuned to our organizational thrusts and programs. With these efforts, we will show that we uphold the highest standards of governance.

Outlook for the Future:

Looking ahead, we are committed to continuing our journey of growth, innovation, and impact. Our strategic priorities for the upcoming year include forging a partnership with the leadership of the PNPA Alumni Association, Inc. to help us convince all alumni to become members of the Lakan MBAI. A positive endorsement by our alumni organization would provide a fresher perspective and venue to explain the beauty and rewards of participating in our innovative approach to providing security to families and dependents of 'PNPAyers'. Through this, we hope they could come to appreciate even better the uniqueness of our products compared to other insurance schemes available to public safety servants.

In conclusion, I urge you to stay true to our mission and vision, embrace change, and foster collaboration, so that we can confidently navigate the challenges ahead and emerge stronger than ever.



On behalf of the Board of Trustees of Lakan MBAI, I am pleased to present to you, on the occasion the 8th Annual General Membership Meeting (AGMM), a report on the modest accomplishments, activities and updates of our Association for CY 2023 and 2024 before this year's assembly. To wit:

I. OPERATIONS

A. Membership

As of June 2024, the association's membership has a total of One Thousand Five Hundred Sixty-Two (1,562) with the majority of it coming from the cadets at eight hundred eighty (880) followed by the active personnel at five hundred nineteen (519), from the retired officers at one hundred seventeen (117) and from our associate members at forty-six (46).

B. Accreditation

In order to achieve efficient collection of membership contributions, we closely coordinated with partner institutions and to facilitate the remittance of member payments.

C. Approval of Application for Basic Life Insurance Plan (BLIP) from the Insurance Commission

The Association's application for the Basic Life Insurance Plan with the Insurance Commission has been finally approved on December 15, 2023. The product secured the accreditation of the Lakan MBAI to provide the life insurance coverage to its members.

D. Health Maintenance Organization

In partnership with the IMS Wellth Care, Inc. (IWC), we have six hundred five (605) members who are enjoying benefits of in-patient care, complex diagnostic procedures, professional fees, medicine and other medical management routine.

Out of six hundred five (605) Lakan MBAI members of the Health Management Organization (HMO) hosted by Lakan MBAI, one hundred forty-two (142) were able to enjoy medical/health benefit for medical consultations, laboratory services and other out-patient health cares.

E. Claims and Benefits

Lakan MBAI provides its members with benefits including Basic Life Insurance, Hospital Reimbursement, and Equity Savings. Over the years, Lakan MBAI has consistently fulfilled its commitment by disbursing the entitled benefits to its members.

From July 2023 up to June 2024, the beneficiaries of three (3) members of Lakan MBAI, received death benefit claims ranging from One Million Pesos (\$\frac{1}{2}\$,000,000.00) for natural death and Two Million Pesos (\$\frac{1}{2}\$,000,000.00) for accidental death.

II. ADMINISTRATION

A. Personnel Management

1. Personnel Hiring and Orientation Training

A General Manager transitioned to a regular employee role on September 16, 2023, while the Bookkeeper Contractual staff became a regular employee on April 12, 2024. Additionally, a new Administrative Staff commenced contractual employment on April 3, 2024, with a six-month on-the-job training.

2. Remunerations and Other Allowance

A Total of One Million Six Hundred Fourteen Thousand Three Hundred Fifty-Two Pesos (\$\mathbb{P}\$1,614,352.00) was disbursed for salaries, bonuses, and 13th-month pay of staff and officers. Consultancy fees amounting to Seven Hundred Twenty-Six Thousand Five Hundred Twenty-Six Pesos (\$\mathbb{P}\$726,526.00) were paid to consultants for actuarial services, external auditing requirements, accountancy, and bookkeeping functions. Monthly travel allowances during regular monthly meetings for the Members of the Board of Trustees totaled Two Hundred Sixty-Three Thousand Five Hundred Pesos (\$\mathbb{P}\$263,500.00)

3. Morale and Welfare

For the period, a total of thirteen (13) leaves of absence was granted to Lakan MBAI personnel. As support to the staff, a total of Two Hundred Ninety-Four Thousand Two Hundred Forty-Five Pesos ($\frac{1}{2}$ 294,245.00) daily meal and transportation allowance were given. Likewise, a total of Fifty-Four Thousand Nine Hundred Seventy-Two Pesos ($\frac{1}{2}$ 54,972.00) in travel expenses were provided to engagements and other similar activities.

B. Maintenance and Operating Expenses

A total of Three Hundred Twenty-Nine Thousand Eight Hundred Thirty-Seven Pesos (\$\pmu329,837.00)\$ was utilized to support expenses incurred in the procurement of meal, snacks, and similar expenses relative to the conduct of meetings and conferences. This includes total provision for the yearly Annual General Membership Meeting (AGMM). Likewise, One Hundred Forty-Nine Thousand Nine Hundred Twenty-Four Pesos (\$\pmu149,924.00)\$ was spent for payment of utilities (water, electricity, telephone line, internet, office cellphone, zoom subscription, google drive) and Fifty-Two Thousand Seven Hundred Fifty-Four Pesos (\$\pmu52,754.00)\$ were spent for supplies and goods for the office.


