-Why not do an actual vote in person? Since we are inviting them to the in person meeting, better to welcome them than vote about them.

## Meeting agenda for Saturday:

- -Welcome new members (assume vote goes well)
- -\$\$ update
- -Outlook on construction
- -Discuss an updated member's dues (now that we have insurance input) Sue to provide a draft budget, divide by 80 members
- -NOT a vote, only a discussion (propose a starting point, discuss if too high or too low, etc.)
  - -Come back in December vote over zoom
  - -Send agenda in advance budget, update, may get more people
- -Also reminder to point out that the \$120k got us the contract, not the full budget to complete construction.
  - -At the meeting, ask if anyone is interested in the role of Social Director!

# **Construction Updates:**

- -operator platform too complicated, simplify
- -Campground folks suggested drop the 25k cost for the spring cleanup / etc. get in equipment, they can help do it, now 5k (maybe)

## **Donation Updates:**

- -Netscout \$2500 towards a work day, if employees come and do it
- -On reserve for the gambling money (2025) assigned a week at a casino, % of the revenue comes to you as a check no idea on how much. 3-5k (typically)

# Other topics discussed:

- -Budgeting Sue has been baking in memberships into donations (ie. If I gave \$1000, she'd count \$40 to membership dues)
  - -Pickle Festival ordering hats / bags, Ashley doing raffle, etc.
  - Social Director Need to recruit for this position. Welcome package for new members!
- -Organizations that donated, get their logos on the website: Aubuchon, Campground, Bob's Fuel, Netscout, AllianceBernstein, Microsoft.
- -Benevity fundraising portal, allows people with matching funds to go through them to do it (collecting and fees and everything); Sue investigating.

Dear FLIA members,
