- ~Solid Waste/Recycling Attendant pay. He has asked for a raise. Currently at \$15/hr. Tracy has reached out to other townships to see what they are paying for reference. Board agreed to raise our pay up to \$17/hr. beginning with the July paycheck.
- ~Ridgeview Estates update: Brody had talked w/Fortney and work is currently getting done. The Clarks are responsible to pay Fortney. Once we know Fortney has been paid and we have received the other paperwork (no liens etc.) we'll continue the process to obtain the road as Township roads.
- ~Patrolman Update: Graveling is done. Now just been grading where needed. Sealcoat holding up ok. Bleeding through in some spots but said should be ok. Will keep sanding in the hot weather where needed.
