Simpsons has one to rent, \$125/hr Board asked what cost would be if we "hired" Crawford. Approx a good weeks work. Brody will call both and ask what they would charge vs renting and let Berent know.

Stop sign on Finely Road is needing replaced. Brody will let the County know as that would be county highway issue.

- N. Brookville Rd culverts need some cleaning up so they flow better. Brody will check it out. Will need to do some ditching as well.
- ~Hannah had a resident ask about property lines and who they would need to talk to to determine ownership lines etc: They will need to contact a land surveyor for that work. She will let the resident know.
- ~Tracy has a \$50 rebate debit card the Township received from Cenex. What do you want done with it? Board agreed to go ahead and put it towards a utility billing, so Tracy will apply it to VernonCom as it will cover for all of Nov and then a partial Dec.
