## Compliance with the Protection of Personal Information Act, 2013

This communication is sent to you by Lilibara Projects (Pty) Ltd. The Protection of Personal Information Act 4 of 2013 ("POPIA") came into operation on the  $1^{st}$  of July 2021 and significantly changes the current data protection regime in the Republic of South Africa. Amongst other things, POPIA requires us to comply with certain requirements when we process your personal information as defined in POPIA.

Personal information under POPIA is defined to also include the personal information of identifiable, existing juristic people and it requires us to provide certain information regarding how Lilibara will deal with the personal information that you give to us, our affiliates, or agents, or that we otherwise obtain.
