Thank you for choosing Merchant Camps and Lodge located in Garfield PLT., Maine. Enclosed is a list of what to bring as well as forms to fill out and bring with you. We look forward to meeting all of you!

What Clothes to bring (Bear Hunt):

- Full Camo Short sleeve and long sleeve, light jacket or pullover, for warm days and cool evenings
- Head net with eye slots & bug net
- Lightweight gloves
- Rubber Boots
- Scent free soaps and scent free detergent (All clothes should be washed in scent free wash or baking soda and placed in plastic bags before arrival)
- Scent Lock is optional but is great option
- Clothes for when not hunting
- Fishing Equipment (if you wish to fish, license is required)

What Gear to bring (Bear Hunt):

- Medications (if you take any)
- Spare Glasses
- Weapon of Choice
- Spare Ammo, Arrows or Bolts
- Seat cushion of quiet material
- EMERGENCY PACK 2 compasses, Flashlight, Knife, Whistle or noise making device, Mirror, Lighter or matches & Fire Starter
- Plastic bottle or container as portable potty to use in stand
- Headlamp & Rain Gear

You may ruin your chances of seeing a bear as well as those that you ride with. You may smoke outside only; all buildings are smoke-free. Please smoke a distance away from all open windows.
