

# **SUNSET MEADOWS BOARD MEETING MINUTES**

## **Thursday, June 16, 2022**

**Present:** Marilyn O'Malley, Mel Huey, Lisa Armstrong, Sandi Patton, Jane Hackett

Special Guests: Rebekah and Jill attended to observe the meeting and Rebekah is considering joining the board.

### **Call to order at 6:37 PM**

### **Approval of the Minutes**

Approval of May 19, 2022 minutes, moved by Jane seconded by Sandi.

### **Treasurer's Report- Mel**

Net income for May was \$15,000. Bottom Line had not received the utility or Visa bills for May. They are expected to be included in the June financial report. The May report was moved to be accepted by Jane and seconded by Sandi and approved by the board.

Delinquency Report: we have 26 owners delinquent on monthly fee. Due to Mel not receiving the financial report until an hour before the meeting, details of the delinquency were not submitted. This will be completed and reviews by board via email.

### **Maintenance – Mel**

- Lane County Forest Products, delivered 5 yards of planting mix and 5 yards of hemlock bark to back of middle cul-de-sac. Bark is being used up fast. There is still soil available.
- Replanted lawn behind 1444, had its first mowing. The replanted area behind 1634 to 1638 is growing but no mowing yet.
- Jeff Broc of Oregon Electric was here on May 17th with locator equipment attempting to locate short circuits in irrigation controllers in front of 1448 and 1488. Jeff wants to reroute underground lines along maintenance shed then reconnect to wires 15 feet from shed. We saved a \$125.00 fee by hiring a temp worker to dig ditch. At the same time the lights along north driveway went out. Oregon Electric sent out 2 electricians without location equipment. They did a small amount of work but were unsuccessful. Jeff with locator equipment is scheduled to come back on June 21st. If he is unable to make repairs we will have a problem with irrigation. We have 2 other irrigation controllers that are working. These 2 control 24 of our 33 zone irrigation zones. We still have nozzle repairs and a few other issues to deal with. In the end Graham Landscaping can be called end to make more difficult repairs.
- Rexius irrigation was called in by EWEB to perform back flow test on our irrigation lines. This is a required test by EWEB.
- Partially drained down pool 3 times to prepare for opening.
- Jeff Plummer should be here this month to continue work on gutter drainage problems. This is an ongoing issue.
- Northwest Siding will be here on August 2nd to begin siding work.
- Jeff Jeppe, will be contacted to work on repairing a broken fence post in front of 1632 and a storage shed in front of 1570.

## **Compliance – Jane Hackett**

- Jane reported there were 5 compliance notices were issued this month. 3 were resolved. 2 are a work in progress. It was also decided to continue with the use of cell phone for reporting issues and promoting it use more.

## **Landscape – Jane**

- Wolf Pack came in and worked a number of trees for us. They did a good job removing dangerous decayed and dead limbs. This included removing limbs over hanging gutters or laying on roofs. We removed 1 large arborvitae that was half dead and cut 4 more down to a reasonable height. We also removed a large branch back to fence line that was growing through the arborvitae. Our new lawn company is beginning to catch up on pruning and edging. We will be working with a nontoxic weed killer to help reduce weeds growing along driveways and sidewalks when it stops raining.
