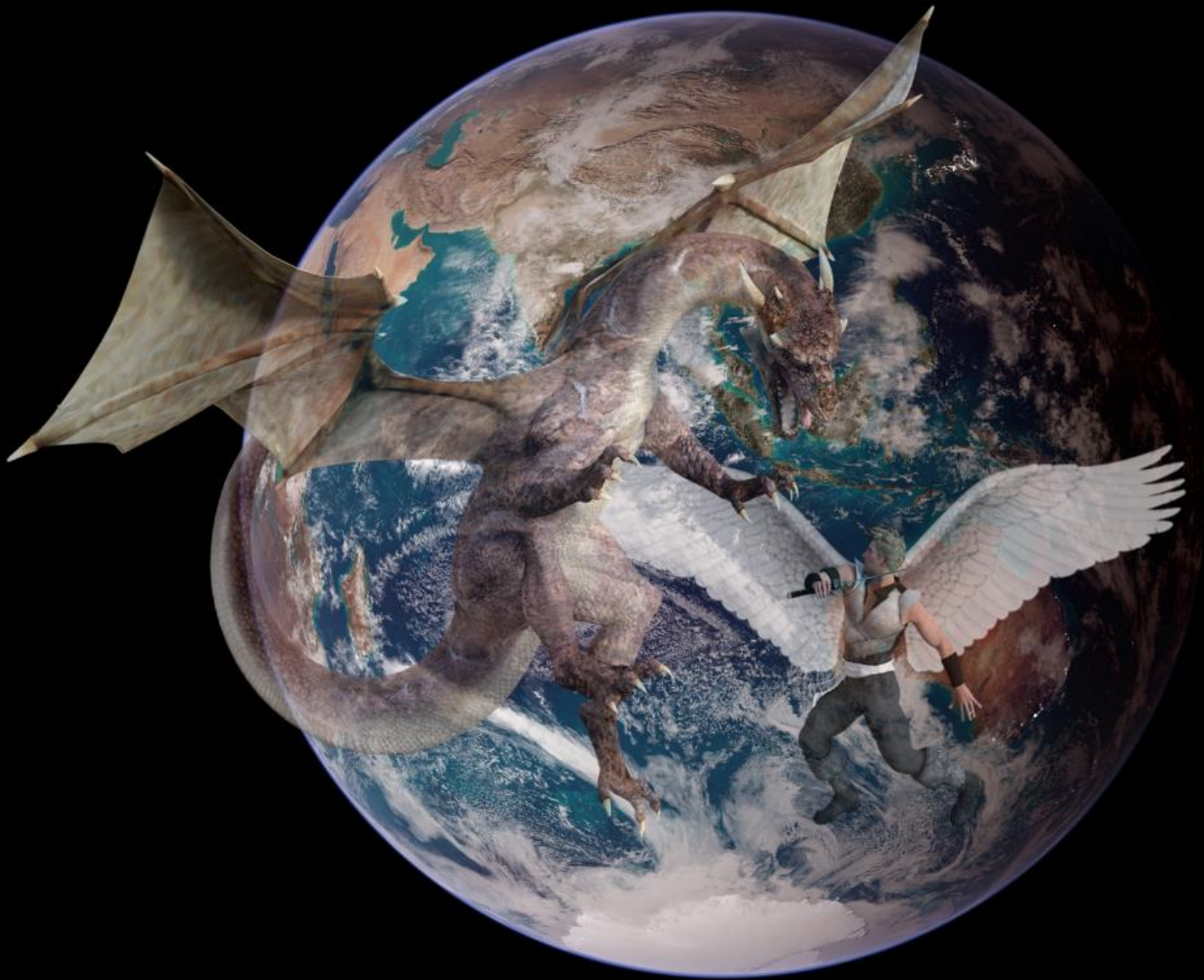


CHRISTIANITY: DO YOU REALLY KNOW WHAT YOU BELIEVE?

1. **ANGELOLOGY, DOCTRINE OF**—The doctrine of angelology says that angels were created, immortal, and their numbers were limited. The creation of heavenly angels by Jesus Christ have them doing God’s bidding by acting as protectors and messengers (ministers) to those who are saved and to those who will be saved (Ps. 104:4; Heb. 1:14). The false teaching of ‘free-will’ did not originate with men, but with angels who fell (I Tim. 5:21). The election of men, as well as angels, cancels the idea of a will free to choose. The exact opposite is true for those who embrace ‘free-will’—those who believe they can decide what is right and wrong when their conscience has told them otherwise, will never get to heaven. This behavior is called playing God or pride. There are good angels and bad angels. A third of them rebelled against their Creator, Jesus Christ, and joined Satan, the great red dragon, in his rebellion.¹ Fallen angels are subject to Christ and serve the purpose of deceiving those who hold the truth in unrighteousness. Demons, devils, or “angels which kept not their first estate,” inhabit the air (Eph. 2:2), and the abode of hell where they are held in chains of darkness unto the judgment of the great day (Jude 6). Angels are always masculine in form and appearance when physically manifested, never feminine in apparition or behavior (Matt. 22:30; Mark 12:25—A woman is given in marriage by her father. Because these verses say the angels are not given in marriage, it is the literary equivalent of saying there are no female angels). Heavenly angels are clothed when they have appeared in scripture. Today, aliens, extra-terrestrial biological entities (E.B.E.’s) are actually demons allowed to materialize in order to deceive the unsuspecting and unbelieving. These are the sexless, naked beings who have been haunting unbelievers for years.
2. **BAPTISMS, DOCTRINE OF**—Baptism by the Holy Spirit is requisite for salvation, while water baptism has been used by men to control others in the various religious settings of works. John’s baptism was one of repentance—making the individual receptive to the truth of Jesus’ message. It could not save the individual. The water baptism John the Baptist performed, was one of immersion not dipping or sprinkling. Immersion pictured the death of the old man and the resurrection of the new. There is NO ordinance of water baptism required for the true church of Jesus Christ. It is used as a means of manipulation, control, church membership, and even salvation. It waned and disappeared in Acts as the apostolic church was spreading and growing. Anyone telling you that you must be baptized in water has been conditioned by their church to say so. Jesus says ‘NO.’
3. **CHRIST’S ATONEMENT, DOCTRINE OF**—This doctrine says that only through the blood of Christ can the sins of mankind be placated or satisfied, and forgiveness granted. The blood of bulls and goats could never atone for the sins of men. Jesus’ atonement covers past, present, and future sins.

¹ A story within itself from Revelation 12:3, 4, the drawing of the third part of the stars of heaven and casting them to the earth by the great red dragon’s tail had a sinister purpose. That purpose was to destroy the woman’s child as soon as it was born. Of course, Satan failed . . . As he always does. It’s very important to note the context of time here. The third part of the angelic host that had gone bad did NOT occur **UNTIL** Jesus was born. And the conflict between Michael and his angels and the dragon and his angels, likewise, has not happened yet. This war in heaven will occur during the 3.5 years **yet to come**.

4. **CHRISTOLOGY, DOCTRINE OF**—While this can be an exhaustive and lengthy topic, I will make it as brief as I know.
- **virgin birth**—This doctrine, essential to God’s requirement of a perfect sacrifice, says two important truths. First, Jesus’ conception was performed by the Holy Spirit. Jesus was begotten of the Father. Mary was overshadowed by the power from on high. Jesus had 23 chromosomes, not the normal 46. Secondly, Jesus’ development within Mary’s womb was also miraculous. He was not connected to his mother by an umbilical cord. Ever wonder why Jesus never addressed his mother AS MOTHER. This is why! Jesus’ birth was the only normal event that characterized a life that was anything but normal.
 - **Jesus’ death**—Unlike what happens to all human beings after they have died, namely decomposition and corruption, this was not the case for the Savior. For three days and three nights, while his body lay in Joseph of Arimathea’s sepulchre, disintegration and decay of the Messiah’s body never occurred. And for the record, the lance thrust into Jesus’ side in order to determine whether he was dead or not, was done so to prove his death—blood and water came forth from his side. Old Testament Messianic prophecies were fulfilled regarding the piercing of his hands and feet (Ps. 22:16), as well as none of his bones being broken (Ps. 34:20).
 - **Jesus’ burial**—Joseph of Arimathea secured the body of Jesus from Pilate. With the Jews pressuring the Roman governor, chances are Pilate would have never released the body to Joseph if Pilate had known Joseph was a Christian and disciple of Jesus. Because Joseph did not go around publicly with a Jesus’ bullseye on his back, and virtually everyone in the upper class were not aware of Joseph’s conversion, his non-public disclosure allowed Joseph to acquire Jesus’ body for the security of all posterity. Can you imagine what would have happened to Jesus’ body, with the rumor and innuendo, if the religious Jews had gotten hold of Jesus’ corpse? These turn of events that scripture records, are truly a testament to God’s sovereignty and protection amidst the hatred of the religious Jews toward the Carpenter from Galilee.
 - **Jesus’ resurrection**—The single most important event in history, and as the first begotten from the dead, Jesus and his resurrection assures all his followers that victory over death is a reality—not only in this life, but in the one to come as well. The resurrection says the deceased body of the saint will one day be re-united with the soul and spirit. This event will occur when a phenomenon known as the first resurrection happens. There are **three periods** of time that all fall under the umbrella of the first resurrection. They are:
 - i. **The resurrection of the just and the rapture of the church**—These two events are indivisible. Prior to the seven trumpet and seven vial judgments, right on the heels of the sixth seal being opened, the resurrection of the just and the rapture of the church occurs (Matt. 24:31; Mark 13:27; Luke 21:28). This event happens as Jesus, descending from heaven with a shout, with the voice of the archangel, and with the trump of God, appears in the clouds for his own, taking the deceased first and then those which are alive and remain to be caught up with the Lord forever (I Thess. 4:13-18).

- ii. **The death of the saints during the 3.5 years or last half of Daniel's 70TH week**—All those who die during this period are also included in this resurrection of everlasting life (Dan. 12:2; Rev. 20:4). For the damned, their resurrection occurs at the end of Jesus' millennial reign, at the Great White Throne Judgment—a resurrection of shame and everlasting contempt (Dan. 12:2).
 - iii. **Those who die during the millennium**—Yes, those who die here as well, are also considered part of the first resurrection (Rev. 20:5)
 - **Jesus' hypostatic union**—Says that Jesus is fully God and fully man. It is the tenet that two natures, divinity and humanity, reside in one person, Jesus the Christ. The incarnation states that Jesus was the only one that could atone for man's sins.
 - **Jesus' Second Coming**—This event occurs at the end of the 3.5 years, which includes seven trumpet and seven vial or plague judgments. The 3.5 years is when the beast is permitted to rule. The beast is nothing more than an extension of the Vatican and its totalitarian lust and aggression to control the world. Jesus' rod of iron rule is not a spiritual one as taught by the enemies of the Cross.² Contrary to these deluded individuals Jesus' Second Coming IS a real, actual, temporal, physical, literal reign of the Messiah from Jerusalem for 1,000 years.
 - **Jesus' Great White Throne Judgment**—The resurrection of the damned occurs at the end of the millennial reign of Christ. Re-united with their body, the damned will be moved in a massive transfer from hell to the lake of fire. Though eternally condemned, judgment will be meted out accordingly—as their work's accord. While it is universally understood the wicked are here, many 'good' people will find themselves here as well—'for by the works of the law shall no flesh be justified.'
 - **Jesus' existence before his incarnation**—The Bible is clear on this subject—"Before Abraham was, I am." (John 8:58) And many other Old Testament references also corroborate Christ's assertion from above (See Genesis 1:1—a uni-plural noun, implying three in one; Genesis 1:3—Jesus as the light of the world, **literally**; Genesis 1:26—our image, our likeness; Dan. 3:25—the form of the fourth is like the Son of God—how would Nebuchadnezzar have known and seen this?)
5. **CHURCH, DOCTRINE OF**—This doctrine dramatically changed when the apostolic church age ended in approximately 100 A.D., with the death of John. All authority Jesus had given his apostles ended upon completion of the scriptures. At that point the completed, inerrant scriptures became the believer's supreme authority. The clerical offices with their power, influence, and notoriety, enumerated in Paul's letters, came to an end when "that which is perfect" came. (I Cor. 13:10). With the Holy Spirit as the believer's teacher and the completed word of God accomplished, the biggest obstacle now to freedom for the believer

² These people come to scripture with the attitude that God's intent is not to communicate with us. They impose themselves on the unsuspecting, unlearned, and naïve and shipwreck whomever they can. These are the ones who have a private interpretation of the Bible, not comparing scripture with scripture (II Peter 1:20, 21). They perform eisegesis, namely they twist scripture to make it say something God never intended. Their approach to scripture is non-literal, spiritual, and idealistic. Indeed, these are like those mentioned in II Timothy 3:7, 8—Ever learning, and never able to come to the knowledge of the truth. 8 Now as Jannes and Jambres withstood Moses, so do these also resist the truth: men of corrupt minds, reprobate concerning the faith.

was access to God's word in one's language. It was now imperative the Bible, coming from *Antioch, Syria*,³ be translated into other languages. After that, it also became apparent that access to the Bible be made readily available through the invention of the printing press, as well as through cost-effective distribution and acquisition. The Bible is not opposed to the gathering of like-minded believers. Their unity; however, must be in Christ and his inerrant word (the K.J.V.). In a book that is clearly prophetic, Revelation points out that certain churches in certain localities, were recognized by Christ as overcomers, specifically the assemblies in Smyrna and Philadelphia. The other five churches were actually not one single church in a specific location, but consisted of several smaller assemblies in a region known as Ephesus, Pergamos, Thyatira, Sardis, and Laodicea. This is why Jesus challenges those who have not been infected by false teaching, within these churches, to overcome. If this had been one assembly, they could not have overcome. They would have been guilty by association, like an accomplice in a murder. These were clearly untainted assemblies, in regions mentioned, that had not been infected with the leaven of works evident through their false teachers and leaders.

6. **COMMUNION, ORDINANCE OF**—Communion is a memorial where the believer observes, in memory, the body and blood of the Lord Jesus Christ in the elements of the bread and grape juice. *Transubstantiation* is the Catholic observance that the elements actually become the body and blood of Jesus. This is blasphemous. *Con-substantiation* is the belief that Jesus is with (con) the elements as the believer partakes of them. This, too, is blasphemous and totally unscriptural. Con-substantiation is a belief and practice held by various Lutheran denominations.
7. **CREATIONISM, DOCTRINE OF**—Yes, six literal, twenty-four-hour days of creation revealing the infinite complexity, diversity and wisdom of Jesus NOT eons of time plus chance. If you want to see the ugliness of evolution just look at collectivism, religion and all the other isms that have plunged men into darkness, despair and hopelessness. For evolution, since man is no different than the animals, namely without a moral conscience, then it could be said that everything despicable within the human condition is predicated (built) on evolution.
8. **DISPENSATIONALISM, DOCTRINE OF**—God has spoken to men throughout history in different ways. God speaks to us today through his completed, inspired, inerrant word (K.J.V.). Get this believer, the apostolic church age has ended! It was a unique period of church history and can never be recovered or duplicated. Certain clerical offices and spiritual gifts have ceased because of the completion and authority of the inerrant scriptures (I Cor. 13:9, 10). A refusal to acknowledge this has led to numerous doctrinal perversions within Protestant churches, for example glossolalia (gibberish passed off as tongues) and bewitching.
9. **DOMINION MANDATE, DOCTRINE OF**—Given to Adam and Eve, its context is within the confines of marriage and provides for the procreation of the human race (not bastard children or those conceived out of wedlock). God's command to Adam and Eve to be **fruitful**

³ There are two streams of Bible manuscripts. Many from Alexandria, Egypt, one from Antioch, Syria. The many manuscripts from Egypt are polluted. The one from Antioch, Syria, where they were called Christians first, is the pure stream which produced numerous accurate copies from the original apostolic autographs.

was a reference to receiving God's blessing in the couple's mindset to live and share the gospel. To **multiply** carries with it the idea of procreation within marriage—this is the primary reason a man and woman get married—to become one in body, soul, and spirit. **Replenish** is the idea of stewardship or care, management, and concern over of all that God has entrusted to man on this planet. **Subdue** is man's adaptive behavior, augmented through God's inspiration, to any earthly environment in order for men to live, thrive and prosper. The careful planning of any human endeavor that affects man's expanse into his environment is embraced by God.

10. **ELECTION, DOCTRINE OF** —This doctrine has nothing to do with God's foreknowledge and who is to acknowledge Christ and who will not. God's foreknowledge does not produce election. Election means man has nothing to do with his justification in the sight of God. Does the candidate have control over who elects him/her? . . .Unless they have access to Dominion or Smartmatic voting machines. Man can neither alter his condemned sentence before his Creator, nor initiate or maintain his pardoned position before Providence. Until the individual understands this, he will **never** come to the knowledge of the truth.
11. **ETERNAL SECURITY, DOCTRINE OF**—Says that because redemption is all of God, the believer's eternal position and security is assured. A redemptive paradigm that teaches works **will never** produce eternal security. By the way, works are produced in the believer by the Holy Spirit NOT by the efforts and determination of fallen men. Jesus said, 'ye shall know them by their works.' Do these works spring from Christ's presence within OR from personal effort and grit?
12. **EXCLUSIONARY REDEMPTION, DOCTRINE OF**—While in I John 2:2 we are told that Jesus' propitiation was extended to not only believers, but also for the sins of the whole world, this is not equivalent to saying all people are saved. Propitiation means Jesus' crucifixion satisfied the Father's requirement of a perfect/sinless sacrifice. Jesus' blood sacrifice supersedes any animal sacrifice in its capacity to cover sin. Jesus' atonement was not momentary and limited. It was infinite knowing no bounds from the past, and extending far into the future. (See also Matt. 7:13, Matt. 9:13; 14; Matt.13:10-15; Matt. 20:16; Matt. 22:14; Luke 15:7)
13. **FAITH, DOCTRINE OF**—Faith, we learn from the Bible, is a gift. It is given to a believer. It cannot be bought, earned, or learned. It is a gift of the Holy Spirit's presence as he indwells the believer. Faith can be increased by reading and hearing the inerrant scriptures. Belief must be mixed with faith IF the individual is to be saved.
14. **FALSE TEACHERS, DOCTRINE OF**—While never being seen for the wickedness God says it is, America's secular 'tolerance' for the creeds of many non-Christian faiths will ultimately be America's undoing. The teaching from Deuteronomy 13 is clear. It is a capital offense, punishable by death to engage in false teaching, enticing people away from the God of the scriptures. This is an eternal war for the priceless souls of men. If you think I'm extreme, then call God extreme. This capital offense for false teachers will be enforced during Jesus' millennial reign when he rules with a rod of iron. There will be no open and public displays of antichristian rebellion. It will be exposed immediately and dealt with swiftly and justly.
15. **FORGIVENESS, DOCTRINE OF** —Facing an epidemic of unforgiveness within the church, fueled by 'Christian' psychology, many people are condemning themselves to a Christless

eternity. Jesus has some very serious words about those unwilling to forgive. The core of the Christian religion, forgiveness, says that each sinner has amassed a debt of sin so great that re-payment of said debt is impossible. Only Christ can pay the ransom. If you do not forgive others, neither will your heavenly Father forgive you. Forgiveness IS NOT an option, but a command!!!

16. **FORMAL EXEGESIS, DOCTRINE OF**—No thought for thought equivalency without word for word parity (equivalency). Remember “The Way?” This was a 70’s paraphrase ‘bible.’ How about the gender neutral ‘bible?’ You get the idea. Pretty disgusting and pathetic.

As Dr. David Otis Fuller has said in his masterpiece, “Which Bible?”, “Devotion to error, can never produce true righteousness.”

17. **GENDER, DOCTRINE OF**—There has been a move for many years to erase the distinctions between men and women. The idea is to create a uni-sex or sexless individual. This is another sinister perversion by the American Left and Feminism to attack God and his purposes behind the sexes.

18. **HEAVEN, DOCTRINE OF**—This fundamental teaching says those who end up here do so not by any merit or innate quality they possess. Heaven is not a pursuit involving man’s will, for man’s redemption lay outside and beyond himself. Redemption, mentioned as having its origin before the foundations of the world, is realized by election. It is man’s only hope of escape hell. God sees ALL men as equally condemned in his sight. It is only by his grace any are saved. It is the blood of Christ that paid the ransom for man’s soul. It is only by the Holy Spirit man’s soul is delivered from hell—it is called the death of the natural man or crucifixion of self. Only when we die, can we hope to live in Christ.

19. **HELL, DOCTRINE OF**—This doctrine reveals much about God’s attributes of righteousness, justice, holiness and glory and his capacity to punish sin and sinners in an objective and hallowed fashion. As a philosophical construct, the Bible in general, and Christianity in particular, mention and address hell as a spiritual abode of the damned, as well as a literal, physical reality existing in the bowels of the earth. Whether they be volcanoes, the Mid-Atlantic Ridge, marine subduction zones, thermal pools, geysers, perpetual ‘natural gas’ vents, etc. all speak of an inner terrestrial core that is violent, convulsive, perpetually dynamic, unbelievably hot, and incredibly tormenting to those souls encountering pressures unlike anything fathomable. Whether it be the many perversions of a place called hell offered up by numerous sectarian or denominational assemblies, religion itself, or counterfeit ‘bibles,’ hell’s severity, finality, and reality pales in comparison to the Bible’s description of such a matter-of-fact location. Hell is real. No amount of wishing, denial, academia, theology, or ‘science falsely so called,’ will ever make it disappear. If you choose not to believe it, you cannot prove it doesn’t exist. Your reality will come to terms with your humanity when succumbing to death, you learn that every attempt at discounting such a reality is no longer fantasy. Hell is real. Its punishment is everlasting. Hell is inescapable. Hell is the epitome of totalitarian mob rule and the debased, evolutionary mindset of those in servitude to self (religion). Many bad people will be there. That is to be expected. What will be shocking; however, is how many ‘decent’ and ‘good’ people will be there.

20. **IMPUTATION, DOCTRINE OF**—This teaching says that the blood of Christ with its forgiving and healing power is only granted to the elect through an event known as **baptism by the**

Holy Spirit. To impute, a legal term, means to credit the sinner's account with a righteousness they can never hope to earn, attain, and maintain. A transference of Jesus' righteousness to the sinner, imputation assures the Father that his Son's efforts from the cross were perfectly fulfilled and just.

21. **INDIVIDUALISM VS. COLLECTIVISM, DOCTRINE OF**—While perhaps many have never heard of this doctrine, its precepts are clearly evident in scripture. Religion, starting with Nimrod as its founder, is collectivist in nature, structure, and implementation. Religion is the elevation of man to divine status or the belief that men can become God. This is the purest, yet most sinister monolithic movement known to man. It is made possible by the most subtle and incremental brainwashing techniques imaginable⁴—the quintessential example of totalitarian mind control, manipulation, and re-education.
22. **INERRANCY, DOCTRINE OF**—This is really an issue of authority. Will you believe in God or men? Will you choose prison or live a life of freedom—liberate your mind to the words of Jesus and his Holy Spirit? Relying on your ignorance, stupidity, or both, pastors and their *statements of faith* talking about faithfulness to original autographs or manuscripts is simply a front. There are none of these originals in existence. This is just a religious/theological run-around to say they don't believe in scripture at all, AND that all 'bibles' are equally in error. This should reveal to any believer how small God is to these pastors.
23. **JUBILE ECONOMICS, PRECEPT OF**—The basic understanding of what is money with its unlawful exchange simplifies a field in which the more complex you sound, the better you are at bamboozling people. Real money is gold and silver, preferably coin. In our country the value of money is established and regulated by the U.S. Treasury . . . At least it is supposed to be. In the Bible, the value of money was established, regulated and monitored by the priesthood. There is no value in worthless paper Federal Reserve Notes. The jubile comes into the discussion as it occurred every forty-nine years. It was actually celebrated on the fiftieth year. This meant a bondman had the opportunity to be freed. It also meant a debt of any kind was forgiven, pardoned or erased. It eliminated the idea of perpetual servitude or indebtedness. It is also from the jubile, that a standard was set for the individual calculation by businesses of what they could charge for a profit. The longer you were from the jubile, the more profit you could charge, the closer you were, the less you could charge—a limit was established. Unlawful weights and measures were seen as stealing, a subtle and incremental form of embezzlement or malfeasance. Then there was the topic of usury, or interest on loans, that can be seen as something lenders (banks) have gotten more creatively adept at as time has progressed.

⁴ Pure and simple this is called bewitching (Acts 8:9). It seeks the cult of personality. It exalts that person to a level of uncharacteristic worship, adoration, and veneration. It also involves casting down the truth and substituting it with a lie. Then it promotes a lie unceasingly. This lie eventually becomes the 'truth.' The primary emotions and behaviors these leaders employ are fear, guilt, sensitivity training/group dynamics (the power of the group against the individual), manipulation, deceit, and communal property sharing/equal pay for unequal effort (unionism or redistribution of wealth). By doing so, they can get their disciples to do anything. Crushing the individual's spirit and identity, the group is always elevated at the expense the individual. This produces consequences at a horrible price; personal responsibility is extinguished, while vice and corruption become the norm.

24. **MAN, DOCTRINE OF**—The biblical doctrine of man says all men are condemned and going to hell. It also says man has inherited the sin of Adam, innately and biologically. Man is incapable of redeeming himself. There is no mention of justification for the ungodly through man's 'free-will.' A man in bondage and captivity is not free to choose. To acknowledge the truth is what is required of the individual. We don't get to choose what is true, we must simply assent to the truth's existence—self-evident, axiomatic, universal. "The heavens declare the glory of God; and the firmament showeth his handywork." (Ps. 19:1)
25. **MAN'S MAKE-UP, DOCTRINE OF**—Says man consists of spirit, soul, and body. These components are indivisible during life, but divisible at death. Man's spirit is his moral conscience. Everyone has one. It tells the individual right and wrong. It is re-enforced by parents, siblings, community, personal life experiences, and the Bible. One's moral conscience is unavoidable unless the individual becomes so hardened to that still small voice, they become perverse in their thinking. The spirit of man is also called the candle of the LORD (Prov. 20:27) searching all the inward parts of the belly. Man's soul consists of his mind, will, and emotions. The mind reflects the personality of the individual. It is where reason and understanding occur. The will is the drive, engine, or motivation of personality. The emotional component of man ebbs and flows. Not a sure foundation on which to make rational decisions, emotions should not become the primary impetus of personality—objective truth should. At death, the spirit of man returns to God who gives it. The soul stands before Jesus Christ to receive judgment. To the elect, this judgment is reception of crowns or no crowns and behavioral reproof, for thoughts and actions, outside the control of the Spirit. For the damned it is the second death—an eternal sentence in hell. For the body of the deceased saved, it is a separation of the soul and spirit. Upon the resurrection, all three re-unite, spirit and soul with body. For the raptured, the living will be changed, in the moment, in the twinkling of an eye. Corruption will put on incorruption. For the damned, they will face an eternal judgment in hell. Their resurrection will occur at the Great White Throne Judgment, at the end of Jesus' physical, literal, millennial reign. During the Great White Throne Judgment, the damned will be judged by Christ and re-located from hell to the lake of fire.
26. **MARRIAGE COVENANT, DOCTRINE OF**—One man to one woman committed to Jesus throughout life for better or for worse, in sickness and in health. The idea of lesbian, gay, bi-sexual, and transgender 'orientations' are abominations and perversions in God's sight. These sins, like all sins, are a choice, not a biological predisposition. Remember, Sodom and Gomorrah? There were three other cities as well that were vaporized by fire and brimstone—Admah, Zeboim and Zoar—cities of the plain. The ordinance of marriage also condemns adultery, bestiality, incest, and any other sexual transgression mentioned and not mentioned in scripture.
27. **MIRACLES, DOCTRINE OF**—A miracle, by definition, is a phenomenon that cannot be explained by scientific analysis, nor subject to its scrutiny. Its performance is supernatural. Its execution is not bound by the conventions of natural law. Frequent and precise, the Bible records numerous miracles from the creation of the physical universe, to the parting of the Red Sea, to God's fleshly appearance via the Incarnation of Jesus Christ, to the ultimate defeat of evil on this planet, to personal redemption, to the birth of an individual. If one

cannot embrace miracles, with their origin in a supernatural God, one will never be saved. Miracles on the other hand do not demonstrate that those performing them are speaking on behalf of God (See the false prophet performing miracles—Rev. 13:14; and the spirits of devils working miracles—Rev. 16:14)

28. **NATIONS, PEOPLES AND TONGUES, DOCTRINE OF**—God allowed these for a reason. As long as a people acknowledge and practice Jesus Christ as Creator, they will be blessed of God, otherwise they will be under God’s curse. History proves a people’s survival and existence depends on the fundamental premise of respect and acknowledgement of the one true Creator—Jesus Christ. There is a move by the American Left to obliterate distinctions of race, language and regional speech so we all become ONE— “Behold the people *is* one.” (Genesis 11:6) God hates collectivism with its many forms and faces. The concept of ‘critical race theory’ is nothing more than an attempt by the Left to hate our ethnicity, our parents, our grandparents, etc. and exchange our unique ancestral roots for a fake globally controlled and monitored identity where no one is different and unique. Margaret Sanger and her Planned Parenthood objective to murder blacks in the inner city has finally come to light, in the evil plight and practice of eugenics, with its sinister agenda to ‘rid the planet of inferior mongrel races.’
29. **OMNIPOTENCE, DOCTRINE OF**—This tenet says all power belongs to Jesus Christ. This tenet also goes on to say that any power the demonic realm may appear to possess, is given to them to ultimately advance the kingdom of Christ on earth. While there is a future war between Michael (Israel’s defender) and his angels, and the devil and his angels that involve Satan’s false accusations against Israel, namely the persecuted woman of Revelation 12:13, this is a SPIRITUAL conflict whose outcome has already been determined in heaven. Jesus does allow the beast to overcome the two witnesses at the end of the 3.5 years, as well as the saints during the 3.5 years. These momentary EARTHLY defeats have an ultimate physical objective revealed—the destruction of the dragon, the beast, the false prophet, and the root of all that is evil on the planet. It also includes the destruction of the Roman Confederacy, better known as the Deep State. It is evident through Rome’s surrogates in the media, Hollywood, consensus science, academia, the courts, the mainstream medical community, major league sports, the banking industry, politicians, and certain elements within the military administrative branch⁵ of the government.
30. **PERFECT WILL, DOCTRINE OF**—Occurring abundantly in heaven, this phenomenon is less evident on earth albeit occurring frequently at certain times and in certain localities more or less depending on the level of spiritual darkness present and the disposition of Providence at the moment. It is without the influence, detriment, or consequences of sin. God is directly involved. And it is abundantly clear that God’s hand is clearly evident in its consequences, car accidents for example, where someone should have died but didn’t—defying the parameters of all physical laws.
31. **PERMISSIVE WILL, DOCTRINE OF**—In the Book of Job we see this. God permits Satan to buffet Job materially and physically. Job’s test is his faith. Permissive will involves Satan’s influence, and man’s sin. It can involve one or both. In the crucifixion we see both. The

permissive will of God is NOT initiated by God himself but rather men, Satan or both. Because of God's sovereignty, and that he is always in control and all powerful, this oftentimes is a difficult concept to understand or accept. Just remember, God is not directly involved in this phenomenon, and as far as man's sin is concerned, God never approves of it.

32. **PNEUMATOLOGY (THE HOLY SPIRIT), DOCTRINE OF**—Particularly, in the New Testament Christ's Holy Spirit accomplished numerous startling realities:

- **Redeems** the individual. Known as baptism by the Spirit, it happens only once in a moment of time, and you will never receive any more of the Spirit during salvation than at any other time. There is only ONE baptism by the Spirit, NOT multiple baptisms as the Charismatic Movement teaches. We can quench the Spirit. This occurs when we attempt to regain control of a life that is no longer our own. The old man has been crucified
- **Imputes (transfers) righteousness** of the law to the believer based on Christ's fulfillment of the law
- Becomes the believer's **teacher** revealing truth and discerning truth in a world of clerical authorities where a re-establishment of truth through these religious surrogates is at war with biblical freedom and liberty
- By indwelling the believer, amidst a tidal wave of 'Christian' counterfeit undercurrents and a growing visible/physical church deeply rooted in the Chaldean mysteries, authentic believers in Jesus have a way to be **sealed** and reveal to other believers their ownership by God in Jesus Christ
- **Accomplishing the will of God** in a marred vessel, when reality says it's impossible
- **The Holy Spirit is a person** NOT an influence, nebulous unknowable, or invisible force

33. **PRAYER, PRECEPT OF**—While it is petitioning the Almighty for particulars, more importantly prayer is discovering the will of God. While in Moses' case his intercession for the Hebrews on behalf of God revealed that God repented himself of the judgment he intended, God's will regarding this complaining bunch of Exodus ungratefults was ultimately realized—that generation died in the wilderness—their belief was not mixed with faith. What God's repentance demonstrated was grace and mercy when the people he granted it to, did not deserve it.

34. **REDEMPTION, DOCTRINE OF**—This is not a cooperative effort between God and men. The act of redemption lies outside man and is something beyond man's grasp, will, and effort. It has NO conditions, whereas religion, sectarianism and denominationalism, are squarely works dependent and fully conditioned on what man does. Christ's blood paid the ransom. His Holy Spirit accomplishes regeneration. Without Jesus' blood ransom and Holy Spirit baptism, salvation is impossible.

35. **SCIENCE FALSELY SO CALLED, PRECEPT OF**—This is predictive, consensus, computer modeling science based on speculation, theory, abstraction, feeling, intuition, prognostication, evolutionary bias, subjectivism, and esoteric religion. It is not rooted in observational fact, objective corroborative testimony, the scientific method, or even an acknowledgement of the reality of biblically-based supernaturalism.

36. **SCRIPTURE'S COMPLETION, DOCTRINE OF**—This is seen by all in religious circles as the biggest threat to their monolith of control and bondage. With scriptures' completion, came the end of man's religious control and clerical tyranny that had started with Nimrod. When the Bible was completed in 100 A.D. and the apostolic church ended, all authority Jesus had given to his apostles went back into the completed, inerrant word of God. Now the assault would start against Jesus precious words, as men sought to undermine its authority and question its authenticity. Unredeemed men hate the words of Jesus, for it denies their authority and control over others.
37. **SECOND DEATH, DOCTRINE OF**—This doctrine clearly teaches there are two deaths. There are those on this side of the grave who are walking corpses, perhaps burying their own spouses, parents or even children. The second death involves those who die after physical death. The Bible calls this the second death. At this point the individual is consigned to an eternal sentence of everlasting hell-fire NEVER able to deliver themselves from this unalterable condition. The lost were afforded countless opportunities on this side of the grave to repent;⁶ however, they chose to play God and reject Jesus Christ's forgiveness. There were even some who, deluding themselves into thinking that one day they might get around to repenting, never realized that truth because God took their foolish lives.
38. **SIN, DOCTRINE OF**—Thoroughly infected by sin and seen by God as a terminal illness, man will die and go to hell. Man has inherited Adam's sin, biologically, genetically, and innately. Biologically, all men will physically die. Genetically, Adam's sin has passed to all his offspring. Sin has affected men through the various genetic diseases man has encountered since the fall. The various organic diseases that afflict humanity have resulted in man's original rebellion against his Creator.⁷ Sin affected men innately by negatively impacting the mind in the areas of thought, reason, and recall. Man's moral conscience, a primary component of personality, has NOT been influenced or affected by sin however. While not a component of personality sufficient enough to deliver him from hell's flames, man's moral conscience IS God's law written on man's heart—God's still small voice. The law from Sinai was ONLY given to reveal man's sinfulness, "that sin by the commandment might become

Where I am going with this is, when the Flood came the earth's surface and its distribution of good, arable land was dramatically re-distributed after the Flood. In that re-distribution, much less fertile land was now available for farming AND the basic elements within the soil for making it a living organism were severely limited. This led to nutrient deficiencies within the very foods' men ate. This in turn led to livestock maladies, which in turn affected men. We are now seeing a tremendous potential in the nutraceutical industry vs. the pharmaceutical industry, namely plant-based supplementation and treatments with their synergistic relationships vs. pharmaceutical drugs with the isolation of a particular compound in its offering as treatment. In isolating these compounds, pharmacology cannot produce the synergism nature provides, namely safeguards in potency and amounts (ratios or percentages), of compounds consistently found in nature. The word *apothecary*, found in the K.J.V., is one who compounded the holy anointing oil and incense for the tabernacle in the wilderness. The oil, representing God's Spirit, was unique in its concoction and was forbidden to be duplicated by anyone for any other purpose. It consecrated and sanctified everything it touched. Whatever it was applied to, was most holy. Likewise, the incense and its compounding. Its smell, unique only the tabernacle, reminded the individual of God's presence, his holiness. Its duplication was forbidden.

exceeding sinful.” (Rom. 7:13). It was to lead men to the foot of the Cross, never to be used to elevate one man above another as the laws of religion consistently do.

39. **SIN’S ORIGIN, DOCTRINE OF**—Appearing in Genesis 3 is the fall of man. It is where sin first appeared on earth. Its consequences are legion and have been visible throughout man’s history. Its fallout affected the whole creation. Sin did not occur millions of years prior to the fall. It sprang from the belief that man, in this case Eve, could become as God. Satan’s lie to Eve that she could become “as gods” was a lie. Satan was really telling Eve she could become as God by determining right and wrong, not acknowledging what she knew to be right and evident already. Sin therefore, is the belief by man that he can become God, and that the goal of those who do this is the exact opposite of acknowledging truth. Sin’s most tangible relic is religion, whose architect is Nimrod, Ham’s grandson, son of Cush.
40. **STEWARDSHIP, PRECEPT OF**—This long forgotten and ignored precept is indispensable to the notion of private property. For renters, it is directed to the derelict mindset of many that believe that since I don’t own it, who cares. The Bible says if you have not been faithful in that which is another man’s, who should give you that which is your own? (Luke 16:12—context of the parable of the dishonest steward) After all, it all belongs to God. Catch my drift. Take care of it as though it were your own . . . because stewardship means you understand that it is ultimately God’s. For the Jews inheriting the Promised Land, it meant that everything the Jews possessed, God gave them. It was to eliminate greed, covetousness, and materialism. Did it? They forgot God and the precept of stewardship and it cost them their captivity, freedom to worship, and material gain.
41. **TIME, DOCTRINE OF**—One of the most disturbing things people of the Christian faith love to do is pick and choose what they like and what they don’t like from scripture. *Syncretism* is the idea of taking a belief from here, and another one from there and coming up with your own, ‘new,’ philosophy of life. I can’t tell you how many times I have witnessed this from church goers (churchianity). Over the years, it has become the norm in Christian circles. Never is this injustice more apparent than when it comes to the subject of biblical time. This is because most people of the Christian faith have succumbed to evolutionary lies and seem to be content with those lies. They believe with lots of time, things will eventually work themselves out. Really! You can give these monkeys all the time they want, while the laws of probability say life, as well as all the transitional forms evolution asserts, for example amoeba changing into fish, etc., will never happen. They have yet to find one example of transitional change in the fossil record. Anyway, the subject of time, as revealed in scripture, is very precise. Consider the following:
- **the day** (terrestrial day, Gen. 1:14)—The precise length of the day is given. It is 24 hours. It is the time it takes the earth to make one full rotation on its axis. In John 12:9 Jesus, the Creator of all, reinforced the day’s definition when he stated, “Are there not twelve hours in the day?” In Genesis 1, even before⁸ the creation of the greater light and the lesser light, as well as the stars, the day was bounded by twelve

⁸ This light is the light of Jesus Christ. It is still in effect today. The earth is the ONLY planet that enjoys such a blessing. While our star, the Sun, is the one often given the lofty moniker as life sustainer, it is actually the light of Christ that animates and sustains all life on earth.

hours of darkness, *the evening*, and twelve hours of daylight, *the morning*. Not only that, but a numerical value was assigned to each day: first day, second day, third day, etc. The context within Genesis 1 clearly establishes the length of the day AND when it began, at 6:00 p.m. in the evening. This is so unlike the messed-up chronology we currently observe.

- **the month** (lunar month)—The month is the time it takes for the moon to rotate around the earth, from one new moon to the other—30 days NOT 28, 29, 30 or 31 days. In Genesis 7:24 the idea of a 30-day month is inferred in the phrase, “an hundred and fifty days.” God is precise, men are not. Why? It’s all about control and man’s incessant rebellion against God, as well as man’s insatiable need to control others.
- **the year** (solar year, Gen. 1:14)—The biblical year is 360 days—with each of the four seasons being three months in duration (Gen. 8:22). It is the time it takes the earth to travel around the sun one time. The biblical new year began in April (Ex. 12:2) NOT January. The Bible’s formula for time calculation is extremely accurate, while man’s chronology is very inaccurate. Consider this with the current date of August 30th, 2021 and how long it is claimed since Christ’s crucifixion. Taking our current date, we come to the current time of 2021 years + an odd smattering of 8 months, with each month offering up a different number of days. If we take the biblical year of 360 days instead of 365 days, a difference of 5 days per year, we arrive at 10,105 days or approximately 28 years (2021x5=10,105 days OR roughly 28 years). Taking this excess, we then subtract that from our current year of 2021 (2021-28=1993). We are actually in the year 1993 according to biblical time, so therefore it has been 1,993 years since the crucifixion of the Savior. What a difference 5 days a year makes over 2,021 years.
- **Adamic genealogy**—Because of the age given for each of Adam’s descendants when they begat their offspring, we know the precise age from creation to the flood of Noah. And from here to other significant events, people, and kingly reigns (southern kingdom specifically), it is easy to calculate our current time from creation, the starting point of it all, to the present. There are no B.C. or A.D. computations with biblical time. While the incarnation of Christ is profoundly significant, his birth must be calculated from creation, the starting point, to really mark a point of any significance. I address this topic of time in a [pdf. document](#) from my website under Bible’s chronology.

42. **TRINITY, DOCTRINE OF**—This teaching says God is three persons in one essence—the Father, the Son, and the Holy Spirit. Each person is one in substance, while each person has a distinct function, purpose and ministry. The Father is supreme Sovereign Conductor, working all things after the counsel of his perfect will. The Son is the Sin Bearer of mankind. The Holy Spirit is the believer’s Teacher, leading and guiding them into all truth. He also crucifies the old man through an event known as baptism by the Holy Spirit. This event happens once. It happens at a specific moment of time. When it happens, the sinner will never get any more of the Spirit at that moment than any other time. Baptism by the Holy Spirit is a requirement for anyone professing and possessing Jesus as Savior. A stumbling

block and rock of offense to all who deny Jesus as God, the trinity has condemned all who reject it to hell.
