## 1 Purpose

This policy defines Inventorium RTO's approach to ensuring the inclusion of industry input in the RTO's vocational education and training (VET) course development and assessment validation activities.

Industry engagement ensures Inventorium RTO's training and assessment is relevant to industry and employers, maximising learners' opportunities for employment, advancement, or further education. The Inventorium RTO systematically engages with relevant industry stakeholders to establish appropriate contexts, methods, resources and trainers and assessors to deliver training and conduct assessment

The primary objective of industry consultation is to enable industry representatives to have input and provide comments and feedback on Inventorium RTO's VET courses, documents, and resources.

## 2 Scope

Implementation of this policy is the responsibility of all full-time and part-time ongoing, sessional, and casual Inventorium RTO staff.

## 3 Definitions

**Consultation** - Participation by industry representatives in a range of activities including input into and/or validation of Training and Assessment Strategies; validation of assessments; course reviews.

Industry consultation may also take the form of focus groups as required, or consultation of industry representatives, e.g., with special expertise or business formats.

**Industry/Enterprise** - refers to Industry organisations, Industry training advisory bodies and skills councils, Unions, Specific clients, Occupational licensing bodies, Employers.

## 4 Policy Statement

Reflective of Inventorium RTO's mission to graduate students who are work ready, Inventorium RTO engages with industry, employers, professional bodies and the community to ensure the continued industry relevance of the Inventorium RTO's vocational education and training (VET) courses.
