► For parquet: after fillered and sanded the floor (final sanding with 180 grit paper), clean the surface and apply two coats of WTVE0754 approximately 120 g/m² for coat, interval between 2 ÷ 4 hour for coat with light sanding in between. ► It must be applied at a temperature not lower than 10°C. ► Equipment cleaning: use water or soapy water. Note: clean immediately after use. ► If properly stored at a temperature between 5°C ÷ 35°C shelf life is 12 months.
