

# Privacy Policy

This Privacy Policy ("Policy") applies to [melyourheartfrenchies.godaddysites.com](http://melyourheartfrenchies.godaddysites.com), and Melt Your Heart Frenchies ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include [melyourheartfrenchies.godaddysites.com](http://melyourheartfrenchies.godaddysites.com). ## Collection of your Personal Information

The Company may also use your personally identifiable information to inform you of other products or services available from the Company and its affiliates.

## **Sharing Information with Third Parties**

The Company does not sell, rent, or lease its customer lists to third parties.

- Engage in public or peer-reviewed scientific, historical, or statistical research in the public in
