Car Show Participants hereby agrees to assume all liability for any injuries or damages arising from or in any manner related to the performance, event or equipment provided by Car Show Participants and within the scope of services provided by Car Show Participants, and for those injuries or damages that Car Show Participants, or its employees, performers, independent contractors or Subcontractors may cause to any persons or property during the Event or while Car Show participants and its Subcontractor are on the Event premises and engaged in the activities described hereinabove**
