



LIMITED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, a licensed Motor Carrier (hereinafter referred to as "CLIENT"), acting through its authorized representative, hereby makes, constitutes, and appoints **CIRCLE 7 DISPATCH SERVICE LLC** (hereinafter referred to as "COMPANY"), as its true and lawful Attorney-in-Fact. The parties acknowledge and agree that **Maria, Lead Dispatcher**, is the primary contact and a designated representative authorized to act on behalf of the COMPANY for carrier onboarding and dispatching purposes within the scope of this Limited Power of Attorney. For revocation and communication, the COMPANY may be reached at circle7d365@gmail.com.

1. SCOPE OF AUTHORITY

The COMPANY is granted full power and authority to act in the name, place, and stead of the CLIENT for the following limited purposes related to the movement of freight:

- **Carrier Onboarding:** To complete and execute "Broker-Carrier" and "Shipper-Carrier" agreements and onboarding packets.
- **Negotiation:** To negotiate freight rates and terms with brokers, shippers, and third-party logistics providers.
- **Documentation:** To sign and accept rate confirmations, load tenders, and other necessary dispatching documents.
- **Information Exchange:** To request and provide certificates of insurance, W-9 forms, motor carrier authority permits, and other documents required by brokers or shippers to facilitate load booking.
- **Administrative Liaison:** To perform all acts necessary to facilitate freight movement on behalf of the CLIENT, including communicating with brokers/shippers regarding pickup and delivery status.

2. LIMITATIONS OF POWER

This Limited Power of Attorney is strictly administrative and is subject to the following limitations:

- **Safety Limitation:** This authority is limited solely to the functions of dispatching and administrative logistics support.
- **Financial Exclusion:** This authority does **NOT** grant the COMPANY any access to, or authority over, the CLIENT'S financial bank accounts, credit cards, or other financial assets.
- **Ownership Exclusion:** This authority does **NOT** grant the COMPANY any right to represent ownership or equity interests in the CLIENT'S business entity.
- **Credit Facilities Exclusion:** This authority does **NOT** grant the COMPANY any authority over the CLIENT'S credit facilities.
- **Operational Control:** The COMPANY shall have no authority over the CLIENT'S selection of drivers, vehicle maintenance, or safety compliance, for which the CLIENT remains solely responsible.

3. INDEMNIFICATION

CLIENT agrees to indemnify and hold COMPANY harmless for all actions taken by COMPANY within the scope of the authority granted in this document. COMPANY shall not be held liable for any claims, losses, or damages resulting from actions taken in good faith reliance upon this Power of Attorney.

4. DURATION AND REVOCATION

This Power of Attorney shall remain in full force and effect from the date of execution until revoked by the CLIENT. Revocation must be provided in writing and is only effective upon receipt by the COMPANY via certified mail or email at circle7d365@gmail.com.

5. GOVERNING LAW

This instrument is executed and delivered in the State of Arizona and the laws of the State of Arizona shall govern its interpretation and enforcement. Exclusive venue for any action related to this instrument shall be in Maricopa County, Arizona.
