Mission City Community Network (MCN) is proud to announce being a recipient of grant from Health Resources Services Administration (HRSA), for expanding access to Quality Substance Abuse Disorder and Mental Health services. MCCN will use these funds to hire additional substance abuse and other staff to provide substance abuse and mental health services in our communities. In addition HRSA awarded MCCN a Quality Improvement grant in recognition of MCCN's high levels of Quality Performance in calendar year 2017. MCCN plans to use the funds to further improve the Quality Improvement programs.

With only a few weeks left before the Mid Term Elections which may have impact on many issues facing the nation and the state, it is important that all of us vote. If you have not registered, it is not too late to register; you can still register until October 22, 2018. 




MCCN Celebrates National Health Center Week
