

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.bluecloudtropicalbbq.com and Bluecloud's Tropical BBQ Sauce and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Bluecloud's Tropical BBQ Sauce include www.bluecloudtropicalbbq.com and BlueCloud's Trop Sauce. The BlueCloud's Trop Sauce website is a Ecommerce site. By using the BlueCloud's Trop Sauce website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, BlueCloud's Trop Sauce may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase BlueCloud's Trop Sauce's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us.
