


CaneToad Coin's vision is to become the most dynamic and engaging meme coin ecosystem in the world. This vision is built on several core pillars:

- The total allocation of 500,000,000 CaneToad Coins will be distributed as follows:
- Australian Funds: 400,000,000 CaneToad Coins (80% of the total)
- Global Funds: 100,000,000 CaneToad Coins (20% of the total)
- Distribution Mechanism: Streamflow Vesting Plan
- To ensure stability and provide a reliable stream of funding, the CaneToad Coins will not be distributed as a single lump sum. Instead, they will be locked within a secure and immutable Streamflow Vesting Plan smart-contract on the Solana blockchain.
- This smart-contract will release funds incrementally to the recipient's digital wallet over a predetermined period. The vesting plan will begin releasing fund after a four years lock-up period.
- After a period of four years. This controlled, "streamed" release of funds serves several key purposes:
- Reduces Volatility: It prevents a large influx of tokens onto the market at once, which could negatively impact the coin's value.
- Provides Long-Term Support: It guarantees a steady, predictable income stream for the recipient organizations, allowing for long-term planning and sustainability.
- Enhances Transparency: The immutable nature of the smart-contract ensures that the distribution schedule is public, verifiable, and cannot be altered.
