

# Student Mental Health and Wellbeing

POLICY

Mount Pleasant Road Primary School

### A. Rationale:

- **A.1.** Schools can play a key role in promoting mental health in all children and young people, recognising that children and young people's learning and development is supported by environments that promote mental health. <sup>1</sup>
- **A.2.** Mental health promotion in schools is about creating positive, safe and supportive environments, and providing opportunities to build and practice relationship skills, resilience and social and emotional competencies. All staff can be involved in mental health promotion as it relates to every area of the school the culture, policies, curriculum and activities.<sup>2</sup>
- **A.3.** It is recognised that every member of Mount Pleasant Road Primary School has an impact on students' health and can contribute to creating an environment that promotes positive mental health and wellbeing. All members of our school community including staff, students, families and volunteers will be supported to meet this policy.

## **B.** Definitions

- **B.1.** Mental health: For children, this means "the capacity to enjoy and benefit from satisfying family life and relationships and educational opportunities, and to contribute to society in a number of age-appropriate ways. It also includes freedom from problems with emotions, behaviours or social relationships that are sufficiently marked or prolonged enough to lead to suffering or risk to optimal development in the child, or to distress or disturbance in the family."
- **B.2.** Resilience: The ability to bounce back from adversity in order to lead a healthy and fulfilling life.<sup>4</sup>
- **B.3.** Social and emotional competence: The ability to recognise and manage emotions, develop caring and concern for others, make responsible decisions, establish positive relationships and handle challenging situations capably.<sup>5</sup>

#### C. Aims:

- **C.1.** Leadership and staff acknowledge the importance of promoting positive mental health and wellbeing.
- **C.2.** This policy confirms our commitment to:
  - **C.2.1.** Providing a safe, welcoming and supportive environment

- C.2.2. Promoting a culture of respect, fairness and equality
- C.2.3. Embedding social and emotional learning into the curriculum
- **C.2.4.** Ensuring families, students and staff are key partners in mental health and wellbeing initiatives
- **C.2.5.** Engaging and working collaboratively with local health professionals.
- **C.3.** As a health promoting school, we will promote the mental health and wellbeing of students, staff and families through learning, policies, creating a safe and healthy physical and social environment, and developing community links and partnerships.

## D. <u>Implementation</u>:

Healthy policies

- **D.1.** This policy should be read in conjunction with the Student Engagement and Wellbeing Policy.
- **D.2.** Staff, families and students are involved in guiding the development and implementation of the whole school mental health and wellbeing policy and are seen as key partners in promoting and supporting positive mental health in the school.
- **D.3.** Staff, families and students are provided with information about policy requirements.
- **D.4.** If a student is suspected of being at risk of or experiencing social, emotional, behavioural or mental health difficulties the school will aim to help the students and will contact relevant parties to assist with the problem.

Healthy physical environment

- **D.5.** The school provides a welcoming and inclusive physical environment that reflects the diversity and interests of the students, families and staff.
- **D.6.** The school provides a warm and welcoming space for students, families and staff to meet informally to discuss private matters.

Healthy social environment

- **D.7.** The school encourages and values the contribution of students, families and staff to a positive school environment and all members of the school community promote a culture of respect, fairness and equality.
- **D.8.** The school has a range of strategies to promote positive and responsible behaviour, and to prevent and respond to bullying, discrimination and harassment.
- **D.9.** Staff have the appropriate knowledge and skills to recognise and support students who may be at risk of or experiencing social, emotional, behavioural or mental health difficulties, including how to access support and make appropriate referrals.

Learning and skills

- **D.10.** The school provides a curriculum that actively engages and builds students' self-awareness, social awareness, responsible decision making, self-management and relationship skills, and social and emotional learning is delivered in one or more key learning area.
- **D.11.** Staff are supported to access resources, tools and professional learning to enhance their knowledge and capacity to promote mental health and wellbeing across the curriculum.

Engaging children, young people, staff and families

- **D.12.** Families, students and staff are key partners in developing and supporting mental health and wellbeing initiatives and are, on a regular basis, provided with information, ideas and practical strategies to promote and support mental health and wellbeing at school and at home.
- **D.13.** Students are engaged in developing and implementing mental health and wellbeing initiatives via junior school council, Bounce Back Program, Circle Time, Restorative Practise, Guided Growth Program and Values for Life.
- **D.14.** Families and students from diverse cultural backgrounds are engaged to ensure cultural values and expectations about mental health and wellbeing are respected.

Community partnerships

- **D.15.** The school engages with local health professionals, services and other organisations to increase their capacity to deliver and promote mental health and wellbeing initiatives where appropriate.
- **D.16.** Cultural groups within the community are encouraged to participate in the school's mental health and wellbeing initiatives.
- **D.17.** The school provides information, where appropriate, to students and families about local mental health and wellbeing services, parenting and family services, and other resources that are available to support the mental health and wellbeing of students and families.

## E. Evaluation:

**E.1.** This policy will be reviewed as part of the school's three-year review cycle.
