Member Spotlight

Meet Joe Kirby, one of our newest Legionnaire-declared dead in 1969 and resurrected a few weeks later by the U.S. Air Force! Knowing his parents couldn't afford college for him, Joe volunteered with the Air Force delayed enlistment program before he graduated high school and his 18th birthday-using the military as a means to a law enforcement career. With his imposing presence of 6'5", Joe quickly succeeded in the Air Police School and immediately thereafter the Air Police's Canine Handler School.

Later, the Air Force offered Joe an adventurous opportunity in Southeast Asia, in support of the Vietnam War. Willing to work outside the safety of the air base fence for 'special assignments.' Joe received additional combat training by completing Army Ranger School and other escape, evasion schools–all would later pay off for him. Their assignment: investigate U.S. plane crash sites in Laos to assist technicians and explosives personnel to salvage or destroy sensitive technology aboard the planes. These young 19- to 21-year-olds would be devoid of identifying clothing or dog tags. If captured or killed, the U.S. government 'would disavow any knowledge of their actions.' Joe's Fire Team consisted of 12 Combat Air Police Dog Handler Teams.

In August 1969 while in Laos, U.S. spotter aircraft warned Joe's Fire Team that two company-sized North Vietnamese Army units were quickly closing in on their location; the U.S. wasn't the only government wanting the plane's technology. The Fire Team finished their assignment and secured a landing zone for three successful helicopter personnel evacuations.

Joe's crew and dogs were set to board the last helicopter when while landing it was struck by enemy fire just 20 feet off the ground. Four of the five-man helicopter crew were killed, but one door gunner was safely blown several yards away.

The fire crew's pre-established escape route was executed with the fire crew, dogs and the gunner. Men discarded unnecessary gear to lighten their loads. After evacuating, the other pilots reported the smoke from the downed fourth helicopter. Subsequent rescue units

found the downed burned out copter and assumed all aboard the copter and fire crew perished.

For the next five weeks, the survivors and their dogs walked westward towards Thailand, subsisting on dog biscuits. Eventual contact was made using short-range

radios with F105 fighter bombers and rescue ensued. Word had not gotten to Joe's wife, Mary, about the incident so she was luckily spared the news of losing him. It wasn't until May 1970 when the feds rectified Joe's demise and reinstated his paychecks and backpay. Following his discharge in November 1970, Joe went from being an X-ray technician and security bouncer in SF to being hired as a Redwood City Policeman. In 1975, he joined the Santa Clara County Sheriff Dept.--working homicide and robbery investigations--and retiring as a Captain in 2003 while simultaneously serving as Chief Range Master at Evergreen College (1978-1998). In late-1971 he joined the Army Reserves, 229th Military Intelligence Company as an NCO-graduating as a Counterintelligence Distinguished Agent Graduate.

Joe moved back & forth between the Army Reserve and the California Army National Guard. As an NCO (E-7), Joe completed Officer Candidate School in 1978 and gained his commission as an officer. As a Captain, Joe was selected to be the Headquarter Company Commander for a USAR Psychological Operations Battalion. He spent four years as commander, usually only a two-year assignment. Somehow Joe also found time to join and compete for the National Guard Composite Rifle Team. While with the Sheriff's Office, he served on and as Commander of the Transit Patrol Division, in addition to SWAT Teams, Canine Teams, Underwater Dive Teams, Mounted Patrol Teams, and the Search and Rescue Unit. In his retirement, Joe enjoys his time with his bride, Mary, of 56 years, adult children and four grandchildren. Joe was recently introduced to the Legion by his brother-in-law, Oxnard Post 48 Vice Commander. As Joe acquaints himself with the Post 105's Family, please express your gratitude to him and his wife for his many years of dedicated public service and sacrifice for our country. - Peggy T.



The Sons of the American Legion Post 105 has had a busy year. Each year we submit National Headquarters our Consolidated Report. This is a synopsis of all hours and donations we made to assist

Veterans and support Americanism and Patriotism with whomever we encounter. Shared below is what we have done over the last year from June 01, 2023, to May 31, 2024 compared to the last Consolidated Report for the same time period.

The Consolidated Report for 2024 shows Post 105 Sons volunteered a total of 771.5 hours and donated \$400 to various groups. The Community Service Hours are items such as working at the Post, helping at various events throughout the county and community while other hours would fall into the areas of Duty Officer, Administrative time and other tasks that we volunteer ourselves to. Please be aware these are only the hours that are tied with Post 105. Many of our Sons donate their efforts to other causes which are not reported.

The IRS values California volunteer hours at \$35.56 per hour; therefore, Post 105 Sons have given \$27,434.54 of valued time to our Veterans. Thank you for allowing us to be able to do that.
