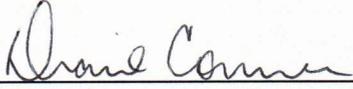

- I. On a motion by Mr. Durio, seconded by Mrs. Conner, and carried unanimously; the Board approved the minutes as presented for November 20, 2025, special board meeting. No public comment.
- II. Mr. Henderson presented the Board members with a copy of the 2026 Budget originally presented at the November special meeting. The budget review advertisement was in the official journal, Lake Charles American Press, in accordance with Louisiana Budget Requirements for Political Subdivisions. A copy of the budget was kept in the office for review, though no inquiries or requests were made to review the budget. Mrs. Conner made a motion to approve the budget as presented, seconded by Mr. Durio; and carried unanimously. No public comment.
- III. Mr. Henderson presented the Board of Commissioners with the financial statements for the end of the month of November. Mr. Henderson stated that the balance sheet looks good. Ad Valorem tax income had been falling off but will pick back up starting with December's income. Mr. Durio made a motion to approve financial statements for the month of November as presented, seconded by Mrs. Conner; and carried unanimously. No public comment.
- IV. Mr. Henderson presented the Board of Commissioners with payments for the month of December. Mr. Henderson informed the Board that the only expenses out of usual payments were the expenses for the Christmas decorations that had been previously approved. Mr. Durio made a motion to approve the payments as presented, seconded by Mrs. Conner; and carried unanimously. No public comment.
- V. Mr. Henderson informed the Board that the current bank of Record for general funds is Merchants and Farmers Bank. The Bank of Record for Bond and Debt Service is First Federal. Mr. Durio made a motion to keep the Bank of Records as is, seconded by Mrs. Conner; and carried unanimously. No public comment.

VI. The current journal of record is the Lake Charles American Press. Mrs. Conner made a motion to adopt Lake Charles American Press as the official journal for 2026, seconded by Mr. Durio; and carried unanimously. No public comment.

VII. There being no further business, Mrs. Conner made a motion to adjourn, seconded by Mr. Durio; and carried unanimously. No public comment.
