## REGULAR BOARD OF COMMISSIONERS MEETING HELD AT WARD 7 COMMUNITY CENTER MEETING ROOM 1615 HORRIDGE STREET, VINTON, LA 70668 WEDNESDAY, MAY 14,2025 AT 5:30 PM

Minutes of the regular meeting of the Community Center & Playground District #3, Calcasieu Parish, Vinton, LA held in the meeting room of the Community Center on May 14, 2025, at 5:30 PM. After full compliance with all regulations as to notice otherwise and respect to conveying of said meeting, the meeting was called to order, and a roll call was taken with the following present:

- I. On a motion by Mrs. Conner, seconded by Mr. Durio, and carried unanimously; the Board approved the minutes as presented for the April 9, 2025, regular board meeting. No public comment.
- II. Mr. Henderson presented the Board of Commissioners with the financial statements for the end of the month of April. Bank Reconciliation for the General Account has not been completed. There was an error reconciling the account due to the switch from Quickbooks to Tyler after the 4<sup>th</sup> quarter of 2024. Mr. Durio made a motion to approve the financial statements as presented, seconded by Mrs. Conner, and carried unanimously. No public comment.
- III. Mr. Henderson presented the Board of Commissioners with payments for the month of May. Mr. Durio made a motion to approve the bills as presented, seconded by Mrs. Conner, and carried unanimously. No public comment.
- IV. Mrs. Labby presented the Board of Commissioners with a Co-operative Endeavor Agreement between the District and Calcasieu Parish Police Jury for the 2025 Summer Feeding Program. Mr. Durio made a motion to enter the agreement with the Parish, seconded by Mrs. Conner; and carried unanimously.
- V. Mrs. Labby updated the Board of Commissioners on the opening of the Community Center Pool. Splash day is scheduled for Saturday, May 24<sup>th</sup>. Swim lessons will start the following week. We are still short lifeguards and are still advertising for the positions. We will have open swim again on Saturday, May 31<sup>st</sup>. Then open for regular hours during the week the following Monday, June 2<sup>nd</sup>. Mrs. Conner informed the Board of Commissioners that she had done some more research on the Power Plate previously presented to the Board. The Power Plate has been very useful to people in therapy and individuals with bone density issues.
- VI. There being no further business, Mrs. Conner made a motion to adjourn, seconded by Mr. Durio; and carried unanimously. No public comment.
