- I. On a motion by Mrs. Conner, seconded by Mr. Durio, and carried unanimously; the Board approved the minutes as presented for the July 9, 2025, regular board meeting. No public comment.
- II. Mr. Henderson presented the Board of Commissioners with the financial statements for the end of the month of July, including the Monthly Budget and Transactions through July 31st. Bank Reconciliations for all accounts for the month of July were presented. Mr. Henderson said that nothing was out of the ordinary. All accounts are in good standing and where they should be. He plans to have the actual year to date incomes and expenses at the October meeting. He will start working on the 2026 Budget.
