Stall Fees: \$130 postmarked on or before April 24; (Thursday through Sunday); Stall Fee postmarked on or after April 25 is \$150; Cancellation fee on stalls is \$25 per stall, Move In Day is May 7, Sorry No Early Move In is available

Day Stall (No overnight use); \$80 per horse; Stall fee for horses laying over for events after show is \$40/stall per day

PHCO Office Fee: \$25.00 per horse; Membership is required in each respective association and/or PHCO;

APHA Fees \$9 (\$1 per judge/class - show processing fee; \$2 per judge/class – APHA Paynt Points fee for all exhibitors regardless of division or class)

APHA Approved Class Entry Fee: APHA Class Fees-\$36.00 (\$12 per judge) or Weekend Division Rate \$150 (1 horse/exhibitor combination)

APHA Chrome Cash Entry Fee: \$50.00 per class; (\$10 APHA fee; \$40 PHCO fee) Must enter corresponding APHA class; Cash Chrome will be applied to invoice(s)

APHA Limited Class fee \$25.00 per class - Buckle Class; Must be PHCO member (Eligibility No World or Reserve World championships in last 5 years in any association, Special Limited Form must be completed)

IRHA Office Fee \$25.00

IRHA Entry Fee is \$50 per class (5% to IRHA=\$12.50, \$25 in purse, \$12.50 to PHCO) or Weekend Division Rate \$150 (1 horse/exhibitor combination)

NSBA Office Fee \$25.00

NSBA Entry Fee is \$25 per class (\$3 to NSBA, \$22 to PHCO) or Weekend Division Rate \$150 (1 horse/exhibitor combination)

All Breed Office Fee \$25.00

All Breed Classes Fees: \$25.00 per class or Weekend Division Rate \$150 (1 horse/exhibitor combination)

Trail and Ranch Trail Equipment Fee: \$20.00

Credit card convenience fee 5%

An exhibitor number will be issued once a formal method of payment has been received by the horse show office

Coggins is required within 12 month, must provide copy for PHCO's records, horse's name and registration must be provided

Classes will be conducted and judged in accordance with current APHA or IRHA Rules.

The age of a youth (YA) competitor on January 1st shall be maintained throughout the calendar year and will determine the age group in which youth can compete.

PHCO MEMBERSHIP REQUIRED FOR ALL HIGH POINT AWARDS; Exhibitor must be PHCO member

MUST show in 1 halter/conformation class and at least 2 Performance classes to be eligible for High Point. (Exception IRHA high point)

APHA High Point Divisions: YTH WT 5-10 yrs, YTH WT 11-18 yrs, YTH 18&U, Yth 13&U, Novice YTH, YTH Ranch 18&U, Amateur, Amateur WT, Novice Amateur, Amateur Masters, Open, Open Ranch, Amateur Ranch

IRHA High Point Divisions: Open, Youth, Non Pro, Youth Walk-Trot and Non Pro Walk Trot

NSBA High Point Divisions: Open, Youth, Amateur, Youth Walk-Trot, Amateur Walk Trot

All Breed High Point Divisions: All Breed YTH W/T, All Breed YTH, All Breed WT 19&O, All Breed 19&O, All Breed YTH WT Ranch, All Breed YTH Ranch, All Breed WT Ranch 19&O, All Breed Ranch 19&O
