Everyone in attendance had their full attention on the person speaking at the podium and no one had their eyes on their cell phones.

I was very impressed with all of the attendees in that meeting room for making the effort to focus their attention on the information being presented and not let the temptation of checking their cell phones every few minutes win over. I truly appreciate how difficult that can be, but the group of men and women in the meeting understood that focusing their attention on the information being delivered was the only way to fully process and retain that information.

Dave Teater, Sr. Director of the Transportation Initiatives for the National Safety Council, stated in a safe driving video, A Deadly Distraction, "The human brain truly does not multitask. When the brain is overloaded by two cognitive tasks, people switch attention (without recognizing it). People can only do one task at a time, one is primary and the other is secondary."

This statement is important to remember, whether we are sitting in a safety meeting, transporting personnel and equipment to a work site, walking around a rig performing an inspection, manually gauging a tank, operating a powered industrial truck, monitoring well pressures, etc.

Workers are more capable of reducing fatalities, injuries, incidents and near misses in the workplace, the roadways and at home when they are focusing on the job they are performing and not toggling their brains between two cognitively demanding tasks.
