



PARTICIPATION AGREEMENT 2024-25

FINANCIAL OBLIGATIONS

The Participants agree to pay the Sylvania Youth Hockey, Inc. (SYHI) fees pursuant to the fee schedules.

The Participants further agree that if the Player is placed on a roster the Participants will be liable for the entire season's fees even if the Player does not play for any reason including, but not limited to, having been suspended, terminated, voluntarily quitting, or leaving SYHI.

SYHI reserves the right, at its sole discretion, to waive a Player's fees and charges if it finds that the Player left the team because of a season ending injury or because the Player has moved out of the region served by SYHI.

Participants agree to make payments thru online (DaySmart) account bill pay. Payments may NOT be handed to a team manager, Tam-O-Shanter front desk, or hockey office. Participants understand and agree to pay rate of 1.5% of outstanding amount to be charged on the 16th of each month.

If the fees are not received on time for any reason, the Participants agree to the following:

- First Offense – verbal/written warning from the Hockey Office
- Second Offense – removal from the ice with possibility of removal from the team

If NSF situation occurs, the Participants agree to the following:

- \$25 fee assessed per incident
- Removal from ice for multiple NSF incidents until current
- No future credit terms (i.e., pay for season in full via credit card)

SYHI/PARENT & PLAYER AGREEMENT FOR THE 2024-25 SEASON

THIS AGREEMENT is entered into between the parent(s)/legal guardian (hereinafter referred to as "Parent") of the player being registered (hereinafter referred to as "Player") (collectively "Parents" and "Player" are referred to as "Participants"), and Sylvania Youth Hockey, Inc. (hereinafter referred to as "SYHI"). The Participants agree that Player will play amateur, competitive/recreational youth hockey for SYHI for the 2024-25 season from approximately August 21, 2024, until approximately March 15, 2025, in exchange for paying all of fees and charges and complying with all terms and conditions of this agreement.

**PARENT'S CODE OF CONDUCT
AGREEMENT**

- IV. Promote and support the Player Code of Conduct Agreement, including but not limited to its emphasis on good sportsmanship and fair play.
- V. Support a drug and alcohol-free environment.

Further, I pledge NOT to:

- VI. Use obscene or vulgar language to anyone at any time.
- VII. Publicly criticize players, coaches, or game officials.
- VIII. Taunt players, coaches, officials, or other spectators by means of baiting, ridiculing, or threat of physical violence.
- IX. Throw any object in the spectator viewing area, player bench, penalty box, or on the ice surface.
- X. Engage in any other physical aggression toward a player, coach, official, or spectator.

By signing this document, I agree to abide by and uphold the above stated Code of Conduct Agreement. I understand that violating this Code of Conduct Agreement may result in my expulsion from the spectator's viewing and game area, and may subject me, my child, and/or my child's team to penalties as determined by USA Hockey, game and/or team officials, and/or the Sylvania North Stars.

**PLAYER'S CODE OF CONDUCT
AGREEMENT**
Adopted from the USA Hockey Code of Conduct

As a player for the SYLVANIA NORTH STARS, I hereby agree to the following:

1. I will strive to have fun learning and playing the game of ice hockey.
2. I will work hard to improve my skills and learn from my coaches.
3. I will work to be a team player and get along with my teammates. I will not criticize my teammates either on the ice, on the bench, or in the locker room.
4. I will display good sportsmanship and discipline during games and practices with teammates and opponents, with team officials, and with game officials.
 - a) No swearing or abusive language on the bench, in the rink or at any team function.
 - b) No lashing out at any official no matter what the call is.
 - c) Anyone who receives a penalty will skate directly to the penalty box.
 - d) Fighting will not be tolerated. Multiple Fighting penalties could result in an appearance before a Discipline Committee.
5. I will be on time for practices and games, and I will notify the coach or the team manager if I cannot make it to a practice or game.
6. I will be responsible for completing school assignments and studies on a timely basis to minimize conflicts with practices and games, and I will maintain my grades as may be required by the team, my coach, or my parents.
7. I will learn the rules of the game from my coaches and my teammates.
8. I will wear the proper protective equipment during all games and practices including a mouthpiece, and an unaltered helmet. I will be responsible for my own equipment.
9. I will never argue with an official's decision.
10. I will dress appropriately for games as determined by the team. I will not wear clothing that is offensive and/or embarrassing to the team.
11. I will show respect for the facilities used by the team including the locker rooms and ice rinks.
12. As a member of a Sylvania North Stars team, I will behave properly and show proper discipline whenever I am with the team, especially in public or at public facilities including restaurants, hotels, shopping malls, etc.
13. I will refrain from taunting opponents and using foul language against opponents, officials, teammates, and coaches.
14. If I am a Bantam or Midget player, I will not drive to out of town games by myself nor will I drive teammates to out of town games.
15. I will not use alcohol or tobacco products and I will not use drugs or medications except as prescribed by a doctor or physician and/or administered by a parent or guardian.
16. I understand that I will be subject to appropriate disciplinary measures by team officials and/or my parents for failing to abide by these rules. Penalties can include "benching" or not being allowed to participate in practices or games, penalties during games as assessed by game officials, suspension from games or practices, or suspension from any of the above associations, depending on the severity of the offense. I understand that I have a right to an explanation of any disciplinary action taken or contemplated against me.
