## Our first Monday PSRA 6:00PM Membership Training Meeting by ZOOM

6:04-6:43 PM membership/training meeting led by PSRA Pres. Adolfo "Demo" DeMontalvo with 12 members attending (disappointingly low attendance!?).

## **Minutes:**

- 1) <u>Update Arbiter Blocks NOW *for January*</u> so John knows to whom he can reliably assign games without turn back. John has assigned games thru to December holiday break, including the Cody White Memorial JV Tourney: Fri./Sat. Dec.1&2 <u>Girls</u>; Fri./Sat. Dec.8&9 <u>Boys</u>. Please swiftly accept the recently assigned games or he will reassign them!
- 2) **55** referees (+1 new since last meeting) have registered for the season. Last day to register is 27 Nov. So far we have recruited **16!** new refs and WELCOME them. We will mentor, train and retain them.
- 3) <u>Hurry, required exams still available online thru midnight, EST, Nov. 27</u>. Don't wait until the last minute to complete it! BOD and senior PSRA members have been helping referees take the test, explaining the rationale of the right answers for situations in the sketchy wording of various questions. *Ask for help* so as to not score less than 75 and be shut out of working varsity the games as a result. Reminder to study/memorize <u>Florida unique blue card scenarios</u>. See & study pages 52 & 53 of the 2023-2024 online FHSAA Officials Guidebook.
- 4) Dave reports all refs have been paid for Oct. games and clients are being billed for Nov. games to be paid approx. mid December.
- 5) Mike covered this season's red card situations and their proper reporting. Illegal Pine Forest pitch lining has been properly reported via an AT-6M. Mike and Demo reminded all re: FL Jessica Lunsford Act background check & fingerprinting—get yours done/updated via the instructional email Mike created that Demo sent to all.
- 6) Warren covered the history of the Bob Hemme memorial scholarship and asked that all refs who can make it to attend, in uniform, the remembrance at the January 3 girls varsity game at Navarre. As we have done annually, please donate prior to January 3 what you can via ref pay deduction to the fund to enable two \$1000 scholarships to the most deserving players selected by Bob's widow Sylvia. Please let Treasurer Dave know what your donation amount is so he can deduct it from your December pay (or he can accept cash/check at our Dec. 3 meeting).
- 7) Scott provided the attached summary of misconduct sanction types listed with the associated rule. This is very helpful for red card reporting where the specific rule needs to be part of the write-up.
- 8) For forward planning, (note we moved some Zoom meetings to accommodate some of our refs who attend PCC and not available Sunday) our upcoming meetings are as follows:
