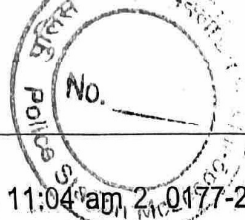

इस समय दर्ज है कि पुलिस अधीक्षक कार्यालय कांगड़ा स्थित धर्मशाला, जिला कांगड़ा, हि0प्र0 की शाखा DPCR से एक शिकायतपत्र बजरिया ई-मेल थाना में प्राप्त हुआ जिसका विवरण इस प्रकार से है:- To, The Senior Superintendent of Police, Distt. Kangra. SSP Office, Dharamshala, Himachal Pradesh. Sub: Threat to life. Respected Madam, I am extremely frightened as I write this complaint to you. Me and my family have been facing threat to our lives since the last three months. A murderous attack on me at my parent's house in Gurugram on the 25th of August 2023 is still being probed by the Gurugram Police and now when me, my wife and two year old baby were at Bhagsunag yesterday for our business work, we were stopped by two criminals on the way connecting mcleodganj to bhagsunag who came on a pulsar bike without a registration plate. They came towards my wife and child when I blocked them. One of them hurled abuses on me and the other was recording the incident on his mobile phone. The abusive person told me to mend my ways with Keshav Shreedhar and take my complaint back in Gurugram else he would eliminate my whole family starting from my infant. I had been facing a serious threat to me and my family's life from two individuals: 1. Sachin Shreedhar: He is an ex-IPS officer who had taken a voluntary retirement from the police to emerge as the biggest power broker in the state of Himachal Pradesh. He had been using his clout and his brother's influence who also retired recently as a senior IAS officer from the state of Himachal Pradesh. 2. Keshav Datt Shreedhar: He is a lawyer who besides practicing at Shimla is involved notoriously in political lobbying, getting clearances for Hydro power project companies from various departments and lobbying for political parties. Both the individuals have been intimidating me and my family members to sell a company that owns and operates Hotels and commercial complexes at Palampur and bhagsunag respectively. Keshav Datt Shreedhar's brother Mr. Rakesh Shreedhar who resides in the United States of America had invested in various projects owned by my family as a shareholder on Keshav Shreedhar's name. Keshav Datt Shreedhar had been facing deep financial crisis due to the sudden death of his partner in a media company who had left him burdened by many loans from different banks. He had been forcing us to sell the properties of our company so that he could settle his loans and advances. When we refused to do this, he took the help of Sachin Shreedhar who is his old friend to intimidate us. Sachin Shreedhar approached various family friends and acquaintances to set up a meeting with us to which we refused as he was not the interested party in our company matters. Having failed in his corrupt practices, he then connived with Keshav Shreedhar to send hired goons to kill me. The criminals attacked me on the 25th of August at my parent's residence. My two and half year old child was also hurt in the incident. The Criminals are still at large. Copies of the complaints are attached for your kind perusal. Madam, I find it critical to bring to your kind consideration that we felt safe in Himachal Pradesh till yesterday when I starting getting consistent telephone calls from the following numbers. 1. 0177-2626938; at 10:31 am, 10:32 am, 10:33 am, 10:34 am, 10:36am, 10:37 am, 10:39



am, 10:41 am, 10:42 am, 10:57 am, 11:04 am, 2. 0177-2626222: at 3:26 am, 3:24 am, 4:23 pm 3. 9418400159: 3:54 pm 4. 8219282766: 4:24 pm Whereas the first two phone numbers are from the office of the DGP, Himachal Pradesh, the last two phone numbers of DSP, SHO Palampur respectively. I was then sent a whatsapp message by SHO Palampur stating that the DGP wanted to talk to me and that I should call back on 0177-2626222. When I called back on the phone number I was connected to the DGP, Mr. Sanjay Kundu who picked up the phone and said "Nishant, you come to Shimla and meet me". I asked him as to why I should do that, he reiterated that "You have to come to Shimla and meet me" As stated above, the two individuals have acquaintances in the highest levels of the Govt., be it political or bureaucratic. I hope the two incidences are not related and the fact that I am being pressurized to be at Shimla as early as possible by none other than the Head of the Police Force of the state of Himachal Pradesh himself despite the fact that I am neither known to the police officer nor have I ever met him ever. The facts go a long way to suggest that there is something seriously wrong and illegal that is being planned against me and my family. I had sensed it yesterday and since I was really threatened by the two incidences which happened one after the other, I face a serious threat of being killed along with my family members. Madam, me along with my wife and kid went to your residence yesterday night but you were not at home. We then took the phone number of your PSO from the police official guarding your house. I called on 9805533312 and spoke to Mr. Sanjay who told me that you will take a while to come. We waited for you right outside your gate but when you did not come back for a long time, we rushed back to Palampur. The lawlessness has gone a bit too far where I have no where to go. In all this anguish, hopelessness and fear, I need your office to shield my family and myself against any physical harm. I live in my house situated inside an estate called Sai Gardens with my wife and infant and fear that anything can happen anytime. I appeal to you and the Department of Home affairs, Govt. of India as well as the State of Himachal Pradesh along with the office of the Chief Minister, Govt. of Himachal Pradesh to save me and my family. I call for a prompt enquiry into what has happened in the interest of law and justice and to ensure that my fundamental right to life and liberty is ensured by the state and your office and take necessary action against the accused whosoever it is in the discharge of your duty as the Senior Superintendent of Police. The life of me and my family rests in your hand and I expect an unbiased and immediate action in this regard. Madam, in both the incidents my location was exposed to the criminals and I am sure that my phone number 9816133333 is being tapped. Also the fact that in both instances the happening was being recorded suggests that the criminals had been acting on somebody else's behest. I request you to kindly unearth the truth from Airtel. The CCTV footage of the criminal act in Gurugram along with copies of my complaints are attached for your kind consideration and records. I am also attaching the call records of yesterday's calls from the office of the DGP, DSP's and SHO's mobile phones and the whatsapp image of the message sent to me by the SHO, Palampur.
