SUMMARY ANNUAL REPORT

For Teamsters Local 641 Welfare Fund

This is a summary of the annual report of the Teamsters Local 641 Welfare Fund, EIN 22-6220289, Plan No. 501, for period March 01, 2020 through February 28, 2021. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Medco Containment Life Insurance Company, Metropolitan Life Insurance Company and Sierra Health and Life Insurance Company to pay prescription drug, life and accidental death & dismemberment claims, and health claims incurred under the terms of the plan. The total premiums paid for the plan year ending February 28, 2021 were \$300,082.

The value of plan assets, after subtracting liabilities of the plan, was \$36,144,500 as of February 28, 2021, compared to \$33,515,646 as of March 01, 2020. During the plan year the plan experienced an increase in its net assets of \$2,628,854. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$13,665,406 including employers' contributions of \$8,483,787, pensioners' and separated participants' contributions of \$458,432, realized gains of \$104,258 from the sale of assets, earnings from investments of \$4,603,125, and other income of \$15,804.

Plan expenses were \$11,036,552. These expenses included \$1,237,378 in administrative expenses, and \$9,799,174 in benefits paid to participants and beneficiaries.
