



# NOTABLE WEEKLY CALLS

## MONDAY, JANUARY 11

**EMS:** A subject believed he had been shot at and thought he may have been hit. He was transported to the hospital for a medical evaluation. Investigation revealed that the incident had not occurred and the subject was in possession of methamphetamine and cocaine.

**SUSPICION:** An incident was reported that occurred two days earlier in which an unknown subject unlawfully entered someone else's home. This is currently under investigation.

## TUESDAY, JANUARY 12

**WELFARE:** A subject made suicidal statements to a crisis worker, who was then unable to reach them via phone after the call disconnected. It was determined that the subject was in another city. Officers worked with the crisis worker, who was able to make contact with the subject and determine that everything was OK

**THEFT:** Report of a theft of jewelry from a local business.

## WEDNESDAY, JANUARY 13

**DISORDERLY CONDUCT:** Complainant advised that his roommate pushed him several times. Officers responded and learned that an argument had broken out due to current political issues. Possible charges are pending.

**MENTAL:** Officers responded to a home for an attempted overdose. The subject was transported to a local hospital via ambulance.

## THURSDAY, JANUARY 14

**JUVENILE PROTECTION:** Received a report of physical child abuse. Officers conducted a preliminary investigation and reached out to a neighboring agency for additional follow up.

**MENTAL:** A suicidal subject stabbed themselves, causing a deep laceration in their abdomen. An officer provided aid until EMS arrived.

## FRIDAY, JANUARY 15

**ACCIDENT:** Officers responded to a business where an employee was suffering from a laceration on their arm, and an EMT onsite was unable to control the bleeding. Officers were able to help get the bleeding under control until EMS arrived.

**DISORDERLY CONDUCT:** Officers responded to a report of a fight in an apartment. One subject had been removed prior to law enforcement arrival.

**HARASSMENT:** Officers investigated a series of harassing messages that were in relation to a case from last fall. Messages are threatening in nature; case was forwarded to DA's office.

## SATURDY, JANUARY 16

**CRIMINAL DAMAGE:** Officers received a report of criminal damage to a business. The area was searched and secured, and surveillance footage was viewed depicting the incident. Incident remains under investigation.

## SUNDAY, JANUARY 17

**TRAFFIC STOP:** Officers assisted the Dunn County Sheriff's Office after a deputy had attempted to initiate a traffic stop in the city. The vehicle operator, who had multiple felony warrants for their arrest, fled into their home. The subject eventually was arrested without incident.



# NOTABLE WEEKLY CALLS

## MONDAY, JANUARY 18

**DEATH:** Officers performed a welfare check and located deceased subject who had passed away due to natural causes. Officers assisted in notifying next of kin and securing care for the animals in the home.

**THEFT:** Subject advised that their vehicle was broken in to overnight. Incident is under investigation.

## TUESDAY, JANUARY 19

**JUVENILE PROTECTION:** Child abuse was reported by medical professionals at a local hospital. The incident is under investigation.

**THEFT:** Subject advised their purse had been stolen from their vehicle the night before, and fraudulent activity had occurred on their credit cards. Incident remains under investigation.

**MENTAL:** Subject was suicidal and attempted to overdose. Officers assisted and transported the subject from the hospital to a treatment facility.

## WEDNESDAY, JANUARY 20

**THEFT:** Two businesses reported thefts in two unrelated incidents. Suspects were identified.

**WELFARE:** A subject appeared to be struggling after admitting to a neighbor that they had used marijuana. Subject refused police and EMS assistance and later went to a hotel where they created a disturbance. Subject again refused police and EMS assistance and agreed to stay at the hotel and cease the disorderly behavior for the night.

## THURSDAY, JANUARY 21

**ASSAULT & BATTERY/DRUG:** An altercation took place at a hotel. Upon investigation it was revealed that another party was in possession of methamphetamine, and that a child may have been exposed. One arrest was made; the subsequent incident is still under investigation.

## THURSDAY, JANUARY 21 CONTINUED

**JUVENILE DISORDERLY CONDUCT:** Officers responded to three different incidents in which juveniles were disorderly. Juveniles were all counseled on their behavior.

## FRIDAY, JANUARY 22

**BURGLARY:** A caller advised that someone was attempting to break in to their house. Officers arrived and detained a subject; the subject was familiar to the caller and counseled at the caller's request.

**FRAUD:** Four reports of fraudulent activity from individuals and businesses.

**OPERATING WHILE INTOXICATED:** Received a call of a driver with an open intoxicant in the drive through of a business. Officers were initially unable to locate the vehicle. A report came in of a subject behaving erratically at a gas station who had hit another car, which turned out to be the same subject from the earlier report. Subject was arrested.

## SATURDAY, JANUARY 23

**OPERATING WHILE INTOXICATED:** Officers observed a vehicle not stop at a stop light. Subsequent investigation revealed the driver to be driving while under the influence of intoxicants. Operator was arrested.

**THEFT:** Officers investigated a report of felony shoplifting at a business. A suspect was identified and a warrant requested.

## SUNDAY, JANUARY 24

**DOMESTIC:** Officers responded to two domestic incidents. Both incidents were resolved.

**WELFARE:** Multiple calls regarding the same subject. Subject has a history of drug and mental health issues that contribute to erratic behavior.



# NOTABLE WEEKLY CALLS

## MONDAY, JANUARY 25

**DOMESTIC-** An argument escalated between family members, with one individual throwing household items at the others. The individual was arrested.

**HARASSMENT-** A subject reported receiving harassing text messages that threatened his life. This is currently under investigation.

## TUESDAY, JANUARY 26

**DISORDERLY:** Officers interacted with the same subject five separate times throughout the day and night. Subject's behavior stems from drug and mental health issues.

**JUVENILE PROTECTION:** Officers investigated a report of child abuse. Investigation is ongoing.

**DOMESTIC-** Officers responded to a home as a caller requested to have someone removed from the home. Upon arrival, they learned that an argument and altercation had occurred. An individual was arrested.

## WEDNESDAY, JANUARY 27

**WELFARE:** Officers responded to a welfare check on an individual who had had a zip tie placed around their neck by another subject. Subsequent investigation revealed the incident stemmed from an incident that took place in Eau Claire. Information was passed along to Eau Claire PD.

**THEFT:** Officers took a report of theft of a catalytic converter. Investigation is ongoing.

## THURSDAY, JANUARY 28

**TRAFFIC ACCIDENT WITH INJURY:** Officers responded to a multi-vehicle accident. Officers processed the accident while completing traffic control, and assisted those involved.

## THURSDAY, JANUARY 28 CONTINUED

**MENTAL:** Officers responded to a call of a suicidal subject in the process of harming themselves. Officers convinced the subject to drop their weapon so that it was safe for the Menomonie Fire Department to provide aid. The subject was transported to a hospital for treatment and an emergency detention.

## FRIDAY, JANUARY 29

**THEFT:** Report of a theft of money from an unlocked vehicle.

**TRAFFIC ACCIDENT:** Officers investigated three separate traffic accidents.

**JUVENILE PROTECTION:** Officers investigated four separate reports concerning possible child abuse.

## SATURDAY, JANUARY 30

**OWI:** Officers observed a vehicle not stop for a stoplight and deviate from the lane of travel. Open intoxicants were observed in the vehicle. Driver was arrested.

**THEFT:** Report of a theft from a business. Subject was later apprehended.

**DOMESTIC:** Officers responded to a report of a domestic in progress that stemmed from a disagreement. One subject was arrested.

## SUNDAY, JANUARY 31

**BURGLARY:** Officers responded to a report of a burglary that had occurred over the weekend.

**MENTAL:** Officers were dispatched to a call involving a subject who was intoxicated and threatening suicide. Subject was taken to the hospital where officers remained to assist.



# NOTABLE WEEKLY CALLS

## MONDAY, FEBRUARY 1

**THEFT:** Officers responded to a theft complaint. Complainant believed items had been taken by an acquaintance. Incident remains under investigation.

**JUVENILE PROTECTION:** Officers received a report of possible child neglect. Investigation is ongoing.

**ASSAULT & BATTERY:** Officers responded to a report of a person who had possibly been hit by a car. Subject received medical treatment and the incident remains under investigation.

## TUESDAY, FEBRUARY 2

**MENTAL:** Officers responded to a report of a subject who was having an anxiety attack and suicidal ideations. Subject was evaluated by medical professionals and a safety plan was put in place with Northwest Connections.

**DISORDERLY:** Officers received a call of a subject running around with their pants down in public. Officers responded and the subject was cited.

**THEFT:** Two subjects were detained at a business for retail theft. One subject was transported to Chippewa County for a bail jumping warrant.

## WEDNESDAY, FEBRUARY 3

**JUVENILE PROTECTION:** Two separate incidents of reported sexual assault were investigated.

**JUVENILE DISORDERLY CONDUCT:** Two incidents of juvenile disorderly conduct were investigated and resolved.

**MOTOR VEHICLE THEFT:** Officers received a report of a motor vehicle theft. The caller advised that the vehicle was stolen by an acquaintance. Officers were unable to initially apprehend the subject but subject was later summoned and faces multiple charges.

## THURSDAY, FEBRUARY 4

**DOMESTIC:** Officers responded to a domestic incident. One subject was arrested.

## THURSDAY, FEBRUARY 4 CONTINUED

**TRAFFIC ACCIDENT:** Officers responded to two traffic accidents within the city limits: one in which a semi struck a light pole, and the other in which a vehicle collided with a snow plow.

**MENTAL:** Officers responded to a call indicating a subject may be suicidal. Officers made contact with the subject and worked with Northwest Connections to set up a safety plan.

## FRIDAY, FEBRUARY 5

**DOMESTIC:** Officers responded to two reported domestic incidents within the city limits. In one incident, a subject was arrested. Officers also provided mutual aid for a domestic incident which was taking place in the county.

**THEFT:** Officers took a report of employee theft from a local gas station. Subject was cited.

**MENTAL:** Officers responded to a call of a subject with suicidal ideations. Officers worked with Northwest Connections to put a safety plan in place.

## SATURDAY, FEBRUARY 6

**THEFT:** Officers were dispatched to a store where a theft was in progress. They made contact with the subject who was subsequently arrested and cited.

**MOTOR VEHICLE THEFT:** Subject reported that their vehicle was stolen overnight. Incident remains under investigation.

**SUSPICION:** A local hotel called dispatch and requested two of its occupants be removed by law enforcement. Upon arrival officers found one of the subjects had an active warrant; drugs and drug paraphernalia were also located. Both subjects were arrested.

## SUNDAY, FEBRUARY 7

**DOMESTIC:** Officers responded to a gas station following a report of a domestic situation. After interviewing the parties involved, one subject was arrested.



# NOTABLE WEEKLY CALLS

## MONDAY, FEBRUARY 8

**HARASSMENT:** Officers investigated two reported incidents of harassment. Options were provided and incidents were documented.

**JUVENILE PROTECTION:** Several juveniles were counseled for sending inappropriate pictures.

## TUESDAY, FEBRUARY 9

**TRAFFIC ACCIDENTS:** Officers responded to four traffic accidents throughout the day.

**MOTARIST ASSIST:** Officers assisted three different motarists throughout the day.

**THEFT:** Officers investigated a report of theft of an ATV and a snowmobile. Both items were later recovered.

## WEDNESDAY, FEBRUARY 10

**MENTAL:** Officers performed a welfare check on a subject who had disclosed suicidal ideations to an acquaintance. Officers worked with Northwest Connections and Dunn County Human Services to create a safety plan.

## THURSDAY, FEBRUARY 11

**MOTOR VEHICLE THEFT:** Officers received a report of stolen vehicles from a business.

**WELFARE:** Officers conducted welfare checks on two different individuals. Both subjects were found to be OK.

## FRIDAY, FEBRUARY 12

**TRAFFIC ACCIDENT:** Officers assisted with a one-vehicle accident in which the vehicle left the road and went through a fence.

## SATURDAY, FEBRUARY 13

**DOMESTIC:** Officers responded to a reported domestic incident. Parties were involved in a verbal argument.

**WELFARE:** Officers completed four welfare checks on different individuals throughout the course of the day and night.

## SUNDAY, FEBRUARY 14

**OWI:** A vehicle was observed crossing the center line while driving. After investigation, the operator was arrested for OWI-3rd.

**ASSAULT & BATTERY:** Officers responded to a report of an unconscious male who had been pushed down some stairs. The male was transported via EMS. After investigating the incident, a subject was arrested.

**MENTAL:** Officers responded to a call of an argument that had resulted in someone possibly being cut with a knife. Upon arrival it was learned that a subject had been having suicidal ideations, and other members of the family had intervened. Officers conferred with Northwest Connections and determined that a voluntary commitment would be the best option.



# NOTABLE WEEKLY CALLS

## MONDAY, FEBRUARY 15

**DISORDERLY CONDUCT:** Officers were called to a report of a large fight. Charges were referred.

**SUSPICION:** Two neighboring individuals reported seeing a subject near their homes. Incident remains under investigation.

## TUESDAY, FEBRUARY 16

**TRAFFIC ACCIDENT:** Officers responded to a three-vehicle accident. One operator received a citation; another operator faces OAR charges and had a valid warrant that they were notified of.

**FRAUD:** Officers received a complaint of identity theft and fraud from a financial institution. Upon investigation, it was learned that the same person was arrested a few weeks prior for attempting to open a bank account with a different agency in Minnesota- also while posing as a different person. The subject faces multiple charges.

## WEDNESDAY, FEBRUARY 17

**DOMESTIC:** Officers responded to a reported verbal domestic that had occurred while subjects were driving.

**DISORDERLY CONDUCT:** Officers responded for two disorderly conduct incidents. One incident occurred at a hotel and involved a verbal dispute between parties.

## THURSDAY, FEBRUARY 18

**WELFARE CHECK:** Officers performed a welfare check on a subject with suicidal ideations. The subject was put in contact with Northwest Connections and a safety plan was put in place.

**CRIMINAL DAMAGE:** Officers received a report of criminal damage from an individual whose tires had been slashed the night before.

**JUVENILE PROTECTION:** Officers received two different reports of juveniles who had viewed inappropriate materials.

## FRIDAY, FEBRUARY 19

**ASSAULT & BATTERY:** Officers responded to a 911 hangup call. Upon arrival they found one party leaving the scene, who became disorderly. Subsequent investigation detailed that this party had assaulted another party. The individual was arrested and faces multiple charges.

## SATURDAY, FEBRUARY 20

**THEFT:** Officers investigated three unrelated theft complaints.

## SUNDAY, FEBRUARY 21

**DISORDERLY CONDUCT:** An altercation took place at a local establishment. Parties were separated and no further action was requested.

**MENTAL:** A subject called to report being a victim of previous childhood abuse. An officer met with the subject and provided information on how to proceed with filing a report and submitting statements.



# NOTABLE WEEKLY CALLS

## MONDAY, FEBRUARY 22

**DOMESTIC:** Officers were dispatched to a residence after neighbors heard loud noises. One party had left the scene prior to officer arrival. Officers spoke with the party on scene and Wisconsin State Patrol assisted with locating the second party.

## TUESDAY, FEBRUARY 23

**ACCIDENT:** Officers responded to an EMS call in which a subject collapsed while walking outside. Officers performed CPR and rendered aid until medical help arrived.

**JUVENILE PROTECTION:** Officers took two reports of juvenile sexual assault.

**THEFT:** Officers received a report of a catalytic converter theft. The incident remains under investigation.

## WEDNESDAY, FEBRUARY 24

**TRAFFIC ACCIDENT:** A witness called dispatch to report an accident, and observed the driver of the vehicle leave the scene. Officers located the operator, contacted the Menomonie Fire Department for medical assistance and are investigating the accident. Wisconsin State Patrol is investigating the potential of an OWI.

**THEFT:** Officers received a report of another catalytic converter theft.

## THURSDAY, FEBRUARY 25

**DOMESTIC:** A domestic incident was reported that had occurred the night before. Officers investigated and referred charges to the DA.

**THEFT:** Officers responded to a theft complaint at a local financial institution in which money from a subject's wallet was stolen after it was left on a counter. This incident remains under investigation.

## FRIDAY, FEBRUARY 26

**SUSPICION:** Officers received a report of suspicious activity in which it appeared that someone had made entry in to a residence. Officers arrived to find a door partially ajar, and due to the nature of the reported activity entered and cleared the home of any potential intruders. While no one was located, officers found that a pipe had burst and water was flooding the home. Officers contacted the Water Department and Excel Energy for assistance, and contact was made with the homeowner.

**DOMESTIC:** Officers responded to reports of a possible verbal domestic situation. Officers spoke with the parties involved.

## SATURDAY, FEBRUARY 27

**ACCIDENT:** A citizen contacted dispatch to report a subject shivering outside in need of assistance. Officers located the subject, who had slipped and partially fallen through some ice on Lake Menomin. Officers assisted with transporting the subject to a local healthcare institution for evaluation.

**DOMESTIC:** Officers responded to a reported domestic situation in progress in which two subjects were arguing over family matters. Upon arrival officers spoke with both parties. Information from this incident was passed on to the DA for consideration along with Dunn County Human Services and Probation & Parole.

## SUNDAY, FEBRUARY 28

**DISORDERLY CONDUCT:** A subject called dispatch requesting officers remove a disorderly subject from their residence. Upon arrival the subject continued their disorderly behavior and attempted to re-enter the residence. The subject was subsequently arrested.



# NOTABLE WEEKLY CALLS

## MONDAY, MARCH 1

**FRAUD:** A subject reported being a victim of fraud. The subject had sent nude photos via a dating app; they subsequently received a message demanding money and threatening to post the nude images publicly if the subject did not comply.

**THEFT:** Officers received a report of a theft of money from a vehicle. Incident remains under investigation.

## TUESDAY, MARCH 2

**THEFT:** Officers received a report of a theft from an unlocked vehicle. Investigation is ongoing.

## WEDNESDAY, MARCH 3

**OWI:** Officers received a call of a vehicle that had been parked in a drive thru for more than ten minutes. Upon arrival, officers found the operator passed out in the driver's seat with the car still in drive and their foot on the brake. Officers were able to position their vehicles in front of the car to prevent an accident in the event that the operator awoke and removed their foot from the brake. After waking the operator and conducting field sobriety tests, the operator was arrested.

**INEBRIATE CONTACT:** Officers were dispatched to a report of a heavily intoxicated subject that nearly fell in to oncoming traffic multiple times. Officers ensured that the subject was safely transported to their home, and the subject will be summoned for bail jumping and obstruction.

## THURSDAY, MARCH 4

**DOMESTIC:** Two separate domestic incidents were reported. Both were verbal in nature.

**JUVENILE PROTECTION:** Officers investigated a reported juvenile sexual assault.

## FRIDAY, MARCH 5

**JUVENILE PROTECTION:** Officers investigated two reports of juvenile sexual assault.

**DOMESTIC:** Following an argument, a subject was reported to have stabbed themselves in the face with a screwdriver. Officers responded and found that the subject had fled. They face several charges regarding the domestic incident.

## SATURDAY, MARCH 6

**OWI:** Officers responded to a report of a vehicle striking a parked car. Upon investigation, officers found that the vehicle's operator was intoxicated. The operator was arrested.

**TRESPASSING:** Officers received a delayed report of an unknown subject in a residence. The occupant had arrived home on 3/5 and discovered an unknown subject in their home. The subject fled. Case remains open.

**DISORDERLY CONDUCT:** Officers had multiple contacts with the same intoxicated & disorderly individual. After a hotel requested officers remove the intoxicated subject from their premises, officers assisted the subject with transportation to another hotel. The subject then began to harass staff members at the second location. Officers assisted the subject in transportation to a facility in Eau Claire. Later, a driver from a taxi company contacted dispatch and advised that the subject was drinking in their cab against their wishes and had passed out in the taxi. The subject was taken to a medical facility for evaluation due to their intoxication level. They were subsequently arrested and face several charges.

**TRAFFIC ACCIDENT WITH INJURY:** A single vehicle accident occurred, with the vehicle striking a tree. Upon arrival, officers found no occupants but observed blood in the vehicle indicating that an injury had occurred with the accident. After checking the vehicle registration, officers were able to make contact with the vehicle occupants at their residence. Both vehicle occupants face several citations.

## SUNDAY, MARCH 7

**MENTAL:** A family member reported that a subject was in need of mental health treatment and had harmed themselves. Officers conferred with Northwest Connections, who sent a mobile crisis worker to assist onscene to assist with evaluation and safety planning.

**CRIMINAL DAMAGE:** Officers observed a subject rolling around in the street. Upon interacting with the subject, they learned that the subject was under the influence of methamphetamine. Due to being under the influence of drugs, an officer accompanied the subject who was transported to a medical facility for evaluation. During the initial contact, it was reported that the subject had punched holes in the wall of an apartment prior to fleeing and being found in the road. The subject faces several charges.





# NOTABLE WEEKLY CALLS

## MONDAY, MARCH 8

**JUVENILE PROTECTION:** Officers investigated two reports of the same juvenile running away. The juvenile was located both times. Later in the day, the juvenile became disorderly and destructive. Officers counseled them on their behavior.

**JUVENILE DISORDERLY CONDUCT:** Officers responded to a report of a juvenile who was disorderly and had thrown a household item at a family member. They worked with the family to put a safety plan for the child in place.

## TUESDAY, MARCH 9

**JUVENILE DISORDERLY CONDUCT/WELFARE CHECK:** Officers responded multiple times to the same family in which a juvenile was being disorderly but did not meet criteria for law enforcement action or an emergency detention. Dunn County Human Services and Northwest Connections were consulted throughout the contacts.

**TRAFFIC ACCIDENT:** Officers responded when a bus was rear-ended by another vehicle.

## ASSIST ANOTHER AGENCY/TRAFFIC

**ACCIDENT/OWI:** Officers assisted when a suspect from an incident in another city was reported to be driving dangerously and erratically, nearing the city limits. Shortly after entering the city, the suspect hit another vehicle and fled. The subject was later apprehended and found to have been operating the vehicle while intoxicated. The subject was arrested and faces multiple charges.

## WEDNESDAY, MARCH 10

**THEFT:** Multiple theft reports were received; two from gas stations and two from individuals.

**JUVENILE DISORDERLY CONDUCT:** Officers responded to a fight in progress at the Menomonie Middle School. The fight was dissolved and a juvenile is being referred.

## THURSDAY, MARCH 11

**SUSPICION:** Dispatch received a call reporting a possible burglary in progress. Upon arrival, an officer observed two individuals in a driveway operating power tools. Both subjects fled upon officer arrival. Investigation is ongoing

## THURSDAY, MARCH 11 CONTINUED

**DOMESTIC:** Officers responded to a domestic in progress. Upon arrival they heard two parties arguing and observed significant property damage. One subject was arrested and faces multiple charges.

## FRIDAY, MARCH 12

**ACCIDENT:** A motorist informed an officer that they had just witnessed a subject fall from their bicycle and strike their head. The subject was transported to a medical facility.

**DOMESTIC:** Officers were dispatched to a residence when a subject called dispatch and advised that a domestic incident had occurred following an argument. Information was forwarded to the DA's office for consideration.

**DRUG:** Officers responded to a report of a subject outside of a residence who was yelling and throwing items. Prior to officer arrival the subject had fallen, striking their head, and when officers arrived they heard screaming coming from the area of the residence. The subject had been the one screaming and was speaking incoherently. Officers learned that the subject was under the influence of LSD. The subject was transported for medical evaluation and a second subject will be receiving citations for drug possession.

## SATURDAY, MARCH 13

**DOMESTIC:** A subject called and advised of a domestic incident that had occurred between the subject and their partner. Upon officer arrival, the partner fled and ran through several yards in an attempt to evade officers. Officers were able to apprehend the partner, who was arrested and faces several charges.

**JUVENILE DISORDERLY CONDUCT:** Officers responded to five different incidents of juvenile disorderly conduct. Three incidents involved the same juveniles.

## SUNDAY, MARCH 14

**DOMESTIC:** A reported domestic incident occurred when two subjects began to argue while out downtown. Officers spoke with both parties and the situation was resolved.

**HARASSMENT:** Officers investigated two reported cases of harassment.

**DISORDERLY CONDUCT:** Officers responded to three reported incidents of disorderly conduct.



# NOTABLE WEEKLY CALLS

## MONDAY, MARCH 15

**TRAFFIC ACCIDENT:** Officers responded to three traffic accidents and one hit-and-run.

**MENTAL:** Officers were dispatched to a call in which a subject was intoxicated and making suicidal statements. A safety plan was established after conferring with Northwest Connections.

## TUESDAY, MARCH 16

**SUSPICION/BURGLARY:** A subject reported a burglary that had occurred prior. After investigation, a suspect was identified. Around the same time, officers responded to a report of suspicious activity. They found several subjects to be in possession of drugs, paraphernalia and weapons. Two subjects were arrested, and the other subjects face citations. One of the subjects arrested was linked to the burglary and faces several additional charges related to the burglary.

**DOMESTIC:** Officers responded to a domestic in progress. Following an argument, two parties had escalated resulting in one party causing significant property damage. One subject was arrested.

## WEDNESDAY, MARCH 17

**THEFT & FRAUD:** Officers responded to two complaints of theft and one fraud complaint.

**DISORDERLY CONDUCT/DOMESTIC (on 3/18):** An intoxicated male was observed trying to light his pants on fire in the middle of the road. That situation was resolved without incident. Later in the night, officers were dispatched to a domestic incident involving the same subject and another party. The intoxicated subject caused significant property damage and attempted to sexually assault the other party in the home. The subject was arrested and faces multiple charges.

**DISORDERLY CONDUCT:** Officers were dispatched to a report of a disorderly incident that took place at a local truck stop and involved multiple parties. The parties were separated and counseled on their actions.

**MENTAL:** Officers were dispatched to a report of an intoxicated male who was possibly suicidal. Officers conferred with the subject and Northwest Connections to establish a safety plan.

## SUNDAY, MARCH 21

**DOMESTIC:** Officers responded to a reported domestic violence incident. Following an argument between two adults, one of the adults pushed the other adult's child and then the other adult. The first adult was arrested and faces multiple charges.

## TUESDAY, APRIL 13

**MENTAL:** Dispatch received a mental call in which a subject had attempted to overdose by intentionally ingesting prescription medication. The subject was transported to a medical facility where the subject went on to make additional suicidal statements. Northwest Connections authorized a Chapter 51 Emergency Detention and the subject was taken to a facility for treatment.

**JUVENILE DISORDERLY CONDUCT:** A juvenile was being destructive and had broken a window inside of the facility, which led to a request for law enforcement assistance. Officers were able to calm them down and apprised Human Services of the situation. The juvenile is being referred for several charges.

**FIRE:** Officers responded for a structure fire at an apartment complex and worked to ensure that all residents were out of the building and accounted for. Officers then conducted a brief investigation into the cause of the fire and made sure all displaced residents had suitable resources.

## WEDNESDAY, APRIL 14

**WARRANT:** Officers observed a subject that they knew to have an active warrant walking in the downtown area. Upon making contact with the subject, the subject fled on foot and ran in to traffic. Officers were eventually able to make contact with the subject, who was also found to be in possession of drug paraphernalia and faces additional charges.

**TRESPASSING:** A landlord called to report a suspicious vehicle and two subjects they did not recognize outside their rental property, which was supposed to be vacant. The subjects were found to have tampered with a vehicle on the property and received several citations. One subject was arrested for a valid St. Croix County warrant.

## SUNDAY, APRIL 18

**TRAFFIC ACCIDENT:** Officers responded to two accidents throughout the course of the day.



# NOTABLE WEEKLY CALLS

**INEBRIATE CONTACT:** Dispatch received a call of an activated fire alarm. Upon arrival, officers located an extremely intoxicated subject in the basement. The subject was assessed by MFD and released to a friend.

**DISORDERLY CONDUCT:** Officers responded to a report of a family dispute where an ex-spouse would not leave the premises. Upon investigation, officers learned that there was a dispute in which a teenage subject did not want to move residences, as they had been sexually assaulted at the residence in the past. Information was passed along to Dunn County Human Services.

After a physical altercation occurred, the subject was able to call law enforcement who arrived and arrested the individual who had been at the residence. That individual faces multiple charges.

**TRAFFIC:** Officers investigated a report of a school bus passing violation. A witness was able to provide information that allowed officers to identify the incident vehicle and driver, and after confirming with the bus company the driver received several citations.

Upon officer arrival, they found that the party with the gun had been disarmed. Officers located the firearm and spoke with both parties. The party with the gun faces several charges.

**THEFT:** Officers investigated two separate theft complaints throughout the day. One incident involved a subject issuing a worthless check for the purchase of lawn equipment. ## FRIDAY, APRIL 23

Officers located the first subject, who also had a valid warrant out for their arrest, and took the subject in to custody. The subject faces multiple felony charges.

## SUNDAY, APRIL 25

**SUSPICION:** Officers responded to a report of an underage party taking place at a residence. Approximately 50 underage persons were located at the party. The host faces a furnishing citation.

**DOMESTIC:** Officers were dispatched to a location when an anonymous caller advised that they could hear yelling and banging. Upon investigation, officers found that a subject had slapped a cat and hit it multiple times with a club. The subject was cited for mistreatment of animals and the cat was taken to the vet by another subject.





# NOTABLE WEEKLY CALLS

## MONDAY, APRIL 26

**THEFT:** Officers received a report of a theft of a catalytic converter from a vehicle that had been parked at a school. Incident remains under investigation.

**DOMESTIC:** A subject reported a physical domestic incident that had happened previously within the city limits. After investigating, officers located and arrested a subject, who faces multiple charges.

## TUESDAY, APRIL 27

**MENTAL:** Officers located a vehicle in a city park after hours. Upon investigation officers found that the lone vehicle occupant was having thoughts of self harm and had pulled over in the park to call their therapist. The subject had materials they had intended to use to self-harm and asked the officers to dispose of them. Northwest Connections was contacted and notified of the incident.

**THEFT:** Officers responded for a retail theft in progress. Two subjects were identified as being involved. After investigating, one subject was arrested and faces multiple charges. A second subject received an ordinance violation citation.

## WEDNESDAY, APRIL 28

**OWI:** An officer observed a vehicle not stop for a flashing red light while traveling at a high rate of speed. The driver then failed field sobriety testing. They were arrested for OWI-2nd and face multiple charges.

**TRAFFIC:** Officers investigated three hit and run complaints, one accident without injury, and assisted two motorists throughout the day.

## THURSDAY, APRIL 29

**OWI:** Officers observed a vehicle proceed through an intersection with flashing red lights without stopping. When officers attempted to make a traffic stop, the vehicle crossed the center line, then swerved back and nearly hit a parked vehicle. **MENTAL:** Officers responded to a mental complaint where a subject made comments of self harm and had left the residence on foot. The subject eventually returned home, and officers conferred with Northwest Connections and the subject to create a safety plan.

## SATURDAY, MAY 1

**THEFT:** A caller reported that the catalytic converter had been stolen from their child's vehicle. Incident remains under investigation.

## SUNDAY, MAY 2

**OWI:** Officers conducted a traffic stop after observing a vehicle driving without headlights on in the early hours of the morning. Officers detected the odor of intoxicants and marijuana coming from the driver, who failed field sobriety tests. Officers located drug paraphernalia and the operator was arrested.

**DOMESTIC:** A caller advised of hearing screaming behind their apartment. Officers arrived on scene and found that a verbal argument had occurred between a boyfriend and a girlfriend. The parties were separated for the rest of the evening.



# NOTABLE WEEKLY CALLS

**FRAUD:** Officers received two reports of fraudulent bills that had been passed at businesses. Incident remains under investigation.

**MENTAL:** A subject cut their arm with a knife after getting into a disagreement with a family member. The subject was transported to a medical facility by EMS. Officers conferred with a behavioral health liaison and Northwest Connections and created a safety plan.

## TUESDAY, MAY 4

**DOMESTIC:** Officers responded to a domestic incident. Passersby observed two subjects arguing in a parking lot. Upon arrival, officers discovered broken glass from a car window. One subject was arrested.

**MENTAL:** Officers responded to a report of a subject who was possibly having a mental health crisis in a business. When officers arrived, they discovered the subject in a “prayer pose” on the floor. The subject told officers that they “needed to repent” several times. EMS arrived to medically evaluate the subject and officers learned that the subject had a mental health and chemical dependency commitment order for a hospital in another city. After speaking with behavioral health staff, officers provided a courtesy ride to the hospital for the subject.

## WEDNESDAY, MAY 5

**DOMESTIC:** After being dispatched to the report of a disorderly incident at a local motel, officers located the suspect. The suspect had left the motel to find an ex-partner and struck them. The suspect was arrested and faces multiple charges.

## THURSDAY, MAY 6

**DOMESTIC:** Officers were dispatched to a domestic in progress at a gas station. Officers were initially unable to locate the vehicle where the domestic was reported to have occurred. Shortly after, officers were notified of a subject at a local hotel. The subject advised they had gotten into a fight with their partner, who had left them in the area without cash or a phone. Officers provided the subject with a hotel voucher and they were transported to a hotel for the night.

**ANIMAL:** Officers were notified that a subject had two large dogs off leash in a park that requires dogs to be leashed. This subject had been issued citations on two other occasions this year for the same infraction. The subject will receive additional citations.

## FRIDAY, MAY 7

**DOMESTIC:** Officers were dispatched to a report of a physical altercation between partners. It was found that one partner was highly intoxicated and had struck the other partner. They were transported to a hospital for chest pain and right shoulder pain. While at the hospital, they made statements about self harm and harm to others. Officers called North West Connections, who assessed the situation and advised that it was OK to transport the subject to jail after they were medically cleared. The subject faces multiple charges.

**DRUG:** Officers responded to a suspicion call a gas station. Staff reported finding a bag of what appeared to be drugs that a subject dropped while paying at the counter. Officers reviewed surveillance footage and identified a vehicle, which they later located in the city. Officers made contact with the vehicle’s owner, who was found to be staying with a subject who had a warrant out for their arrest. Officers found large amounts of methamphetamine and paraphernalia with both subjects. Both subjects were arrested and face multiple charges.

**DISORDERLY CONDUCT:** Officers were dispatched to a disorderly conduct complaint at a business. A subject was walking through the parking lot swinging their arms at customers and had a large knife on their belt. The subject advised that they were intoxicated and admitted to having smoked marijuana earlier. The subject faces disorderly conduct and bail jumping charges.

## SATURDAY, MAY 8

**FIRE:** Officers responded to two house fires throughout the day. In the early morning, officers utilized the fire extinguisher to attempt to put out the flames until the Menomonie Fire Department arrived onscene. Later in the evening, officers were dispatched to a report of another house fire but due to the severity of the fire officers were unable to approach the residence. When the MFD arrived, they entered the residence and did not locate anyone inside. The owner of the property and tenants were contacted and advised of the fire.

## SUNDAY, MAY 9

**JUVENILE PROTECTION:** An complainant reported four children had been left unattended in a vehicle in the parking lot of a business. Their parent was paged in the business twice and returned to the vehicle. The parent was counseled on the dangers and possible legal consequences of leaving children unattended in a vehicle.



# NOTABLE WEEKLY CALLS

## MONDAY, MAY 10

**DOMESTIC:** Two subjects were involved in two incidents where one subject struck the other during an argument. The subjects were separated for the evening and one faces possible charges.

**EMS:** Officers responded to an EMS call in which a subject was unresponsive in a residence. Upon arrival, officers began chest compressions and administered a dose of Narcan upon learning of the subject's drug use. The Menomonie Fire Department arrived and officers continued chest compressions while the MFD began medical treatment, until the MFD advised that a pulse had returned. The subject was transported to a local hospital for treatment.

## TUESDAY, MAY 11

**MOTOR VEHICLE THEFT:** A rental vehicle was stolen from a gas station in the early hours of the morning two days prior. The renter reported it to law enforcement on May 11, and advised that they believed it had been stolen by an acquaintance they had been with that evening. Incident remains under investigation.

**TRAFFIC ACCIDENT:** Officers responded to a report of a vehicle that had driven through the front of a building. Officers assisted at the crash scene.

## WEDNESDAY, MAY 12

**WARRANT:** Officers located a subject with two valid felony warrants out for their arrest. Upon arresting the subject, they discovered methamphetamine in the subject's possession. Subject was arrested.

## THURSDAY, MAY 13

**OWI:** Officers were dispatched to a report of a subject who was intoxicated and passed out in a running vehicle. Upon arrival, in addition to the conditions described in the initial report officers observed an open intoxicant in the vehicle. The subject failed the field sobriety testing, and was charged with OWI-1st.

## FRIDAY, MAY 14

**DOMESTIC:** Officers responded to a domestic dispute in which two subjects had been in an argument and one subject damaged the property of the other. The second subject disclosed an additional domestic incident that had been previously unreported, in which the first subject kicked a door in and physically assaulted the other subject. They face multiple charges

## SATURDAY, MAY 15

**ATTEMPT TO LOCATE:** Officers responded to a subject who was attempting to locate their spouse, who had left after becoming upset earlier in the day. While officers were speaking with the subject, the spouse called the subject and an officer was able to speak with them on the phone and verify their welfare, though the spouse did not disclose their location. The spouse later made phone contact with an officer and advised they were at a hotel, but did not specify which one.

**OWI:** Officer conducted a traffic stop on a vehicle for operating without headlights during the hours of darkness. During the contact, several indicators led the officer to suspect possible impairment of the operator. An OWI investigation ensued. It was determined through the investigation that the operator of the vehicle was too impaired to be operating a motor vehicle. The operator was arrested for OWI 1st.

## SUNDAY, MAY 16

**ATTEMPT TO LOCATE:** Officers were notified by WI State Patrol of a high speed chase occurring on I-94. The vehicle reached speeds of nearly 100 mph and was suspected to have been stolen by a possibly impaired driver. As the pursuit neared the city limits, mutual aid was requested and officers set up spike strips on the exit to try to prevent the vehicle from entering the city. The vehicle exited and the spike strip deployment was successful. The vehicle continued back on to the interstate where the vehicle crashed in to a tree not long after. Officers aware then able to successfully took the operator in to custody and obtain medical assistance for the operator.

**MENTAL:** Officers responded to a report of a subject who was attempting to commit suicide by jumping off of a bridge. A family member and a bystander prevented the subject from jumping, and officers had to physically remove the subject when they arrived. The subject was taken in to protective custody and transported a medical facility to be evaluated and for treatment.

**ASSIST ANOTHER AGENCY (also 5/17):** Officers received a report of a missing juvenile from another city who was reported to have been dropped off in Menomonie. Subsequent investigation in partnership with the agency, DCI and the FBI resulted in the juvenile being safely located.



# NOTABLE WEEKLY CALLS

## MONDAY, MAY 17

**ASSIST ANOTHER AGENCY:** (Carried over from 5/16). Officers received a report of a missing juvenile from another city who was reported to have been dropped off in Menomonie. Subsequent investigation in partnership with other agencies resulted in the juvenile being safely located.

**TRAFFIC ACCIDENT- NO INJURY:** A subject accidentally drove their vehicle through the wall of a building. No one was injured and officers assisted at the scene.

## TUESDAY, MAY 18

**INEBRIATE CONTACT:** Officers received a report of an assault & battery that had occurred. The subject denied needing medical assistance. Upon officer arrival, they found that the subject was heavily intoxicated, could not say what had occurred other than they “had been jumped” and could not provide a description of the suspects. Officers were able to locate the subject’s missing property on a nearby sidewalk and the subject was satisfied with that outcome.

## WEDNESDAY, MAY 19

**THEFT:** Officers received a theft report in which a subject reported \$10,000 stolen from their residence in the early morning hours by an acquaintance. Upon investigation, officers found evidence that the two had arranged to meet and the theft victim had intended to meet and sell prescription medication to the other subject. It was also determined that the subject violated their probation by leaving another city in Wisconsin. Officers found non-prescribed pills that were individually bagged in the subject’s abandoned property behind a hotel. After obtaining a search warrant, they located additional drugs and the missing money. Both subjects face charges.

**ASSIST ANOTHER AGENCY:** A MPD Investigator and Dunn County Investigator were completing a drive by of a residence when they observed a subject retrieve a hatchet from a vehicle and run towards other subjects in the residence with the hatchet overhead in a threatening manner. The Investigators requested assistance and pursued the individual into the residence where they found two injured individuals. The subject dropped their weapon and was arrested, along with another subject. Multiple MPD units and units from other area agencies responded to assist.

## THURSDAY, MAY 20

**JUVENILE PROTECTION:** Officers responded to a local hospital for a report of a young child who had shown evidence of possible abuse. Officers gathered statements and collected photographs to share with the agency in the jurisdiction where the abuse would have taken place.

## FRIDAY, MAY 21

**TRAFFIC ACCIDENT:** A witness reported that a vehicle had crashed in to a residence. The witness was heavily intoxicated but was able to point officers to a residence in which a vehicle with heavy front end damage was located, which matched damage to side of the front porch of the residence. The registered owner of the vehicle was not located. This incident remains under investigation.

**BURGLARY:** Officers responded to a burglary in which subjects had money taken from their bedrooms. Officers found evidence that someone may have gained entry to the residence through a window. Officers were able to take DNA swabs in an attempt to identify a potential suspect. Incident remains under investigation.

## SATURDAY, MAY 22

**WARRANT/DRUG:** Officers made contact with a subject who had a valid warrant for their arrest. Officers located and identified marijuana, methamphetamine and paraphernalia in the subject's vehicle. The subject faces multiple charges.

**DOMESTIC:** Dispatch received a domestic complaint in which two subjects had gotten in to an argument at a local hotel. The subjects exited the hotel, and one subject pulled out a knife and threatened to kill the other. The other subject was able to go back inside and was assisted by the staff, who contacted law enforcement. The subject with the knife was arrested and faces multiple charges.

## SUNDAY, MAY 23

**DOMESTIC:** Officers responded to a hotel, where staff advised of receiving multiple noise complaints about items being thrown, yelling and stomping coming from a room. It was reported that witnesses had heard a subject ask another subject if they could breathe, and believed that the subject may have been being choked. Officers found one of the subjects to have red marks on their neck and after further investigation one subject was arrested.



# NOTABLE WEEKLY CALLS

## MONDAY, MAY 24

**FRAUD:** Officers took three separate reports of fraudulent activity throughout the course of the day. Behavior ranged from credit card fraud to identity theft.

**JUVENILE DISORDERLY CONDUCT:** Officers were dispatched to a report of a juvenile being disorderly and causing damage to property. Upon arrival, officers learned that the juvenile was in an argument with a family member which led to the destructive behavior. After the juvenile had calmed down, it was agreed that they could stay with another family member for the remainder of the night.

## TUESDAY, MAY 25

**TRAFFIC:** Officers received a report of a school bus violation in which a vehicle had passed a bus that had been stopped with its stop arm out while its lights were flashing. The operator received a citation.

**ANIMAL:** Officers received a report of possible animal abuse in which two dogs from the same household had been significantly injured in recent months. The dogs were removed from the household and investigation is ongoing.

## WEDNESDAY, MAY 26

**SEXUAL MISCONDUCT:** A juvenile flagged down an officer to advise that an individual had exposed themselves while walking on the bike trail. Officers searched the area and did not find anyone matching the description.

**MENTAL:** Officers responded to a local bar after an individual made comments that were suicidal in nature. Officers met with the subject and conferred with Northwest Connections to create a safety plan.

## THURSDAY, MAY 27

**MENTAL:** Officers received a call of a possible suicidal person. Officers provided a variety of service options and the call was resolved without further incident.

## FRIDAY, MAY 28

**ACCIDENT:** A subject was traveling to work via bicycle when they fell off and struck their head. A witness called 911, and officers and medical personnel responded to evaluate the subject. The subject was found to be heavily intoxicated and was transported to a medical facility for evaluation.

## FRIDAY, MAY 28 CONTINUED

**MENTAL:** Officers responded to an incident in which a resident at a group home had tied a shoelace around their neck and had barricaded themselves under a blanket. The resident was transported to a medical facility where a mental health evaluation took place. A safety plan was put in place with staff at the group home and the resident was transported back to the group home without incident.

## SATURDAY, MAY 29

**MENTAL:** Officers received a report from a citizen concerned an individual was going to jump into traffic to cause harm. Upon inquiry officers learned the individual was experiencing mental health issues. Officers worked with the individual's family to receive the appropriate care.

## SUNDAY, MAY 30

**OWI:** Officers observed a vehicle swerving while driving. Officers conducted a traffic stop and noticed several indicators that the operator may be intoxicated. The operator subsequently failed the field sobriety tests and their breath test registered as more than twice the legal limit. The operator was arrested for OWI-2nd.

**MENTAL:** Officers responded to an altercation involving a parent and a child. In the altercation, the child broke a window and was bleeding from the arm. The child was transported to a medical facility. The parent advised that the child had made comments of self harm and not wanting to be alive anymore. A mental health evaluation was done on the child, and a protective placement Chapter 51 was approved. The child was transported to a behavioral health facility.

**ASSIST ANOTHER AGENCY:** Officers were advised of a vehicle pursuit that was heading towards the city. The pursuit occurred after a subject fled a traffic stop, and at one point prior had grabbed a State trooper's taser. The vehicle was reported to be traveling in excess of 100 miles per hour and had encountered a successful spike strip deployment prior to attempting to exit the Interstate. Officers had set up spike strips at the Interstate off ramps to deter the fleeing vehicle from entering the city, but the vehicle drove around them. The vehicle stopped on the I94 overpass, and MPD officers assisted State Patrol with a felony traffic stop. The subject was taken to a medical facility for evaluation, where officers remained on standby due to the subject's behavior.



# NOTABLE WEEKLY CALLS

## MONDAY, MAY 31

**THEFT:** A subject stole several bottles of cough syrup from a gas station and a customer was injured when they tried to prevent them from fleeing. Officers located the subject, and the subject was cited for retail theft.

## TUESDAY, JUNE 1

**SUSPICION:** Officers were dispatched to a report of two subjects who were acting like they were under the influence of drugs in front of a fire station. They arrived to find that both subjects had valid warrants out for their arrest. The subjects were subsequently arrested.

**JUVENILE DISORDERLY CONDUCT:** Two juveniles were in a physical fight causing injuries to one of them. One juvenile was referred for battery, and the other was warned for possession of alcohol and underage consumption.

## WEDNESDAY, JUNE 2

**SUSPICION:** Officers responded when an individual believed they may have located a human finger in Lake Menomin. Officers retrieved the item to test it as it was not immediately evident what the item was. It ultimately was found not to be a human finger.

## THURSDAY, JUNE 3

**DOMESTIC:** A complainant called dispatch and advised they could see and hear a subject breaking windows of a vehicle that was parked in a hotel parking lot. The subject left the scene prior to officer arrival. Officers arrived on scene and made contact with the victim. The subject was identified and arrested.

## FRIDAY, JUNE 4

**DOMESTIC:** On a 911 call, dispatch heard a subject saying they were being held hostage and another subject screaming before the line disconnected. Officers learned that a physical altercation had occurred. One subject was taken into custody and faces multiple charges.

**DISORDERLY CONDUCT:** Officers were dispatched to a possible domestic in progress. As officers arrived, they were approached by a juvenile, who was yelling and swearing, stating another individual pointed a firearm at them. The other individual, who was open carrying a firearm, said they heard the juvenile yelling that they were going to kill someone and thought someone was in danger. The situation was calmed down and information was forwarded to Dunn County Human Services.

## SATURDAY, JUNE 5

**OWI:** An officer observed a vehicle cross the center line while driving. The officer had to swerve to prevent the vehicle from hitting them head on. The officer conducted a traffic stop and observed multiple additional indicators that the operator was intoxicated, and the operator admitted to having consumed alcohol prior to driving. The operator failed field sobriety tests and blew more than three times the legal limit when officers administered a breathalyzer test. The operator was arrested for OWI-2nd.

**OWI:** A witness reported observing a vehicle leave the roadway at a high rate of speed. Upon officer arrival, they found that the vehicle had driven over an embankment and was located approximately 100 feet from the roadway, with its front end against a tree. The operator was uninjured. Based on indicators, officers administered field sobriety tests to the operator, who failed them. Drugs and paraphernalia were also located within the vehicle. The operator was arrested and faces multiple charges.

**DISORDERLY CONDUCT:** Officers were dispatched to a disorderly conduct complaint. A verbal altercation had occurred between several parties, with two parties using racial slurs toward another. Upon investigation, officers learned that both of the offending parties had active warrants for their arrest. The two parties were arrested and face multiple charges, including for disorderly conduct-hate crime.

**DISORDERLY CONDUCT:** Officers were dispatched to a business for a report of a subject that approached the caller, who was inside their vehicle, and began talking about marijuana. When the caller attempted to roll their window up, the subject reached into the vehicle, frightening the caller. Upon investigation it was learned that the subject, who appeared to be intoxicated, had a warrant out for their arrest. The subject was arrested and faces additional disorderly conduct charges.

## SUNDAY, JUNE 6

**JUVENILE RUNAWAY:** A juvenile with a recent history of running away from the group home where they are placed left the facility twice during the course of the day. Officers located the juvenile both times and assisted the juvenile to return to the facility.



# NOTABLE WEEKLY CALLS

## MONDAY, JUNE 7

**PROPERTY FOUND:** Officers were called when a subject located a large safe in the river while swimming. Officers assisted with transporting the safe to an alternate location and are investigating to determine if it is associated with any other cases.

**DISORDERLY CONDUCT:** Officers were dispatched to a disorderly incident between a parent and child. The parent was reported to have struck the child while riding in the car. The child did not have any injuries. Both parties were engaged in a verbal argument afterwards. They were separated for the evening and information was relayed to Dunn County Human Services.

**DOMESTIC:** Officers responded for a domestic incident that was not in progress. The caller reported that a subject had been bitten and struck in the face by another subject at their residence. While en route to the incident location, an officer located the suspect walking away from the area. The suspect was taken into custody for multiple warrants and faces multiple additional charges from the domestic incident.

## TUESDAY, JUNE 8

**DOMESTIC:** Officers responded to a domestic dispute at a group home between residents. Two subjects were in a verbal argument that became threatening, with one subject using racial slurs. One subject was arrested.

## WEDNESDAY, JUNE 9

**CRIMINAL DAMAGE:** A caller contacted dispatch and advised their ex-partner had smashed the windshield of their vehicle. The ex-partner had left the scene prior to law enforcement arrival and was in a different city. The ex-partner faces multiple charges.

## THURSDAY, JUNE 10

**MENTAL:** A parent reported that their adult child, who has multiple mental health diagnoses, was having a psychotic break and left the residence. The subject's family was concerned that they were a danger to themselves and others. Based on statements from the subject, reports from the family and an assessment completed by Northwest Connections, a decision was made to take the subject into protective custody, and the subject was transported to a medical facility.

## FRIDAY, JUNE 11

**MENTAL:** A subject was suicidal and was walking near the train tracks. The subject was transported to a medical facility for evaluation. After contacting the subject's guardian, an assessment was completed by NWC, Behavioral health nurse at Mayo Menomonie, and the subject's guardian. The subject and guardian agreed to seek voluntary treatment.

## SATURDAY, JUNE 12

**DOMESTIC:** Officers were dispatched to a motel for a report of a possible domestic disturbance in progress. A subject was located hiding under the bed in a room. The subject was a Huber inmate at the time and was transported back to the jail. The subject faces additional charges.

**WELFARE/DISORDERLY CONDUCT:** Officers were dispatched to a welfare check on a subject who had told a business they were recently admitted to the hospital and requested to use their phone. Later the same day, officers were dispatched to a subject attempting to enter a locked restaurant. In both instances, the subject identified themselves as a 17-year-old juvenile from another city who was stranded in Menomonie. Over the course of nearly two hours, officers contacted Human Services for options, attempted to contact the subject's friends and family, and also sent a TTY to Sawyer County to have their deputies stop out at a family member's home. The subject was ultimately found to have been posing as their brother, and in actuality was 27 years old and out on probation. Drugs and paraphernalia were also located. The subject was arrested.

## SUNDAY, JUNE 13

**DOMESTIC:** Dispatch received a call to report a domestic in progress, and could hear arguing in the background. A subject had arrived at their ex-partner's house looking for their children, and became disorderly when they were not there. The subject was arrested.

**THEFT:** Officers investigated a report of a theft that had occurred from a local nonprofit. Bags of furniture and clothing had been stolen, and the suspect was attempting to sell the items at a garage sale. The suspect was arrested and faces multiple charges.



# NOTABLE WEEKLY CALLS

## MONDAY, JUNE 14

**THEFT:** A car dealership reported having several catalytic converters stolen from their vehicles. Incident remains under investigation.

## TUESDAY, JUNE 15

**DOMESTIC:** Officers responded to a reported domestic incident in which a subject kicked their ex-partner's door in. A verbal altercation occurred and the subject left. Information was forwarded to the DA's office for consideration of potential charges.

## WEDNESDAY, JUNE 16

**MENTAL:** Officers responded to a reported overdose in which a subject had likely taken methamphetamine, marijuana, and consumed alcohol and was experiencing negative side effects. The subject was transported to a medical facility for evaluation.

**WEAPON:** A subject reported a fight between juveniles that would possibly take place on Saturday and involve weapons. Officers spoke with all parties involved and counseled the juveniles.

## THURSDAY, JUNE 17

**CRIMINAL DAMAGE:** Officers responded to a criminal damage complaint in which a vehicle had been damaged while its owner worked at a business. The window had been smashed and the center display unit had been removed. Earlier in the shift, the investigating officer took a crash report in which a subject had crashed their vehicle a short distance from where the criminal damage complaint took place. The officer observed the operator remove a center display unit from the vehicle after the crash. After additional investigation, the center display unit was located and a subject, the operator of the vehicle that was involved in the crash, was arrested.

**SEXUAL ASSAULT:** A subject reported that while shopping at a store, another subject had grabbed their buttocks and left the store. The subject reported it to the store, who contacted law enforcement later when the subject was in the store again, following women and taking pictures of their buttocks. The subject left prior to officer arrival. Incident remains under investigation.

**DOMESTIC:** Officers responded to a report of a domestic incident. Partners had been in an argument that became physical, with one party assaulting the other and leaving the scene prior to officer arrival. That party was arrested and faces multiple charges.

## FRIDAY, JUNE 18

**THEFT:** Officers received a report of a theft that had occurred from a business in which a customer had intentionally not scanned a watch while checking out before they left the store. The subject was successfully identified. Incident remains under investigation.

## SATURDAY, JUNE 19

**MENTAL:** Officers received a report of a subject who was hearing voices, causing them to consider harming themselves or others. The subject was not currently in crisis. Officers provided information on resources to the subject and their spouse.

**TRAFFIC ACCIDENT WITH INJURY:** Officers assisted Wisconsin State Patrol with two separate one-vehicle rollover accidents that occurred on I-94. One was located at mile marker 41 and the other was located at the exit 45 WB off ramp.

**DOMESTIC:** Dispatch received a call alerting law enforcement to a domestic in progress at a park between two parties. Bystanders observed one party scream and yell at another, and when one of the parties attempted to distance themselves from the other, the other party followed them and continued to scream at them. Bystanders heard scuffling and breaking glass, which prompted them to call law enforcement. Both parties were located and one was arrested and faces multiple charges.

## SUNDAY, JUNE 20

**CRIMINAL DAMAGE/OWI:** A subject lit another subject's camper on fire. This was witnessed by the camper's owner, who was able to put the fire out. The camper's owners were acquainted with the subject, who used to date their adult child. The subject was located driving and was found to be intoxicated. They were subsequently arrested.

**DISORDERLY CONDUCT:** Officers responded to a disorderly conduct complaint. A subject was upset that another subject's motorcycle was too loud, and began yelling at them and threatened to shoot the other subject's child. When speaking with officers, the first subject admitted to making the threat. Per the request of the victim, the first subject did not receive charges but officers counseled the subject on the severity of their words and the potential charges they could have received from the situation.





# NOTABLE WEEKLY CALLS

## MONDAY, JUNE 21

**MOTOR VEHICLE THEFT:** A vehicle was stolen from a dealership. This vehicle was used to drive to another dealership, where two additional vehicles were stolen. All vehicles have since been recovered. Incident remains under investigation.

**SUSPICION:** A subject stated that they had been thrown from a moving vehicle. Upon arrival officers found the subject to likely be under the influence of drugs with some injuries. The subject did not wish to provide additional information and was transported via ambulance to a hospital.

## TUESDAY, JUNE 22

**BURGLARY:** In the early hours of the morning, an alarm was triggered at a restaurant. Officers were unable to contact any key holders, but checked all of the doors and the building appeared to be secure with no signs of forced entry. The restaurant manager arrived later that morning to find that someone had entered through a window, stolen bottles of alcohol and damaged property inside. Security footage was reviewed and the suspect was identified as someone they had removed from the restaurant the day prior. Upon investigation the stolen bottles were located with the suspect's belongings. The suspect was arrested and faces multiple charges.

**TRAFFIC STOP:** A subject was soliciting people for money in the parking lot of City Hall. When confronted, the subject fled in a vehicle at a high rate of speed, striking a traffic sign. They failed to stop at a stop sign and drove the wrong way down a one-way street. This was observed by the Chief of Police, who initiated a traffic stop. The subject was a revoked driver and advised that the vehicle they were driving was not registered to them; additionally the license plate on the vehicle was actually registered to a different vehicle of theirs. The operator received multiple citations.

**DISORDERLY CONDUCT:** Officers were dispatched to a complaint of a subject saying racial slurs at a truck stop. The subject was a driver for a transportation company, and officers worked to identify them. Per the truck stop's request the subject was not charged, but they will be trespassed from the entire chain of truck stops.

## WEDNESDAY, JUNE 23

**FRAUD:** After matching with someone on a dating site, a subject sent and received nude photos. The subject then received a message from someone purporting to be the person's father, claiming the person was a minor and saying that they would not pursue criminal charges if the subject paid them money. The subject ultimately paid more than \$1,000 before realizing they had been the victim of a scam.

## THURSDAY, JUNE 24

**FRAUD:** A subject reported being targeted for a scam through an app. The subject was contacted several times by another person, who convinced the subject to send a video exposing themselves. The subject then received a subsequent call from another subject, claiming to have recorded that video. They demanded the subject send money or they would post the video to social media. The phone number that the subjects were using turned out to be an international number that traced back to Africa. The subject did not send money and was provided information on increasing their social media privacy.

## FRIDAY, JUNE 25

**DOMESTIC:** Officers were dispatched to a reported domestic incident. Two subjects had gotten into an argument that became physical, with one subject hitting the other in the head with a gun after the other subject had strangled them. One subject was transported to a hospital. The other was arrested. Information was sent to the DA's office to review for potential charges for the other subject.

**OWI:** After observing traffic violations, officers pulled over a vehicle and noticed the driver appeared to have glassy eyes and slurred speech. The driver admitted to having consumed alcohol prior to driving. The driver was cited for OWI-1st.

## SATURDAY, JUNE 26

**MENTAL:** Officers were dispatched to a report of a subject that stabbed themselves in the throat following an argument with their significant other. Officers secured the scene and the subject was transported to a hospital for medical and behavioral health treatment.

## SUNDAY, JUNE 27

**SEXUAL ASSAULT:** A subject reported having been sexually assaulted by an acquaintance. Incident remains under investigation.



# NOTABLE WEEKLY CALLS

## MONDAY, JUNE 28

**JUVENILE RUNAWAY:** Officers received a report of two juveniles who did not return home after visiting another city. Officers contacted other jurisdictions and the juveniles were ultimately located in another city.

## TUESDAY, JUNE 29

**FRAUD:** A subject reported losing their wallet at a store earlier in the day. The subject then noticed fraudulent charges on their credit card. The subject cancelled their credit card and contacted law enforcement. Incident remains under investigation.

## WEDNESDAY, JUNE 30

**JUVENILE DISORDERLY CONDUCT:** Officers were dispatched to a complaint of a disorderly juvenile. The juvenile was yelling profanities and becoming physical with other juveniles and staff members at the facility where they were located. Northwest Connections was contacted and a safety plan was made for the juvenile.

**DOMESTIC:** Officers were dispatched to a report of a domestic incident. The parties were separated upon officer arrival. Officers spoke with both parties and upon investigation learned that it had been physical. One party was arrested.

## THURSDAY, JULY 1

**ANIMAL:** Officers responded for an animal complaint in which a caller advised that a dog was barking very loudly. Officers located the dog and observed the dog to be very malnourished and timid. The Dunn County Human Society was contacted and the dog was taken there for further evaluation.

A friend of the subject had located a bag of unknown pills in the subject's possession. After further investigation, it was determined that the pills were MDMA or "Molly" and the subject may have ingested them. The subject was transported to a hospital for medical evaluation and was charged for possession of the narcotic.

## FRIDAY, JULY 2

**DOMESTIC:** Officers were dispatched when three family members engaged in a verbal altercation where they all threatened each other. The parties were separated for the evening and information was sent to the DA's office for review for potential charges.

## SATURDAY, JULY 3

**DRUG:** While conducting follow up on a case, officers observed several items of drug paraphernalia in a hotel room. One of the subjects they were speaking with was on probation so they were subject to an Act 79 search, where officers located large quantities of methamphetamine. They found evidence of selling drugs, large quantities of prescription pills and in total more than 75 grams of methamphetamine. Both subjects were arrested and face multiple charges.

**SUSPICION:** Officers conducted a traffic stop after observing a subject operating a vehicle with its lights off behind a business after closing hours. The operator provided false information and had a warrant out of a neighboring county for their arrest. The operator was arrested and faces multiple charges.

## SUNDAY, JULY 4

**DISORDERLY CONDUCT:** Officers received a report of a subject who had thrown fireworks at another subject's vehicle and engaged in other disorderly behavior. This caused a small dent in the vehicle. The subject faces disorderly conduct charges.

**SUSPICION:** Officers were dispatched to a gas station when a subject asked an employee to contact Law Enforcement. The subject was homeless and in need to a place to stay and get out of the heat. **JUVENILE DISORDERLY CONDUCT:** A subject called dispatch to advise that their foster child was becoming disorderly and had locked them out of the house and thrown things within the house. The juvenile was calmed down and agreed to be calm the rest of the night, and was able to stay at the residence.

**INEBRIATE CONTACT:** Officers were dispatched to a report of an unconscious intoxicated subject who was lying in the bathroom of a local bar. The subject was transported to a medical facility for evaluation and charged with bail jumping.

**DRUG:** Officers responded to a suspicion complaint and discovered two juveniles smoking marijuana in a vehicle. Officers conducted a probable cause search and in addition to the marijuana located items consistent with the sale of marijuana. The parents of both juveniles were informed; one juvenile received several citations and the other faces several charges.

**ASSAULT:** A subject contacted law enforcement to report that they had been assaulted outside of a bar following a game of pool. One subject was punched and kicked in the head. The subject and their partner had visible drug paraphernalia on the hotel bed and methamphetamine, THC, BHO, and multiple firearms in the room. Both subjects were arrested and face multiple charges.

**OWI:** Officers conducted a traffic stop after observing a vehicle fail to stop for a stop sign. The operator was under 21 and admitted to consuming alcohol. An open bottle of alcohol was located in the vehicle. The operator was arrested for OWI-1st.

**OWI:** Officers were dispatched to a report of a car accident. The caller reported finding a subject asleep at the wheel of a vehicle with heavy front end damage. Officers located the vehicle, which was parked horizontally in the middle of the roadway. Northwest Connections and the juvenile's social worker were contacted and a safety plan was established.

**DOMESTIC:** Officers were dispatched to a physical domestic. One party had been drinking and had assaulted the other, causing the other partner to become frightened and hide. The assaulting party was arrested and faces multiple charges.

**HARASSMENT:** Dispatch advised of a harassment complaint in which the complainant, who resides in Minnesota, and reported receiving threats from a subject that resides in Menomonie. The subject made threats to kill the complainant and the subject's ex-partner. The subject was located and arrested.

## TUESDAY, AUGUST 10

**MENTAL:** Officers responded to a report of a subject who made suicidal statements while speaking on the phone with Northwest Connections. Officers spoke to the subject who advised they did not have any current suicidal thoughts. A safety plan was set up for the subject and Northwest Connections to conduct a phone call meeting later in the evening. Later in the evening while on the scheduled phone meeting, the subject made statements of hearing voices and wanting to overdose. The subject was placed into protective custody under Chapter 51.

**VIOLATE RESTRAINING ORDER:** A subject reported receiving a phone call from a blocked number. The subject recognized the caller's voice and believed it to be an individual whom they have a restraining order against. Information was sent to the DA's office for review for potential charges.

**DISORDERLY CONDUCT:** A subject went into a business and proceeded to yell multiple profanities at an employee while recording the incident. This was witnessed by multiple other employees and the recording was posted to the subject's SnapChat after they left. The subject was charged with disorderly conduct.

**WELFARE:** Staff at a car dealership reported an elderly subject had walked into the dealership looking for their vehicle. The subject had parked their vehicle at a restaurant, eaten there, and had been unable to find their way back. The subject was confused and did not have any family or friends to contact. Officers provided the subject a ride back to their residence and contacted a neighbor who said they would assist in looking after the subject. Information was sent to the Dunn County Aging and Disability Resource Center (ADRC) for their follow-up considerations.

## FRIDAY, AUGUST 13

**OWI:** Officers observed a car speeding after screeching its tires while driving away from the downtown area. They made contact with the operator at a gas station and observed several cues leading them to believe that the driver was intoxicated. The operator admitted to having consumed alcohol and failed the field sobriety tests. They were subsequently arrested for OWI-1st.

**TRAFFIC ACCIDENT- FATALITY:** A citizen reported seeing a motorcycle tipped over in a parking lot. Upon officer arrival, they located an unresponsive subject nearby. Officers performed lifesaving measures until EMS arrived and determined that the subject was deceased.

**SUSPICION:** An employee advised that a subject was in their store and behaving strangely. Officers arrived and found that the subject was highly intoxicated, which is in violation of their felony bond. The subject blew a .324 breathalyzer and was transported to a medical facility for evaluation before being arrested for bail jumping.

**CRIMINAL DAMAGE:** Officers were dispatched to the report of a subject who had kicked in the back door to a downtown bar. The subject then climbed onto the roof of the bar, jumped over to the roof of another bar, then jumped on top of a dumpster before continuing on foot. Officers located the subject, who ran west from downtown into a marshy area. Additional officers from several agencies arrived to assist with apprehending the subject, who was arrested for and faces several charges.

## SUNDAY, AUGUST 15

**DEATH:** Officers responded to a report of an unresponsive subject, who was found to be deceased. Incident remains under investigation.

**TRAFFIC ACCIDENT:** Dispatch received calls when a vehicle vs moped accident occurred within the city. Officers responded to provide traffic control and determine the cause of the accident.

**JUVENILE SEXUAL ASSAULT:** Officers received a report of a juvenile sexual assault that previously occurred in the city. Investigation is ongoing.



# NOTABLE WEEKLY CALLS

## MONDAY, AUGUST 16

**ATTEMPT TO LOCATE:** Staff from a group home reported a subject was missing. Officers canvassed the area and sent out a Crime Alert via the Wisconsin Crime Alert Network. The subject ultimately returned to the facility on their own.

**DOMESTIC:** Officers responded to an apartment regarding a domestic incident. One subject advised they had been pushed into a wall by another subject, who was throwing several items within the apartment at a neighboring apartment door. The other subject was arrested and transported to the hospital for evaluation.

## TUESDAY, AUGUST 17

**SEXUAL MISCONDUCT:** Following a dispute about driving behavior, a subject pulled their shorts down to expose their full genitalia to another subject. Information was sent to the DA's office to review for potential charges.

## WEDNESDAY, AUGUST 18

**THEFT:** A subject advised of theft of prescription medication. They had left it in their vehicle while they went into a store for a few minutes, and returned to find it missing.

## THURSDAY, AUGUST 19

**WARRANT:** Officers were dispatched to the back side of a business for the report of a female who was bleeding. The subject informed officers that they had been assaulted by three subjects; however, they did not want to provide any information into who the assailants were. The subject had a warrant out of Barron County and was transported to a Barron County Deputy once they were medically cleared.

## FRIDAY, AUGUST 20

**MOTOR VEHICLE THEFT:** A subject reported their vehicle had been stolen. The vehicle had been left unlocked with a spare key inside. The vehicle was entered in NCIC as stolen and this case will be pending for further investigation. ## SATURDAY, AUGUST 21

**OWI:** Officers were walking downtown when they observed a pickup truck back into a parking kiosk. The operator admitted to drinking and submitted to field sobriety tests. The operator was subsequently arrested for OWI-1st.

**OWI:** Officers observed a vehicle spinning its tires and speeding away from downtown in the early hours of the morning. When an officer conducted a traffic stop, the operator of the vehicle refused to give their real name. The real identity of the operator was later identified. Several observations from the traffic stop led officers to believe the operator was under the influence of an intoxicant. The operator refused to participate in field sobriety exercises and was taken into custody for operating while under the influence 4th offense and resisting/obstructing an officer.

**INEBRIATE CONTACT:** Officers were dispatched to a Welfare check at a park as an individual had asked someone for a ride. The anonymous reporter stated that the individual looked intoxicated and wanted them checked on. The subject was found to be intoxicated and admitted to consuming intoxicants despite being out on an absolute sobriety bond condition. The subject's breathalyzer came in at .298 and they were arrested. Once in custody, the subject threatened to kill the arresting officer. The subject faces multiple charges.

## SUNDAY, AUGUST 22

**WELFARE:** Officers were dispatched to a follow up regarding a welfare check that day shift had attempted earlier in the day. A subject left a facility they had been placed at under Chapter 51 in a neighboring community. Officers made contact with the subject and Northwest Connections was contacted as well. There were no concerns for the subject's safety, they had plans to seek assistance later in the week and were working with Human Services, so it was determined that they were safe to remain at their home.





# NOTABLE WEEKLY CALLS

## MONDAY, AUGUST 23

**THEFT:** Officers received a report of a stolen catalytic converter. Incident remains under investigation.

## TUESDAY, AUGUST 24

**CRIMINAL DAMAGE:** A subject called and advised a vehicle had been vandalized. There were no cameras in the area, and the subject did not have any suspects at that time.

## WEDNESDAY, AUGUST 25

**SUSPICION:** Officers received a call from the Pierce County Sheriff's Department. They a juvenile had made statements indicating they had made several types of gas or pipe bombs. The juvenile had possibly told someone that they had taken a bomb to a facility in Menomonie on several occasions, but had not recalled bringing it inside. Officers contacted the facility who advised that there was no way anyone would be able to bring in something like a bomb to the facility. Upon a more in depth interview by a Pierce County Investigator, the juvenile indicated they had made a bomb in their home located in Pierce County, but had never brought anything like that to Menomonie.

**MENTAL:** A subject reported that they had hurt themselves badly and needed an ambulance. They also advised that they took medication in an attempt to overdose. Officers located the subject, who had several wounds on their body and rendered aid until MFD was able to arrive. The subject was transported to a medical facility for evaluation.

**MENTAL:** Officers were dispatched for a report of a person in a vehicle that was suicidal and might have a gun. Officers located the vehicle and identified the people involved. After investigation it was determined that the initial information provided proved not to be accurate. One subject remained in Menomonie to seek treatment for methamphetamine use and the other subject was given a taxi ride to Eau Claire to seek treatment for methamphetamine use / mental health issues.

**MENTAL:** Officers were dispatched to a welfare check on a subject who had made suicidal statements. Officers spoke with the subject and a safety plan was approved with Northwest Connections.

## THURSDAY, AUGUST 26

**ATTEMPT TO LOCATE:** A child was taken from a residence by their parent who no longer was their guardian. The child's guardian had not given permission for the parent to take the child and there was concern for the child's welfare. Many officers and deputies canvassed residences to search for the child and their parent. The parent called the guardian and returned the child and was subsequently arrested.

## FRIDAY, AUGUST 27

**DISORDERLY CONDUCT:** Officers responded to a hotel when a subject refused to leave. The subject was found to have a valid warrant and was arrested.

## SATURDAY, AUGUST 28

**DISORDERLY CONDUCT:** Officers were asked to stand by at a residence while a subject retrieved property from a family member and their significant other. Officers arrived to find the subject had taken custody of a cat who had blood on its head and nose. The subject's family member advised that they had observed the significant other chase the cat, hit and kick it, and attempt to stab it. The significant other was arrested and faces multiple charges.

**OWI:** Officers were dispatched to a suspicion complaint. The anonymous complainant advised there was a vehicle parked with a male in the backseat who appeared to be passing out. The driver was arrested for OWI 4th after filing Standardized Field Sobriety Tests.

**DOMESTIC:** A caller reported two partners got into a physical fight. One subject had since left the scene. The subject was found to be the predominant aggressor and was subsequently located and arrested.

## SUNDAY, AUGUST 29

**TRESPASSING:** A subject was found in a residence that was supposed to be vacant and listed for sale. The subject had moved in all of their belongings and had been living there for several days. Subject was removed from the property and summoned for criminal trespass to a dwelling.



# NOTABLE WEEKLY CALLS

## MONDAY, AUGUST 30

**DISORDERLY CONDUCT:** Officers were dispatched when a subject hit and punched staff at a treatment facility. The subject was arrested.

**MENTAL:** Officers were dispatched to a report of a suicidal subject. When officers arrived, they were able to secure the subject and contacted EMS to perform a medical evaluation. The subject disclosed a plan to attempt suicide by cop. The subject was transported to a medical facility for an emergency detention.

## TUESDAY, AUGUST 31

**SEXUAL ASSAULT:** Officers received a report of a sexual assault that had occurred when a subject touched another subject inappropriately at a business. The subject was arrested.

## WEDNESDAY, SEPTEMBER 1

**DOMESTIC:** Officers were dispatched to a physical domestic disturbance. A subject was arrested and faces several charges. Northwest Connections was contacted and a safety plan was established for another subject. During the police investigation a third subject interfered with two separate times and faces charges for disorderly conduct and obstructing an officer.

**OWI:** While on patrol, officers heard a vehicle loudly rev their engine multiple times and accelerate at a high rate of speed near the downtown area. **MENTAL:** MPD officers were asked to check for a subject who was believed to be suicidal. The subject was located, and a mental health evaluation was conducted. It was determined that the subject was a risk to themselves and was taken to a medical facility for an emergency detention.

**DOMESTIC:** Officers were dispatched to a domestic incident in progress. Officers spoke with two subjects who both stated that another subject scratched them, drawing blood. The subject was transported to a medical facility due to their level of intoxication. An officer rode along to assist with the transport. En route to the facility, the spouse became combative and spit on the officer. The subject faces multiple charges.

**OWI:** While on bike patrol, officers observed a vehicle park and the operator exit with an alcoholic container. The operator was under 21 and admitted to having six beers prior to operating the vehicle. The operator was also found to be in possession of cocaine. They were arrested and face multiple charges.

## SUNDAY, AUGUST 29

**OWI:** Officers conducted two separate OWI investigations. In both instances, the operator was found to be intoxicated and was arrested.

**DOMESTIC:** Officers were dispatched when a couple engaged in a loud verbal argument. One party broke the other party's laptop and became disorderly during the altercation. The party was subsequently arrested and faces multiple charges.

**SUSPICION:** Officers responded to a report of a subject who was acting suspiciously outside of a business. Upon investigation they learned that the subject was highly intoxicated and had been sleeping underneath a parked vehicle in the parking lot. The subject was arrested on a probation hold.

**DOMESTIC:** Officers were dispatched for a report of possible physical domestic. While arguing over parenting a shared child, one partner admitted to slapping the other in the face. Information was sent to the DA's office to review for consideration of charges.

The caller reported hearing someone in the residence and came out of a room to find that their wallet was missing. The caller's roommate also was missing their wallet. Neither of the parties observed the suspect.

**SUSPICION:** Officers were dispatched to a call of a small child who had been located without their parents. While officers were with the child, dispatched received a call regarding a child who had wandered away and was reunited with their parent.

**MENTAL:** Officers were dispatched to a report of a juvenile that had razor blades in their possession. The juvenile told officers they were very stressed out and was transported to a medical facility to be medically cleared. A safety plan for the juvenile was approved with Northwest Connections as well as the medical facility.

## SATURDAY, SEPTEMBER 18

**DOMESTIC:** An individual in a gas station parking lot advised officers that there was a subject crying at another gas station. Officers located the subject and their partner, who were in an argument. Officers spoke with both subjects and advised them to remain separated for the night.

## SUNDAY, SEPTEMBER 19

**MENTAL:** Officers were dispatched to a medical facility for a report of a disorderly patient who was hitting staff. Due to the patient's mental health needs it was determined that the patient met the criteria for a Chapter 51 Emergency Detention.

**ATTEMPT TO LOCATE:** Officers were dispatched to a report of a missing juvenile. The juvenile was scheduled to arrive on a bus in Eau Claire after traveling from Chicago and was not located or able to be reached. After checking multiple resources and reaching out to agencies in Chicago, the juvenile called to advise that they were safe and had not gotten on the bus.



# NOTABLE WEEKLY CALLS

## MONDAY, SEPTEMBER 20

**MENTAL:** Officers responded to a report of a subject who was threatening their life and others within the room. Officers contacted Northwest Connections and brought the subject to a medical facility for a mental health evaluation. A Chapter 51 was approved and the subject was transported to a medical facility.

## TUESDAY, SEPTEMBER 21

**CRIMINAL DAMAGE:** Dispatch advised officers of a criminal damage complaint in which a subject took a bat to the side of another subject's vehicle. The subjects were acquainted with each other, and the victim advised that there had been an ongoing dispute due to them dating the ex-partner of the other subject. **OWI:** Officers observed a vehicle driving without a front license plate. Upon conducting a traffic stop, they smelled the odor of marijuana and located marijuana within the vehicle. The operator admitted to having used it and failed field sobriety tests. **ASSIST OTHER AGENCY:** Officers assisted when a high-speed chase on I-94 ended at mile marker 47 and the suspect was not cooperative. The subjects were not local and had been traveling to a city on the other side of the state. The subject was transported to a medical facility.

## WEDNESDAY, SEPTEMBER 29

**JUVENILE DISORDERLY CONDUCT:** Officers were contacted when a middle school student became disorderly and school staff was unable to control them. The student had threatened staff with scissors, prompting law enforcement involvement. Officers were able to locate the student's parent and transport them to the student's location.

One party confronted the other about damaging their vehicle, and the other party took out pepper spray and sprayed it. Information was relayed to the DA's office for consideration of charges.

**ASSAULT & BATTERY:** MPD Officers responded for a physical altercation that was occurring between an estimated 15-20 people. Upon investigation it was learned that a subject had been assaulted during the event and the suspects fled prior to law enforcement arrival. Officers have identified a suspect and the incident remains under investigation.

**DISORDERLY CONDUCT:** Officers were dispatched to a report of a disturbance at a local bar. A subject who had created a disturbance was asked to leave by staff. The subject pulled out a knife and began pointing it at witnesses and claimed "someone was going to get murdered today". The subject fled the scene prior to officer arrival, but was later located and arrested for disorderly conduct, second degree reckless endangerment to safety, terroristic threats, and misdemeanor bail jumping.



# NOTABLE WEEKLY CALLS

**DOMESTIC:** Officers were dispatched when two parties argued over household chores. One party went to the garage to retrieve a metal pipe, at which point a third party intervened. The party was charged with domestic disorderly conduct.

**SEXUAL ASSAULT:** Officers received a report of sexual assaults that had occurred previously. Investigation is ongoing.

## SATURDAY, OCTOBER 9

**OWI:** Officers observed a moped without tail lights being operated in the early hours of the morning. There was a passenger on the back of the moped in addition to the driver. The operator, who was under 21, admitted to having consumed alcohol earlier in the evening and blew a PBT of .10. The operator was cited for OWI-1st

**FRAUD:** A subject reported losing more than \$1,000 through a Coinbase account. There is no way to identify who the money was sent to. The victim planned to work with their bank to try to recover their lost funds.

## SUNDAY, OCTOBER 10

**OWI:** Officers conducted a traffic stop when a subject did not stop for a flashing red light. The subject failed field sobriety tests and was arrested and charged with OWI-2nd.

**WARRANT:** Officers responded to a report of a subject behaving erratically. The subject was arrested on a Pepin County warrant.

**TRAFFIC:** Officers were notified of a traffic violation in which a vehicle failed to stop for a stopped school bus. The registered owner was identified and received a citation.

## THURSDAY, OCTOBER 14

**TRAFFIC ACCIDENT- WITH INJURY:** Officers responded to a three-vehicle traffic accident. Officers assisted with traffic control and processing the accident.

## FRIDAY, OCTOBER 15

**TRAFFIC ACCIDENT:** Officers responded to three different traffic accidents throughout the day, none of which resulted in injury.

Officers made contact with the juvenile and their parent and explained possible options to them. Northwest Connections was also apprised of the situation.

## TUESDAY, OCTOBER 19

**WEAPONS VIOLATION:** Officers received a report that three individuals were intoxicated and handling firearms in a reckless or negligent manner. Officers responded and rendered the scene safe. All three were found to have consumed alcohol, and all three gave different versions of the events. All admitted to handling firearms after having consumed alcohol and were cited for city ordinance disorderly conduct.

## WEDNESDAY, OCTOBER 20

**MENTAL:** Officers responded to a report of a juvenile who had made some concerning suicidal comments. Officers were able to identify and locate the juvenile who had made the comments and conducted a mental health evaluation into the matter. The juvenile ultimately wanted to seek mental health treatment and was willing to voluntarily commit themselves to a behavioral health unit.

## THURSDAY, OCTOBER 21

**SEXUAL ASSAULT:** A subject reported being sexually assaulted. Following an investigation a subject was arrested and charged with sexual assault.

## FRIDAY, OCTOBER 22

**MENTAL:** MPD Officers responded for a report of a person who was having suicidal thoughts and had already self-harmed. Officers conducted a mental health evaluation. The person was later taken into protective custody under a Chapter 51.15 emergency detention and transported to a behavioral health facility.

## FRIDAY, OCTOBER 22 CONTINUED

**MOTOR VEHICLE THEFT:** A subject found that their motorcycle had been stolen. The motorcycle was entered as a stolen vehicle and information on the stolen motorcycle was sent to surrounding counties.

## SATURDAY, OCTOBER 23

**OWI:** Officers observed a vehicle fail to stop for flashing red lights. The occupants were speaking in a lethargic manner and admitted to having consumed alcohol prior. Officers conducted Standard Field Sobriety Tests (SFSTs), and the operator blew a PBT of .155. They were subsequently arrested for OWI-1st.

**DISORDERLY CONDUCT:** A subject was removed from a downtown bar by a bouncer. The subject became disorderly on several different occasions inside and outside the bar. They continuously yelled profanities and drew the attention of bystanders on the sidewalk. They were arrested for Disorderly Conduct and Misdemeanor Bail Jumping.

## SUNDAY, OCTOBER 24

**OWI:** Officers observed a vehicle travel through an intersection without stopping for the flashing red lights. Upon conducting a traffic stop, the occupants admitted to having consumed alcohol and an open intoxicant was observed in the vehicle. After failing SFSTs, the operator was arrested for OWI-1st.

**DOMESTIC:** A subject reported that a domestic incident had occurred and it was physical. Officers interviewed both parties and one party was arrested.

**MENTAL:** Officers responded to a report of a subject who was making suicidal statements. The subject agreed to go to a medical facility for evaluation, and officers assisted when they became disorderly at the facility. The subject met the criteria for a detention under a Chapter 51.15 hold.

**SUSPICION:** Officers were dispatched to a suspicion complaint where residents advised they saw a subject looking into their windows. Incident remains under investigation.



# NOTABLE WEEKLY CALLS

## MONDAY, OCTOBER 25

**THEFT:** A subject reported having their Social Security Card, Drivers license, and state insurance card stolen. Officers advised the victim to contact the Social Security Administration regarding the items.

## TUESDAY, OCTOBER 26

**OWI:** Officers observed a vehicle accelerate and travel at a high rate of speed downtown. After initiating a traffic stop, the operator admitted to having consumed alcohol prior to driving and had a canceled driver's license. They failed the Standard Field Sobriety Tests (SFSTs) and blew a PBT of .15. They were arrested for OWI-2nd.

**TRAFFIC:** Officers received two separate school bus passing reports. In one report, the bus driver physically prevented children from exiting the bus as a vehicle operator passed the bus illegally. Operators from both reports were cited.

**ASSAULT & BATTERY:** Officers were contacted regarding an assault and battery at a restaurant. Witnesses on scene provided a suspect vehicle registration plate, and contact was made with the owner who admitted to their family's involvement in the incident. Two juveniles were referred to Human Services for Disorderly Conduct and Battery.

## WEDNESDAY, OCTOBER 27

**SUSPICION:** Officers responded to a report of a subject stating they were bleeding internally and externally. The subject was transported to a medical facility.

**ASSIST ANOTHER AGENCY:** DUSO deputies received a report of a stolen vehicle. MPD officers located the stolen vehicle and its operator, who advised that they had a gun in their pocket. Officers were able to safely take the suspect into custody.

**MENTAL:** A subject called 911 and stated they were going to commit suicide via overdosing on alcohol and pills. They advised they had already taken the medications and had been drinking, and had self-harmed. The subject was transported to a medical facility. A safety plan was created with Northwest Connections.

## THURSDAY, OCTOBER 28

**ASSAULT & BATTERY:** Officers received a report of an assault & battery. An individual had gone to a residence to check on a friend. While at the residence, the friend's partner threatened the individual and prevented them from leaving. The subject was charged with 2nd degree recklessly endangering safety, false imprisonment, and felony bail jumping.

**THEFT:** Officers received a report of a vehicle window that had been smashed while the owner was shopping in a store. Items were taken from the vehicle.

## FRIDAY, OCTOBER 29

**THEFT:** Dispatch received reports of four vehicles that were broken into and valuables stolen while parked outside of an exercise facility. All of the vehicles had items missing. Investigation is ongoing.

**DOMESTIC:** Dispatch was notified of a verbal dispute between a couple. One party was arrested for domestic disorderly conduct.

## SATURDAY, OCTOBER 30

**ASSAULT & BATTERY:** Two subjects assaulted bouncers at a downtown bar. After investigating and reviewing video footage, officers arrested the subjects who both face multiple charges.

**DISORDERLY CONDUCT:** MPD was dispatched to a report of a disorderly person at a business. Staff advised that a subject had become belligerent after being refused the sale of alcohol, and then proceeded to urinate on flowers that were outside of the business. The subject left prior to law enforcement arrival. Investigation is ongoing.

## SUNDAY, OCTOBER 31

**MENTAL:** MPD and MFD were dispatched to a hotel for a report of a subject in crisis. The subject was highly intoxicated and eventually transported to a medical facility.

**DOMESTIC:** Officers responded when a subject contacted dispatch regarding a dispute with their partner. After investigating the situation, officers arrested the partner, who faces several charges.



# NOTABLE WEEKLY CALLS

## MONDAY, NOVEMBER 1

**CRIMINAL DAMAGE:** A business found that two of their locks had been damaged when someone tried to drill through them. The locks, while damaged, remained intact and nothing was stolen.

## TUESDAY, NOVEMBER 2

**DRUG ENDANGERED CHILDREN:** A caller informed dispatch that they had observed drug activity in their bathroom via a camera that they had placed in there previously. Their sibling, who was staying with them, was viewed with a substance that upon investigation tested positive for methamphetamine. The sibling was unaware of this camera, and a partially nude video of them was captured without their consent. Investigation is ongoing.

**HARASSMENT:** Officers received a complaint from a subject who had received harassing messages from an ex-partner. The messages were concerning and threatening in nature. The partner faces multiple charges.

**CRIMINAL DAMAGE:** A subject reported someone slashed a tire on their vehicle. There are no known witnesses at this time.

## WEDNESDAY, NOVEMBER 3

**TRAFFIC:** Officers received a report of a vehicle passing a school bus illegally. The operator was identified and received a citation.

## THURSDAY, NOVEMBER 4

**JUVENILE DISORDERLY CONDUCT:** Two juveniles were involved in a verbal and physical altercation while at the High School. One juvenile was cited for disorderly conduct.

## THURSDAY, NOVEMBER 4 CONTINUED

**MENTAL:** A subject reported that their sibling had harmed themselves. The sibling was not in need of medical attention, and had been stabilized by a parent. The sibling was left in the care of their parent under a safety plan after consultation and assessment with Northwest Connections.

## FRIDAY, NOVEMBER 5

**MENTAL:** Officers responded to a report of a client threatening an employee at a group home. Officers made contact with the client and conducted a mental health evaluation. A safety plan was developed between Northwest Connection and staff at the group home to have the client remain in the group home with a different employee.

## SATURDAY, NOVEMBER 6

**EMS:** Dispatch was alerted when a subject began choking while at a restaurant. Upon officer arrival, the subject did not have a pulse and was not breathing. Officers arrived onscene before EMS and began CPR. The subject's heartbeat returned and was transported to a medical facility.

## SUNDAY, NOVEMBER 7

**DRUG:** Officers observed a vehicle operating whose operator had a suspended drivers license. After initiating a traffic stop, officers observed drugs and drug paraphernalia in the vehicle. It was also discovered that the operator was in possession of a concealed gun without a concealed carry permit. The operator was arrested and faces several misdemeanor charges.



# NOTABLE WEEKLY CALLS

## MONDAY, NOVEMBER 8

**OWI:** Officers observed a driver swerve within their lane while driving, and noticed that the vehicle had a brake lamp that was out. Upon conducting a traffic stop, the operator failed Standard Field Sobriety Tests, blew a PBT of more than twice the legal limit and was arrested for OWI-1st.

## TUESDAY, NOVEMBER 9

**JUVENILE SEXUAL ASSAULT:** Officers received a report of a juvenile sexual assault. Investigation is ongoing.

**THEFT:** Two unrelated individual complaints of thefts from vehicles were reported. Officers provided resources and suggestions to both victims.

## WEDNESDAY, NOVEMBER 10

**OWI:** Officers were dispatched to a report of a subject passed out in a vehicle at a gas station. The operator came to and was found to have an open intoxicant in the vehicle. They failed SFSTs and blew a PBT of .188. They were arrested for OWI-1st.

**SEXUAL ASSAULT:** Officers received a report of a sexual assault. One subject was arrested and faces several charges.

**DISORDERLY CONDUCT:** Officers were dispatched to a disorderly incident in which a subject had become disorderly outside of a residence. The subject did not know the homeowner but objected to signage in their yard, and escalated to shouting profanities. The situation was resolved without incident.

## THURSDAY, NOVEMBER 11

**DRUG:** Officers conducted a traffic stop on a vehicle whose operator had a revoked driving status. Drugs were found in the vehicle and the passenger had multiple warrants for their arrest from other counties. The operator received a citation and the passenger was arrested and faces multiple charges.

## FRIDAY, NOVEMBER 12

**MENTAL:** A subject called 911 to report they were having thoughts of self harm. They were transported to a medical facility for evaluation.

**FRAUD:** A subject reported sending their identifying information to someone posing as a loan company. The subject was provided resources and advised to contact the Federal Trade Commission, Social Security Number Administration and their bank to make them aware of their compromised identity.

## SATURDAY, NOVEMBER 13

**OWI:** Officers noticed a car parked in a parking lot after hours. As they walked up to the vehicle, they noticed the operator appeared to be unconscious and was applying the brake with the vehicle still in drive. The officer repositioned their squad car in order to block the vehicle from crashing into the building if the operator released the brake when they awoke. Officers were able to put the vehicle in park and wake the operator by rubbing their sternum. The subject eventually woke up and failed SFSTs. They were arrested and charged with OWI-2nd.

## SUNDAY, NOVEMBER 14

**DOMESTIC:** Officers responded to a 911 hangup. Upon initial contact nothing suspicious appeared to be occurring. While officers were standing outside the residence about to leave, loud arguing and yelling could be heard from outside the residence. A domestic incident investigation ensued. One party was arrested for domestic disorderly conduct.

**OWI:** Officers responded to the jail when jail staff notified them that an intoxicated person had driven to the jail to pick up a current jail resident. Jail staff had this person submit to a PBT, and they blew over the legal limit. They failed SFSTs and were arrested for OWI-1st.

**DISORDERLY CONDUCT:** A subject reported that their child had been struck in the face by another juvenile. The juvenile was referred for charges.



# NOTABLE WEEKLY CALLS

## MONDAY, NOVEMBER 15

**BUSINESS BURGLARY:** Employees discovered a business had been broken into overnight. Two doors had been pried open with a crowbar which caused damage to both door frames. Money had been taken from the business. Investigation is ongoing.

## TUESDAY, NOVEMBER 16

**MENTAL:** Officers responded to a report of a subject who had threatened to kill themselves. Contact was made with the subject, who did not want to speak with Northwest Connections but sought out a provider on their own.

## WEDNESDAY, NOVEMBER 17

**EMS:** Officers were dispatched when a subject called 911 to report that they were injured. The subject had made suicidal comments to dispatch. The subject was heavily intoxicated and transported to a medical facility for treatment.

**OWI:** Officers conducted a traffic stop when a subject failed to stop for a red light. They observed the operator's eyes to be glassy and observed several other clues indicating the driver's potential intoxication. The operator failed Standard Field Sobriety Tests (SFSTs) and when given a PBT, blew a .25. They were arrested for OWI-1st.

## THURSDAY, NOVEMBER 18

**OWI:** Officers conducted a traffic stop when they noticed a vehicle operating without any head or tail lamps lit in the dark. The operator failed SFSTs and when a PBT was administered, blew a .15. They were arrested for OWI-1st.

**JUVENILE PROTECTION:** Dispatch was notified when a naked toddler knocked on the door of a residence. At the time of the call it was 30 degrees Fahrenheit. MPD has responded to multiple similar calls involving the same child in recent months. The child was reunited with their family and Dunn County Human Services was notified.

## THURSDAY, NOVEMBER 18 CONTINUED

**DOMESTIC:** A parent and juvenile had a verbal argument. During the argument the juvenile threw a large picture frame at the parent. Dunn County Human Services was contacted and arranged for the juvenile subject to stay with a different adult.

## FRIDAY, NOVEMBER 19

**THEFT:** While investigating another incident, officers learned that a subject had multiple stolen tablets in their possession. Investigation is ongoing.

## SATURDAY, NOVEMBER 20

**DOMESTIC:** Officers responded to a domestic incident in which one subject had hit another in the head with a frying pan. One subject was arrested.

**DOMESTIC:** Officers were called to a residence twice in the same evening. One resident suffers from dementia, and for the second incident, they became violent toward another resident. Dunn County Human Services was contacted and together with officers developed a plan to allow the resident to calm down and follow up with the resident the following day.

**MENTAL:** Officers were contacted when a subject called a helpline and advised that they planned to harm themselves. Officers made contact with the subject, who had cut their arm. Officers worked with the subject who agreed to seek voluntary treatment.

## SUNDAY, NOVEMBER 21

**ASSIST ANOTHER AGENCY:** Officers were dispatched to assist the Dunn County Sheriff's Office when a subject fled from a traffic stop and was believed to have a weapon. An MPD officer assisted in searching for the subject and, when located, taking them into custody without incident.

**DRUG:** Officers observed a subject who had a warrant out for their arrest. While taking the subject into custody, methamphetamine was located on the subject. The subject was arrested and faces additional charges for possession of methamphetamine.



# NOTABLE WEEKLY CALLS

## MONDAY, NOVEMBER 22

**MENTAL:** Dispatch received a report that a subject was overdosing on medication. The subject was transported to a medical facility for treatment and a safety plan was created.

## TUESDAY, NOVEMBER 23

**FIRE:** Officers responded to a report of a structure fire. Upon arrival, officers notified dispatch the structure was fully engulfed and power lines were down in the road. Officers observed a dog in the side yard, and a window exploded as they released the dog. The dog was safely secured in a vehicle and officers stood by as MFD put the fire out.

**WELFARE:** Officers assisted UW-Stout PD to conduct a check on the welfare of a subject in one of the dorms. Upon arrival, a subject was located without clothing and covered in blood. The subject was transported to a medical facility.

## WEDNESDAY, NOVEMBER 24

**SUSPICION:** A subject advised that their vehicle was broken into the night prior. Nothing was taken, though items were taken out of the glove box.

## THURSDAY, NOVEMBER 25

**DISORDERLY CONDUCT:** Officers responded to a disorderly incident. After investigating the incident, it was determined that one subject was the predominant aggressor. Methamphetamine was located in both of the subject's front pockets. The subject was arrested and faces multiple charges.

**EMS/WELFARE:** Officers responded to a hotel for an extremely intoxicated subject who requested to be taken to a hospital. MFD transported the subject to a medical facility. Later that evening, officers responded for the same subject back at the hotel who was laying on the floor due to their intoxication level. Officers verified the subject's welfare and determined that the subject was not a harm to themselves or others and just wanted to talk. They were provided information on Northwest Connections.

## FRIDAY, NOVEMBER 26

**THEFT:** A subject reported package theft that had occurred. The subject was able to be refunded for the lost items and prevention strategies were discussed.

## SATURDAY, NOVEMBER 27

**DOMESTIC:** Officers responded to two domestic incidents involving two different groups of people. Both incidents were verbal only in nature and did not meet criteria for an arrest.

## SUNDAY, NOVEMBER 28

**ASSAULT & BATTERY:** Officers responded to an EMS downtown. Officers learned that a subject had touched two individuals inappropriately which caused an argument. The subject threw a beer bottle at one individual striking them in the head and had to be restrained by patrons and staff. The individual was transported to a medical facility. The subject was arrested and faces several charges.

**DOMESTIC:** Officers were dispatched to a Domestic incident at a business in which a subject attempted to drag another subject through a parking lot. Officers located the subjects and learned that one subject had become very upset following the death of a family member. That subject was transported to a medical facility. One subject was cited for Possession of a Narcotic and the other was referred to the DA's office for Domestic Disorderly Conduct charges.

**DOMESTIC:** MPD Officers responded for a report of a domestic related incident in which an adult subject was throwing things around the residence and being physical with their parent. The subject was subsequently arrested.

**MENTAL:** Officers were dispatched to a residence for a report of an intoxicated subject who had cut off their pinkie toe with a butter knife. Upon arrival officers verified this to be true, and the subject advised officers that they had consumed their toe. The subject was transported by personal vehicle to a medical facility and a safety plan was put in place with Northwest Connections.



# NOTABLE WEEKLY CALLS

## MONDAY, NOVEMBER 29

**ASSAULT & BATTERY:** A subject reported being attacked in an alleyway by another individual. The individual was on probation, and due to the allegations of a physical incident Probation & Parole issued a warrant for the individual. They were taken into custody without incident.

## TUESDAY, NOVEMBER 30

**THEFT:** Officers responded to a report of a theft in progress at a store. Officers located the subject and learned that they had been released from jail in another state that morning. The subject was on their way to their home in a different state when they stopped and attempted to steal more than \$3,000 worth of items from the store. The subject was arrested for felony retail theft.

## WEDNESDAY, DECEMBER 1

**TRAFFIC STOP:** Officers attempted to stop a vehicle for several traffic violations. The vehicle did not stop. A deputy located the vehicle a short while later after it had crashed in the city. Three occupants were in the vehicle, and one became resistive with the deputy and fled on foot. Officers pursued the subject and ultimately located them when a hotel contacted law enforcement to advise that the subject had returned. The subject faces multiple charges.

## THURSDAY, DECEMBER 2

**THEFT:** Officers were alerted to theft that took place in a group home. An employee reported theft from residents and requested information be documented.

**FRAUD:** A subject reported suspicious bank activity. Options were discussed and the subject worked with the bank to reinstate the money they had lost.

## FRIDAY, DECEMBER 3

**SUSPICION:** Officers were alerted when an unknown intoxicated subject entered a residence and fell asleep on the couch. The subject received several citations.

**CRIMINAL DAMAGE:** Officers took a report from a city employee in another department of the tires on their vehicle, a former squad vehicle, being punctured.

## SATURDAY, DECEMBER 4

**MENTAL:** Officers performed a welfare check on a subject. After speaking with the subject and Northwest Connections, the subject was placed on a safety plan and was left in the care of a friend.

**DISORDERLY CONDUCT:** Officers were dispatched to a disorderly scene that involved possibly 5 subjects fighting in front of a bar. Officers learned that a confrontation resulted in one subject striking another in the face. The subject was under 21 and had been consuming alcohol. The subject received citations for disorderly conduct and underage consumption.

## SUNDAY, DECEMBER 5

**DISORDERLY CONDUCT:** Officers observed a physical fight downtown. A subject, who had thrown punches at others was tackled to the ground by several bar patrons outside. Officers detained the subject while another subject continued to argue with the bar patrons and swung a bag at the bouncer of the bar. Both subjects were heavily intoxicated and were cited for public intoxication.

**MENTAL:** Officers were dispatched when a subject made possibly suicidal statements. The subject was transported to a medical facility for evaluation and agreed to seek voluntary treatment.

**VEHICLE FIRE:** Officers responded when a vehicle was reported to be on fire. A second vehicle was ignited. Officers onscene assisted and provided traffic control and scene security.



# NOTABLE WEEKLY CALLS

## MONDAY, DECEMBER 6

**DRUG:** Officers located several individuals who were behaving suspiciously. They were found to be smoking marijuana. One subject was cited.

**SUSPICION:** A subject reported seeing someone look in to their windows and then run off. Officers did not locate the subject and were unable to locate any footprints or tracks in the snow where the individual had been.

## TUESDAY, DECEMBER 7

**DOMESTIC:** A third party reported a physical domestic incident between partners. After investigation both parties stated that the incident was verbal only in nature.

## WEDNESDAY, DECEMBER 8

**MENTAL:** Officers were dispatched to a mental health call for a subject who was harming themselves and "acting aggressive." The subject was transported to a medical facility where they were medically cleared and left in the care of a friend.

**DISORDERLY CONDUCT:** Officers were dispatched when a caller stated that someone was being stabbed with a fork by their adult sibling. Upon officer arrival the parties were separated and they were able to determine that no one had been stabbed. The parties were instructed to remain separated for the rest of the evening.

## THURSDAY, DECEMBER 9

**VIOLATE ORDER:** A subject reported that their adult child was at the residence and refused to leave, in violation of a bond condition. The adult child has five felony open bonds and faces several charges.

**MENTAL:** A welfare check was conducted on a subject who was possibly suicidal. The subject denied feeling that way and a safety plan was put in place for the subject to stay with a friend.

## FRIDAY, DECEMBER 10

**CRIMINAL DAMAGE:** Officers were dispatched to a criminal damage complaint involving two vehicles' tires being slashed. While investigating, two subjects interfered in the officer's investigation. Both subjects will receive charges, and the criminal damage investigation is ongoing.

## SATURDAY, DECEMBER 11

**OWI:** MPD was requested by UW-Stout PD to respond to the scene of a possible accident involving a vehicle that struck a light pole. After speaking with the operator of the vehicle, several clues led officers to believe the operator was under the influence of an intoxicant. The operator was put through field sobriety exercises and was ultimately taken into custody for OWI-1st.

**DOMESTIC:** Officers responded for a welfare check of an individual who had sent picture messages to their significant other of bruising on their arms. Following investigation a subject was subsequently arrested for several domestic related charges, along with bail jumping and a probation hold.

## SUNDAY, DECEMBER 12

**THEFT:** Officers were advised of a theft from a store when a subject pushed a cart out of the store that was full of unpaid merchandise. A subject was located at the scene and was in possession of the vehicle believed to have been used in the crime. The subject admitted they had been traveling with another individual. Also located with the vehicle were numerous items believed to have been stolen from another store. Property was returned to both stores. The two subjects were both arrested and face multiple charges.





# NOTABLE WEEKLY CALLS

## MONDAY, DECEMBER 13

**SUSPICION/SEXUAL ASSAULT:** A subject reported receiving a harassing phone call. Upon interviewing the subject, officers learned that a coworker was alleging the subject had sexually assaulted them. Investigation is ongoing.

## TUESDAY, DECEMBER 14

**DOMESTIC:** Officers responded to a reported domestic incident between partners. One partner had threatened the other, and the other partner locked the other partner outside during a dispute, and the other partner hit the door and windows repeatedly. They were arrested and face domestic disorderly conduct charges.

**DEATH:** Officers responded to two unrelated calls in which deceased subjects were located.

## WEDNESDAY, DECEMBER 15

**ASSAULT & BATTERY:** Officers were dispatched to a juvenile disorderly conduct complaint. A juvenile had been physically attacked while walking home from school by other juveniles. The other juveniles admitted to this and were referred for disorderly conduct.

**OWI:** Employees at a restaurant contacted law enforcement to report suspicions of an intoxicated driver in their drive-thru. Upon officer arrival, they made contact with the operator who gave several indicators that they were intoxicated. They failed field sobriety tests, blew a PBT of .15 and were arrested for OWI-1st.

**TRAFFIC ACCIDENT:** Officers responded to five traffic accidents throughout the day.

**STREET:** Officers received 8 calls pertaining to debris and trees down following the storm.

## THURSDAY, DECEMBER 16

**JUVENILE DISORDERLY:** A subject reported ongoing bullying of their child by another child, including making threats. The child was counseled by officers and school staff.

## FRIDAY, DECEMBER 17

**OWI:** Officers conducted a traffic stop when they observed a vehicle cross the center line. The driver failed Standard Field Sobriety Tests and was arrested for OWI-1st.

**MENTAL:** A subject advised a verbal argument at their residence had occurred, and their partner had left on foot and threatened suicide. The partner was ultimately located and had no intentions of committing suicide. The partner agreed to return home and to speak with a member from Northwest Connections via phone.

## SATURDAY, DECEMBER 18

**DOMESTIC:** Officers responded to a physical domestic incident. One subject was arrested.

**OWI:** A subject saw a vehicle nearly strike another vehicle while driving. The vehicle had struck another vehicle and when officers made contact with the operator they stated they had just given the other car "a love tap". The subject failed SFSTs and blew a PBT of .14. They were arrested for OWI-1st.

## SUNDAY, DECEMBER 19

**DRUG:** Officers responded when they received a complaint of subjects using drugs in a hotel. A subject admitted to having smoked marijuana and swallowing a small baggie of meth. Officers transported the subject to a medical facility for evaluation, and after being medically cleared the subject was transported to jail for multiple warrants.

**MENTAL:** A subject called Northwest Connections advising that they were having suicidal thoughts. Officers responded and transported the subject to a medical facility for a Chapter 51 evaluation.

**DOMESTIC:** Two subjects were involved in a verbal altercation while driving. Later in the evening, there was a civil standby while a subject collected belongings from the other subject's residence. Due to how uncooperative all subjects were, this took nearly two hours to resolve. Information was forwarded to the District Attorney's Office for their consideration of charges.



# NOTABLE WEEKLY CALLS

**ASSAULT & BATTERY:** An altercation between a resident and a staff member at a home health care facility was reported. Investigation is ongoing.

**OWI:** Officers located a running vehicle parked on the side of the road that appeared to have struck some property. The operator was placed through field sobriety exercises and was subsequently taken into custody for OWI-1st.

## TUESDAY, DECEMBER 21

**MENTAL:** Dispatch received a call from someone who was wishing to seek mental health treatment and threatened to harm officers if they arrived.
