

Open Container (5-1-3)

Fine Amount: \$175.30

- No open intoxicants allowed on any public street, alley or sidewalk

Public Intoxication (5-1-11)

Fine Amount: \$389.50

2nd offense w/in yr: \$641.50

- No person in a public place shall conduct him or herself in such a manner as to become intoxicated or incapacitated and to create a public nuisance

Prohibition of Public Urination, Defecation, Vomiting (5-1-12)

Fine amount: \$263.50

- No urination, defecation, or vomiting in any public place or on any private property not intended for such use

Noises Prohibited (5-1-6)

Fine Amount: \$263.50

2nd w/in yr: \$389.50

3rd w/in yr: \$515.50

- No unreasonably loud or excessive noise

City Parks Hours (7-4-1)

Fine amount: \$175.30

- All parks in the city are closed to the public between the hours of 10:00 P.M. through 7:00 A.M.

Recyclable and Nonrecyclable Material (4-1-4)

Fine Amount: \$150.10

- Garbage must be placed curbside
- Cannot be placed more than 24 hours before collection or 12 hours after collection

Residential Front Yard Parking (4-6-1)

Fine amount: \$15.00

2nd offense: \$25.00

- All vehicles must be parked on a driveway or parking pad authorized by the City Building Inspector

General Parking Restrictions (6-4-7)

Fine amount: \$15.00

2nd offense: \$25.00

- You cannot park on the street for a continuous period (24 hours or more)
- Seasonal Restrictions: 2:00 A.M. - 7:00 A.M. from November 1 to April 1, you must park on the odd side of the street on odd-numbered calendar days, and vice-versa. This is to facilitate snow removal

Pedestrian Crossing (6-1-4)

Fine Amount: \$162.70

- No pedestrian can cross a street or highway where there is a "no pedestrian crossing" sign

What are ordinances?

Ordinances are legislation enacted by a municipal authority. They are not meant to be invasive, and are meant to make the city of Menomonie an enjoyable place to live, work and visit.

Ordinances help to maintain the quality of life within a community by allowing citizens to work together to uphold similar standards when it comes to public health and safety. This allows the city to run smoothly and efficiently to help to protect the property value, health and best interests of all Menomonie residents.

Common ordinance violations

In-Line Skates & Play Vehicles (6-7-3) Bicycles (6-7-5)

Fine Amount: \$162.70

Wisconsin State Statute prohibits the use of skateboards & longboards on public roadways, including all streets or bicycle ways that are a part of a street in the City of Menomonie.

City of Menomonie ordinance prohibits the use of rollerblades, bicycles, skateboards, and longboards on sidewalks in the downtown business district. Specific areas include:

- **BROADWAY STREET** From vacated Wilson Avenue (UW-Stout PD building) to Crescent Street.
- **CRESCENT STREET** From Broadway to 4th Street East.
From 7th Street East to 9th Street East.
- **MAIN STREET** From Broadway Street to 9th Street East.
- **WILSON AVENUE** From 3rd Street East to 9th Street East.
- **2ND STREET EAST** From Main Street to its northern terminus.
- **3RD STREET EAST** From Wilson Avenue to Crescent Street.
- **4TH STREET EAST** From Wilson Avenue to Main Street.

**Exception: The UW-Stout pedestrian corridor that connects the North Campus to Main Campus is the only designated route where bicycles, rollerblades, longboards and skateboards are permitted to be used.*

Common ordinance violations cont'd

Burning Regulations (9-3-4)

Fine Amount: \$169.00

- Must be 25 feet from a structure
- Must be contained within a pit at least 10 inches deep or other container
- Flames no higher than 4 feet
- Must use only dry, untreated and unpainted clean wood.

Snow & Ice Removal (7-1-5)

Fine Amount: \$150.10

2nd offense w/in yr: \$162.70

- Must not deposit snow or ice onto city sidewalks or streets.
- Must clear sidewalks before 12:00 noon of the day following the end of the snowfall.

Improper Storage of Furniture (4-1-3)

Fine Amount: \$150.10

- No furniture not designed and intended for outdoor use can remain outdoors.

Excessive Lawn Height (5-1-4)

Fine Amount: \$200.50 (per day)

- Lawns must be shorter than 9 inches tall
