- 2) IF SAID PUPPY DIED WITHIN THIS CONTRACTS EFFECTIVE PERIOD, THE BUYER AGREES TO ASSUME FINANCIAL RESPONSIBILITY FOR AN NECROPSY ON SAID PUPPY, TO BE PERFORMED BY A LICENSED VETERINARIAN TO DETERMINE THE CAUSE OF DEATH.
