Open Forum:

- Patchwork on roadway

- Vereda Baja
 - O In addition to damage on Caminito San Lucas and El Trebol during the July 2018 flood, Vereda Baja saw some considerable damage and drainage problems with the culverts. Culverts are stopped up and overflowing. The culvert that runs along Richards Avenue is the City's responsibility; the culverts that run under Vereda Baja (between the two churches) are the homeowners' responsibility.
