- 1. Approval of minutes from 05/26/2022 regular meeting of the Board:
 - a. Keith moved to approve the minutes as presented.
 - i. Seconded Chris
 - ii. Unanimously approved.
- 2. HHC 2022 Summary Report and Review
 - a. Match went well with no significant problems.
 - i. All agreed 2-day event structure was a good thing and to continue.
 - b. Canopies were a good investment they will be stored at A-1 Agency (Joe)
 - c. Need to replace about 20 T-posts for 2023.
 - d. Practice day complicates things, not a real benefit.
 - i. Unanimous decision to cancel practice day in 2023.
 - e. Meals went well need to think ahead for HHC 2023.
 - i. Can look into having HHC 2023 awards banquet at Weston Co. Fairgrounds:
 - 1. Rental fee + commercial kitchen fee TBD
 - 2. May need event insurance
 - ii. Felix (Beard BBQ) would like to be part of this; and it was decided we should give him the first right of refusal to cater HHC 2023 awards banquet and have him charge by the plate.
 - iii. May need to do something different with Friday dinner (Pizza Barn for sale).
 - f. Prize table was more limited this year as industry back to tradeshows, etc. with no COVID.
 - g. Chris is going to be retired shortly / closing BCG.
 - i. Chris to have shop completely closed by 12/31/2022
 - 1. No more advertising expenses, so BCG will not be an HCC sponsor.
 - 2. HHC & HHCF will need own website going forward.
 - a. Chris willing to create and host; estimates about \$500.00 to start up and for first year fees.
