If you have a barn, stable, farm, store or warehouse, you can help save lives!

Working cats are an environmentally friendly way to help you control rodent population without using poison.

Prior to adoption, all the cats will be spayed/neutered, dewormed and vaccinated for FVRCP and rabies. There is no fee for adopting our working cats but a donation is much appreciated to help cover some of the cost of medical treatment.

Sometimes we rescue cats from a situation in which they may have been living without much human contact and cannot be fully domesticated, or are just much happier outside no matter what we do. At any given time we can have a dozen or more cats like this living in foster homes waiting for a safe place to go. If you think you can offer a safe place and food and warmth to some working cats, please complete the application below. By placing these cats into working settings, we can open up these foster homes to rescue more cats!
