- 1. **The 2023 PLA Annual Members meeting was called to** order at 10:06 by President Kerry Romsa. The Pledge of Allegiance was recited.
- 2. **9 proxies were registered and a quorum was confirmed**. There were 68 members represented including the 9 proxies. There are a reported 411 members in the Pelican Lake Association.

# 7. Committee reports

- a. Land Use Todd VanLangen
  - i. The committee would like to see more shoreline restoration projects on the lake to protect the lake from harmful runoff.

- ii. Establishing a Buffer Zone can be as simple as not mowing near the lake. Oneida County Land and Water Department has many resources to help a property owner get started. <a href="mailto:msadauskas@co.oneida.wi.us">msadauskas@co.oneida.wi.us</a>
- iii. Todd introduced Michele Sadauskas, Oneida County Conservationist
  - 1. Michele thanked the 7 property owners on Pelican Lake who allowed their properties to be examined by Michele and her assistant for shoreline improvements.
  - 2. Some concerns noted: bank erosion; lack of vegetation; shallow rooted shoreline plants which don't hold soil; too much hard surface that doesn't let rain soak in; mowing to the shoreline.

3. Key Idea- have as much vegetation as possible along the shoreline. This slows water running into the lake and allows it to soak in and allows shoreline habitat. Vegetation acts as a filter

#### d. Financial Review

i. Ed Rueckl, representing the independent Financial Review Committee which was formed last year to review PLA financial transactions reported on findings through December 31, 2022. The committee followed accepted financial guidelines in reviewing randomly selected cash and other transactions. Ed read the committee report which the BOD had not seen. The report graded the transactions in a Pass/Fail method. Reviewed were checks issued, bank statements, deposits, and other financial transactions. The committee was not aware of any modifications to the financial statement. Ed noted that the financial recording was very detailed.

- e. **Pelican Lake Scholarship**. Kelly Kraetsch reported on a draft of the proposed scholarship. Proposed details
  - \$ 1,000 award for Elcho High School senior pursuing post-secondary education Vocational tech; Associate degree; or Bachelor's degree
  - i. Must be a high school senior or equivalent.
  - ii. Must be a resident of Schoepke or Enterprise
  - iii. Must have demonstrated interest in Conservation/Natural Resources/ or Aquatic Studies
  - iv. Must have a minimum GPA of 2.0 (or equivalent)
  - v. Members questions
    - 1. Does the scholarship violate 501c(3) provisions?
    - 2. Should families of PLA members be included?
    - 3. Is 2.0 GPA the right level?
    - 4. Should there be 2 \$500 awards?
    - 5. In a small school graduating class there may not be anyone going into those fields
    - 6. A second or third year student may value the award more.

- f. Fish/Wildlife Committee Larry Burkhart/ Jeff Griffey
  - i. Nathan, the new Oneida County biologist has been very responsive to questions
  - ii. Spearing- 2022 754 walleyes 12 musky; 2023- 1,305 walleyes 4 musky
  - iii. Fyke nets set this spring for musky. 106 musky caught. Of those 86 had chips put in when stocked. Stocking began in 2012 with 1800 fingerlings put in every 3 years. Largest musky 48.5 inches; medium 36.4 inches
  - iv. PLA bought 10 chip readers for use with dedicated musky fishermen as well as for use on judge boats in tournaments. To be recorded: length, date, size, location. 3 are available on a daily basis. Help determine growth rate and population.
  - v. Also netted 108 northern. No disease found on any.
  - vi. DNR will not support northern management. Hope higher water levels will mean better survival of spawn.
  - vii. 2024 a survey will be done on all species.
  - viii. A creel census will happen this year. Please cooperate with the people doing the survey.
  - ix. Proposed rule change for panfish bag (25 to 10 daily) passed statewide 84% approval; Bass size and bag (from 1 over 18" bag limit to 5 bag limit with 1 over 18" none 14"-18") Passed statewide 80% approval
