ALL Applicants must have a **Washington State Business License (UBI #)**. Please make sure this is included in your application. Please also make sure you give us a good email address that you check and have access to – this is how we will be sending you much of your Merchant information and answering your questions!

RSPD 2022 reserves the right to refuse participation to any Applicants with displays of any items, information, or services that are deemed inappropriate to the event.

2022 Rusty Scuppers Pirate Daze Merchant Application

All returned applications **must be accompanied by a check or money order for the full amount** made payable to Half Moon Bay Pirates RSPD 2022 in the memo. This fee is non-refundable you are expected to be at the festival. Ineligible applicant's fees will be returned promptly.

Assignment of booth space and location is at the discretion of the RSPD 2022 Committee and is largely determined by need, type of wares, and seniority. If you have been a vendor with us last year and wish to maintain the same space please write the space # and a landmark such as across the street from a specific business or a specific corner. We try hard to accommodate our vendors but we ask your patience during the sign in process.

You will be informed of your space when you check-in. Check-in will be from Thursday, June 23, 12:00 PM to 8:00 PM, and on Friday morning, June 24th, from 8:00 AM to 11:00 AM. All vehicles must be off the street no later than 11:30 Friday morning as the event begins at noon.

Be advised that failure to clean up your space after the event including placing all trash into the dumpsters provided and sweeping up your area will result in a **clean up fee of \$75.00**

INPORTANT VENDOR INFORMATION

JUNE 24 – JUNE 26, 2022

Greetings all ye Salty Merchants! Please READ this information thoroughly in order to make your venture more successful & comfortable! We wish every Merchant the best of success, and an enjoyable weekend!

SET-UP: All cars must be OFF the street by 11:30am on Fri (no later) – the Festival STARTS at noon on Friday!!!

TEAR DOWN can begin at 6pm Sunday, when the street will be open to vehicles. We must all be off the street by midnight, Sunday evening. Please do **NOT** tear down early unless it is an emergency, as that impacts your fellow Merchants.

Festival Hours are: FRIDAY: noon to 7pm; SATURDAY, 10am to 10pm; and SUNDAY: 10am to 6pm.

You can bring vehicles in during the evening and early morning for resupply, etc., but please be aware that as there are no fees for the public to attend, people may be coming in and walking down the street as early as 8 or 9am in the morning on Sat and Sunday. We expect all Merchants to be open for business by noon Friday & 10am Saturday and Sunday morning!

If you bring vehicles in overnight, for resupply or sleeping, please make sure they are off the street and in proper parking by 9:30 am each morning! How LATE you stay open, beyond 9:00 pm on Fri / Sat is up to you.

IMPORTANT DETAILS - PLEASE READ!!!

GARBAGE: There are HUGE dumpsters in the main parking areas behind the festival that are available to our Merchants! Please do NOT use the small street cans on Westhaven, as those are for local businesses and our thousands of attendees. In previous years, some Merchants have overflowed those cans, and made the local business's upset, which endangers the future goodwill of these businesses in making the street space available for our Merchants! **PLEASE do not dump on Westhaven, (the main festival street!)**

This has become such an issue of contention, that should we find Merchants dumping their garbage in the street cans, they may find themselves not accepted in the future, and/or accessed a garbage fee for future years if accepted!

FAILURE TO CLEAN UP YOUR SPACE AFTER THE EVENT WILL RESULT IN A \$75 CLEAN UP FEE.

Also, Food Vendors should bring their own trash cans if possible, and make sure their area is well pick up after.

No one likes to eat in a place that looks like a garbage dump, so help your business by keeping your area clean!

PARKING: Similarly, we have had issues with Merchants taking up space in the main parking lots behind

Westhaven Drive with their trailers. That space is for our many Attendees, and the town has made it clear that they will TOW any trailers parked in the public lots behind the festival.

There is a large vacant lot at the corner of Dock Ave and Harms Street, where you can park your rigs for free. North Montesano St (the main street you enter town by), turns into Dock Ave when you hit the large curve going into town. For GPS reference, this is kitty-corner to the Knotty Pine Tavern, at 201 E Dock St, Westport, WA 98595. Another local reference here is the large white cannery building – if you pass these, you have gone too far for the parking area. If you wish to sleep in any large rig here, that is fine, but please know there's no power or septic hook-ups here, or any toilets; it's just a free parking space for your rigs.

When you are through offloading your rigs, please park in this location. **Any Trailers parked in the public lots behind the festival, (bordered by Nyhus St N. and Westhaven Drive), WILL BE TOWED!!!** We do not want to see that happen to any of you, so please be careful about this!

WEATHER! I cannot emphasize this enough – weigh down your booths!!! We are right on the ocean shore, and strong gusts are common. Because we are on a street, we cannot stake anything down, so booths need to be weighted with sand, concrete blocks, water, or whatever. Think about your displays as well, as wind can easily blow over some displays or light items.

SALE of WATER: One of the few ways the festival has of making money during the event itself is from the sale of bottled water. For that reason, we ask ALL vendors, including Food Merchants, to not sell WATER at your booths. If people ask, just refer them to the Booty Booth, by the Main Stage – thank ye!

TREASURE CHEST DRAWINGS: In order to reduce the number of tickets we need, and speed up the drawings, please give ONLY ONE TICKET OUT per purchase! This will make things a LOT easier on everybody! **Merchants will be provided OFFICAL double stub Rusty Scupper tickets for this.**

REST ROOMS: There are portable potties on site Fri through Sun, and a large permanent bathroom facility in the parking lot area behind the business's on Westhaven, between Coast Road and Carstenson, however, that one closes at approximately 1:00am.

WATER for YOUR USE: Cold, potable water is available at the top of each Float.

SLEEPING/CAMPING: If you wish to sleep in your booth, or in a vehicle parked in front of your booth, that's fine – all we ask is that you let one of our crew know that you're there, so they can inform security Thank ye much, and see ye all soon!

SECURITY: Security is provided Friday and Saturday night only. Vendors are still responsible for securing their tents and wares.
