All returned applications **must be accompanied by a check or money order for the full amount (US currency only)** made payable to WGCOC with RSPD 2026 in the memo, along with your photos. If accepted, you will receive notification by June 1, 2026. Your fee is then non-refundable, and you are expected to be at the festival. Ineligible applicants' fees will be returned promptly. **NSF Fee of \$40.00 will be applied to all NSF checks.**

Assignment of booth space and location is at the discretion of the RSPD 2026 Committee. We try hard to accommodate our vendors, but we ask for your patience during the sign-in process. **We CANNOT guarantee any space for any vendor.**

You will be informed of your space when you check in. Check-in will be on Thursday, June 25, from 3:00 PM to 8:00 PM, and on Friday morning, June 26th, from 8:00 AM to 11:00 AM.

DO NOT SET UP WITHOUT CHECKING IN. Spots are assigned and failure to check in could result in you having to repack and move your booth to another space. This is non-negotiable. Arguments over terms may result in your dismissal from the festival with no return of paid fees.

All vehicles must be off the street no later than 11:30 Friday morning as the event begins at noon.

Be advised that failure to clean up your space after the event including placing all trash into the dumpsters provided and sweeping up your area will result in a **CLEAN UP FEE OF \$100.00.**

IMPORTANT VENDOR INFORMATION

JUNE 26 – JUNE 28, 2026

Greetings all ye Salty Vendors! Please READ this information thoroughly to make your venture more successful & comfortable! We wish every Vendor the best of success, and an enjoyable weekend!

SET-UP: All cars must be OFF the street by 11:30 am on Friday (no later) - the Festival STARTS at noon on Friday!!!

TEAR DOWN: begins at 4 p.m. on Sunday. The street will be open to vehicles at 4:30. We must all be off the street by midnight, Sunday evening. **NO EARLY TEAR-DOWNS UNLESS AUTHORIZED BY THE FESTIVAL COMMITTEE.**

Festival Hours are FRIDAY: noon to 7 pm; SATURDAY, 10 am to 10 pm; and SUNDAY: 10 am to 4 pm.

You can bring vehicles in during the evening and early morning for resupply, etc., but please be aware that as there are no fees for the public to attend, people may be coming in and walking down the street as early as 8 or 9 a.m. on Sat and Sunday. We expect all Vendors to be open for business by noon Friday & 10 am Saturday and Sunday morning!

If you bring vehicles in overnight, for resupply or sleeping, please make sure they are off the street and in proper parking by 9:30 a.m. each morning! How LATE you stay open, beyond 9:00 pm on Fri / Sat is up to you.

GARBAGE: There are dumpsters in the main parking areas behind the festival that are available to our Vendors! **Please do NOT use the small street cans they are for local businesses and our thousands of attendees.** In previous years, some Vendors have overflowed those cans, and made the local businesses upset, which endangers the future goodwill of these businesses in making the street space available for our Vendors!

PLEASE do not dump on Westhaven, (the main festival street!) This has become such an issue of contention, that should we find Vendors dumping their garbage in the on-street cans, they may find themselves not accepted in the future, and/or accessed a garbage fee for future years if accepted!

PARKING: We have ample parking reserved specifically for Vendors please see the location below.

Please do not park in the main parking lots behind Westhaven Drive with your cars and/or trailers. **Any cars or Trailers parked in the public lots behind the festival, (bordered by Nyhus St N. and Westhaven Drive), will be towed at owner's expenses!**

There is a large vacant lot at the corner of Dock Ave and Harms Street, where you can park your rigs for free. North Montesano St (the main street you enter town by), turns into Dock Ave when you hit the large curve going into town. For GPS reference, this is kitty-corner to the Knotty Pine Tavern, at 201 E Dock St, Westport, WA 98595. Another local reference here is the large white cannery building – if you pass these, you have gone too far for the parking area. If you wish to sleep in any large rig here, that is fine, but please know there are no power or septic hook-ups here or any toilets; it's just a free parking space for your rigs.

When you finish offloading your rigs, please park in this location. We do not want to see this happen to any of you, so please be careful about this!

WEATHER: I cannot emphasize this enough – **WEIGH DOWN YOUR BOOTHS!!** We are right on the ocean shore, and strong gusts are common. Because we are on a street, we cannot stake anything down, so booths need to be anchored with bags or buckets filled with sand, concrete blocks, water, etc. Think about your displays as well, as wind can easily blow over some displays or light items. RSPD cannot guarantee that we will be able to provide such weights.

RESTROOMS: There are portable potties on site Friday through Sun, and a large permanent bathroom facility in the parking lot area behind the businesses on Westhaven, between Coast Road and Carstensen, however, that one closes at approximately 1:00 am.

WATER for YOUR USE: Cold, potable water is available at the top of each Float.

SLEEPING/CAMPING: If you wish to sleep in your booth, or a vehicle parked in front of your booth, that's fine – all we ask is that you let one of our crew know that you're there, so they can inform security. Thank you much, and see you all soon! No Camping is allowed on the grass lawn near the viewing tower.

SECURITY: Security is provided on Friday and Saturday nights only. Vendors are still responsible for securing their tents and wares.

FAILURE TO CLEAN UP YOUR SPACE AFTER THE EVENT WILL RESULT IN A \$100 CLEAN-UP FEE.

FOOD VENDORS:

- Picnic tables are provided in the Food Court for the convenience of the attendees.
- Keep the Food Court area clean.
- Be considerate of other vendors. Keep your area clean
- A Grays Harbor County Health Certificate is required to operate at RSPD. A copy of the certificate and insurance **MUST** be returned no later than June 1, 2026. Failure to provide it will result in your not being allowed to operate.
- All regulations of the Health Department must be followed at all times. Failure to do so will result in your business being promptly removed from the festival.
- Electricity is limited if you have a generator please plan on using it.
