Over the past 9 years, God has richly blessed our ministry and for this we are incredibly grateful. The growth The James Project (JP) has experienced has allowed us to serve many foster children and foster families in Sangamon County. The stories of struggle, hope, and determination behind these families continually remind us why we do what we do.

The number of children in foster care has dramatically increased and the need for the services we provide is greater than ever. DCFS reports one in five children is abused or neglected before turning 18. During this time when youth are at home for virtual school (potentially with an abusive parent) and they don't have a teacher, coach, or other trusted adult to turn to for help, it disrupts their lives even more. As the pandemic goes on, families are stretched to the limits emotionally and financially.

Covid-19 set the JP back this year—in resources, volunteers, and fostering families. Working from "not enough" has led us to our 2021 campaign titled Beyond Enough.

We know that enough today will not be enough tomorrow. The needs keep growing. At the very heart of these needs are the 625 foster children in Sangamon County. Adding to the existing foster care crisis is the increasing number of children whose lives have been disrupted during and after the quarantine, creating a foster care emergency.

There is much more we can do and so many more families we can help! Instead of operating from behind, we need the resources allowing us to innovate better solutions, recruit more families, and proactively prevent large numbers of foster parents walking away from fostering due to lack of support. In this coming year, please remember us, pray for us, and join our mission. Help us reach not just enough, but...


#### CARDS BY KIDS

## WE ALMOST SAID NO BY: KASEY MILLER, FOSTER MOM

"We almost said no." I kept thinking those 4 words all night, all morning, and even while the judge was talking to us during the adoption proceedings. I now look at our sweet toddler and cannot imagine our lives without him in it, but in the back of my mind that phrase is still there. So why did we say yes? I honestly have no answer other than God. We had many reasons for turning him away. We had

four kids already—three under age 3. Things had finally become "manageable" with our little ones. The timing wasn't great. The caseworker needed to know NOW and would bring the baby boy within the hour. We really, REALLY weren't prepared for another newborn so soon. We almost said no. But we didn't. We said yes. That small voice, that gut feeling, that string pulling on our hearts led us against common sense and rational thinking to make a decision we wouldn't have otherwise. God nudged us toward this little life and we fell in love. On Beau's 2nd birthday in August, our foster son became our forever



son. We will forever be grateful we said yes!



To say we feel extremely fortunate to have the second annual Artsy Art Fair go ahead as planned this summer is an understatement! On July 29th, our tremendous volunteers and supporters rallied around us as the venue switched from an indoor event to an under-the-big-top fair outdoors at Lakeside Christian Church. Decorators made the large tent feel like a big party! Despite the high heat index, fair goers both young and old purchased many items from talented local artists, and the cotton candy, glitter tattoos, face painting, chainsaw sculpture, and balloon artist only sweetened the experience. Our dedicated JP child artist Hollis Snider hosted art lessons at her booth called "Hollis' House." The children loved it! To all who came out to the fair, we THANK YOU for your support and look forward to seeing you next year.





#### MATTRESS MINISTRY NEEDS A BOOST

In 2019, The James Project fulfilled requests for 64 beds for newly placed foster children in Sangamon County. In 2020, we have exceeded this number of requests, with a combination of toddler, twin, and bunk beds totaling 80 so far, and still have 5 weeks remaining in the year! When Illinois shut down because of Covid-19 and forced all children home, they inadvertently kept children close to their abusers and away from those in the world who normally protect them by mandated reporting or removing them from the abuse. The result has not only been a huge increase in abuse cases,

but a massive increase in the severity of the abuse being seen. Since partially reopening in June, children have been coming into foster care by the droves. Sixty-six percent of our bed requests this year have been from June to September. While we were prepared and on



budget in January for this regular need, we sadly are now far behind. Would you consider donating to our mattress fund? No amount is too small! Each complete bed we purchase costs us \$165. We are behind \$5,000 this year in this fund due to Covid-19. Children deserve a safe place to rest their heads in what may be the first safe home they have ever known.


