

SCHEDULE A - Accelerator Program

The Accelerator Program rewards Solution Advisors for acquiring high-producing, high-quality, and profitable merchant accounts. This program provides a one-time activation payout based on the first month's projected processing margin, with increased payouts for higher-margin deals. In addition, high-performing consultants can earn additional one-time payout multipliers based on their monthly production, further rewarding consistent performance and portfolio growth.

How the Profitability Accelerator Program Works

The goal is simple: The more profitable the merchant relationship, the greater the payout. This encourages Solution Advisors to focus on pricing discipline, strong merchant relationships, and long-term residual growth.

Profitability Accelerator Payout Tiers Program - Performance-Based Activation Payout

When a merchant account is approved and activated, the Solution Advisors receives a one-time payout based on the estimated monthly margin generated by that merchant account. The payout may increase through the Profitability Accelerator tiers.

MONTHLY MARGIN GENERATED	ACTIVATION PAYOUT
\$0 – \$299	100% of first-month margin
\$300 – \$499	105% of first-month margin
\$500 – \$699	110% of first-month margin
\$700 – \$999	115% of first-month margin
\$1,000+	120% of first-month margin

Production Accelerator Payout Tiers Program - High-performing consultants receive additional payout multipliers.

The Monthly Production Accelerator Payout Tiers Program rewards Solution Advisors for consistent production and strong monthly performance. Under this program, high-performing consultants receive additional payout multipliers based on the total number of merchant accounts approved and activated within a calendar month. As production increases, payout multipliers increase as well, allowing Solution Advisors to earn higher activation payouts while continuing to grow their residual portfolio. This program is designed to encourage sustained activity, reward top performers, and accelerate both short-term income and long-term residual growth.

MONTHLY DEALS CLOSED	ACTIVATION PAYOUT
1 – 4 deals	Standard payout
5 – 7 deals	+10%
8 – 10 deals	+15%
11+ deals	+20%

Program Qualification

To qualify for payouts under the Profitability Accelerator Program and the Monthly Production Accelerator Payout Tiers Program, the following conditions must be met:

- Merchant account must be approved by underwriting and fully activated.
- Merchant must begin processing transactions on the platform.
- Merchant pricing must meet minimum profitability standards established by the company.
- Merchant account must remain active and in good standing.
- Accounts must not be involved in excessive chargebacks, fraud, or policy violations.

Accounts that fail to activate, cancel shortly after activation, or are terminated due to risk or compliance issues may be subject to payout adjustments, reversals, or forfeiture of program payouts. The company reserves the right to review merchant account performance to ensure compliance with program standards. Accounts that fail to activate or cancel shortly after activation may be subject to payout adjustments.
