American Covenant Senior Housing Foundation, Inc. formed in 2003, is dedicated to developing and owning low and moderate-income housing. Initially development of strictly senior housing was the goal for American Covenant but it was later decided the addition of family projects would support that goal.

Our Board of Directors are knowledgeable and supportive of our goal of helping house those who need assistance. Our growth has been conservative to insure we have capacity to handle both operations and construction.

We currently have properties in Montana, Indiana, South Carolina, Utah, Wyoming, and Nevada. Our projects, for the most part, are financed by USDA 515 loans as well as Low Income Housing Tax Credits.

This is a scattered site project with locations in Pioche, Panaca and Caliente.

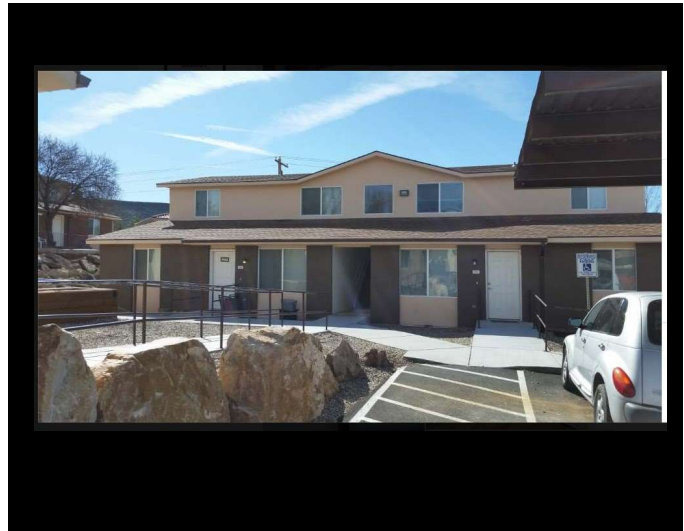

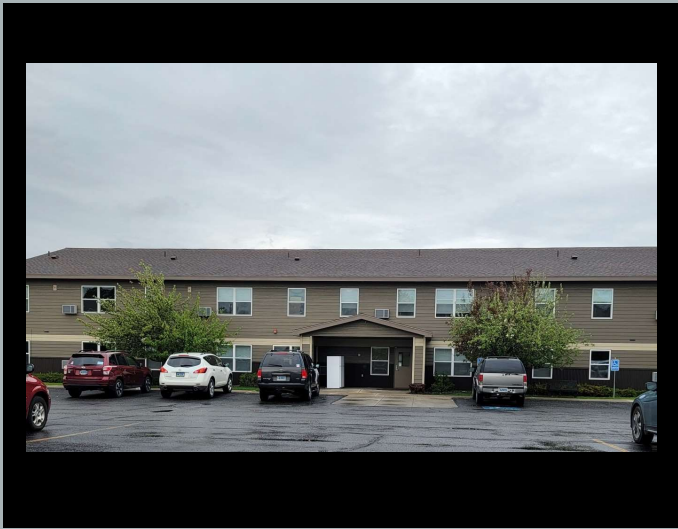
This is a special project that services the senior community by providing high quality units.
