Membership Contract

The undersigned individual (the Member), hereby indicates their desire to become a member of TherHab® Fitness and Anovo Therapeutic Fitness and Physical Therapy, group fitness and wellness classes, and is pursuant to the terms and conditions of this class membership agreement.

Health Attestation

The Member attests that they are fully able to participate in an exercise regimen of the therapist's design or choosing without undue risk.

Group Class Membership Dues

The Member agrees to pay either monthly or annual dues. These dues may be paid by automatic invoice using debit or credit card transaction, or in-person via debit, credit, or check. Membership contract options include month to month, 4-month period, or 12-month period with pricing discounts for longer term commitments.

This gym membership agreement entitles the member to access to TherHab® facilities so long as all dues are current.

Personal & Group Training

Personal training is offered by the facility but is not included in the member's membership dues. TherHab® reserves the right to add additional fees for any personal that the Member chooses to participate in.

Indemnification

This group class membership serves as a liability release, pursuant to which the Member agrees to indemnify and hold Anovo Therapeutic Fitness and Physical Therapy and TherHab® Wellness harmless against any and all claims of loss or damage without limitation.

Facility Rules & Participation

The Member hereby agrees to abide by all posted safety guidelines and regulations while using Anovo Therapeutic Fitness and Physical Therapy facilities and equipment. Additionally, the Member agrees to dress and conduct themselves in a manner deemed appropriate for a fitness facility.

The Member shall not consume drugs, alcohol, or tobacco products on property. The Member agrees not to photograph or videotape on Anovo Therapeutic Fitness and Physical Therapy property or in TherHab® Fitness Classes. Anovo Therapeutic Fitness and Physical Therapy reserves the right to revoke the Member's access if these terms are violated.

Membership Cancellation

This group class membership may be cancelled by providing written notice, in person, at Anovo Therapeutic Fitness and Physical Therapy or a TherHab® Wellness location. The contract will be considered annulled 30 days after the legal cancellation paperwork is signed. If the facility membership contract is cancelled prior to the expiration date, the Member agrees to pay a cancellation fee of \$75.00. Month-to-month memberships require a 15-day cancellation notice prior to the end of the previous month to avoid a \$75.00 cancellation fee.

If the Member must cancel due to relocation to an area more than 25 miles from an Anovo Therapeutic Fitness and Physical Therapy facility or a TherHab® Wellness facility, or extreme emergency, the Member may cancel or put their account on hold without paying the cancellation fee. This is at the discretion of Anovo and TherHab® management.

Membership on Hold

If a member needs to place the membership on hold due to personal conflict, illness or injury of client or family member, or prolonged vacation (over 4 weeks) he/she may place the membership on hold for up to 6 months.

The contract will be considered on hold 30 days after the legal "on hold" paperwork is signed. At this time the client should indicate when he/she would like the contract to resume. The same rule applies for individuals who undergo major surgery (4 weeks or more).

Authorization to Store Payment Information

The undersigned here agrees to allow have Facility store payment information for billing purposes. Client agrees to be billed monthly for membership services.

Binding Law

This group class membership contract shall be considered binding upon the members signature and shall be upheld and enforced in accordance with the laws of North Carolina. Any legal proceedings related to this facility membership contract shall take place in courts located in Waynesville, North Carolina.
